<u>CALL TO ORDER (Llame Pedir)</u>. On Wednesday, June 19, 2024, the SETA CFC met at 7:30 PM at InterGroup, 5151 Mitchelldale, Suite 10B. Tony W, SETA CFC Chair, started the meeting with a moment of silence followed by the Serenity Prayer, after which he read the SETA CFC Statement of Purpose. 14 volunteers attended, including 3 remotely via Google Meet. Two new persons were in attendance.

SECRETARY'S REPORT (Revision Minuto). Larry L, SETA CFC Secretary, circulated the May 15, 2024, meeting minutes, which the group read on their own. It was moved, seconded, and passed to accept the minutes as presented.

It was then moved, seconded, and passed to accept the Treasurer's Report as presented.

CHAIR REPORT (COORDINADOR INFORME). Tony W reported that:

- June TDCJ newsletter has not items related to SETA CFC.
- AA World Services is going to stop printing hard copy Box 459 due to low subscription rates currently under 50, while costs are \$35,000 to distribute 4 issues per year. Box 459 will still be available online.
- The National Corrections Conference will be in Charlotte, NC, from 11/8/2024-11/10/2024. Registration can be done via http://national correctionsconference.org. Room reservations re going fast.
- No news yet about Harris County Atascacita Jail. Larry L is the only person we know is going into Harris County Jail downtown. For information about going in, one should contact Henry N.
- Grant G and Matt S from College Station are working to get meetings into the Brazos County Jail in Bryuan.
- Jim O is still working on getting a meeting into the Waller County Jail. Their main criterion is to be off paper.
- Chuck M informed us that CFC Houston will remain separate and independent of SETA CFC, which means that individuals may choose to work with CFC Houston but not as a Committee. Cristian S requested clarification about the relationship between CFC Houston and SETA CFC.
- Tony hopes to start taking a meeting into Wallace / Pack again. So far, Chuck M seems to be the only person going in there regularly.
- There was general discussion about who was going into various units.
- Tony ended his report with a quotation from Bill W that, "To the world you may be one person, but to one person you may be the world.

CO-CHAIR REPORT (COORDINADOR INFORME). Harold B reported that:

- He is the liaison for the Luther Unit. A number of people are on the list there but many are not going regularly. He is creating a new database for volunteers who are going there.
- Others are going to the Pack Unit but they are not affiliated with our Committee. Tony W indicated that according to the Pack Unit records, Chuck M is the only person going in there. There was discussion about who else may be going in there. NA was going in regularly.

CONFERENCE REPORT. Sarah ME reported that:

- Conference planning is proceeding on schedule.
- We have about 60 registrations, but we do not yet have an accurate count for the Spanish districts.
- A couple of panels are set and good to go.
- We have about 35%-40% of our room bloc requirement met.
- Speakers are confirmed, and we're working on a recently released inmate speaker rather than a video recording from TDCJ.
- TDCJ training is confirmed.
- The Website for registration is up and working.
- We'll be following up with the hotel about the Ice Cream Social and Sweets Night.
- Hospitality suite and volunteers are in process.
- Saturday Night banquet numbers still need to be increased.
- Bahiyyah W reported that flyers will be available at the State Convention.

SPANISH LIAISON (ENLACE ESPAÑOL). Yolanda L was not present so there was no Spanish Liaison report.

GRAPEVINE (LA VIÑA). Terry P was not present so there was no Grapevine report.
