Natalie B reported as follows:

- She was not present last month due to health issues, and she thanked everyone for their support and well wishes.
- She received 5 letters, 3 from prisons and 2 from county jails.
- She forwarded those that requested literature to Libby at InterGroup.
- She forwarded the other 2 to program participants.
- She is having a problem with one inmate in particular.
- There has been some confusion in handling his letters, though she has attempted to treat them properly. He asked about whether anyone is going into Galveston County jail. Sarah E said she knows several people going there, so Tony W asked Natalie to forward the inmate's letter to him and he would reply, and Sarah said she would speak with Natalie after the meeting. Natalie concluded that she wanted the inmate to understand that the problems were all just practical issues and everyone wants to help him.
- Natalie added that she has some letters for Roy and one for Tilly from a female inmate who wants to correspond. Roy said he has some letters for Natalie also.
- She also shared a letter from an inmate at the Wynne Unit, who thanked the committee for everyone's hard work and contribution. Everyone agree that it was good to hear such unsolicited appreciation.

CONFERENCE REPORT.

Yolanda L reported that:

- The Spanish districts have met and are still trying to recruit more individuals to take meetings inside the prisons.
