- Melissa Is a Volunteer Correspondent and was assigned an inmate, but was unsure of what return address to use. She called Intergroup and spoke to Dick, who told her to use Intergroup's address, but she didn't know when or how she would receive mail. General discussion followed about no correspondence mail having been distributed in Monday's Intergroup CFC Board Meeting. Also discussed SETA's address being different from Intergroup's.
- Elizabeth/Secretary Continuing to go into Henley Unit with Dori on 1st, 3rd & 5th Thurs. and doing Step Work with the women. Finished Step 1 and started Step 2. Had previously made contact with VOA on Lavender Rd. to start up a meeting there, but Ms. Granger has not returned calls. Coincidentally, Dori ran into a busload of the women from that VOA and we now have our foot in the door of the facility and are again trying to start a meeting.
- Mariano Visiting 701 San Jacinto every Tuesday and averages 12 to 15 inmates per meeting. Still going to Estelle Unit on the first Monday of the month.
- Richard/Intergroup CFC Liaison Takes meetings into Wynne, Luther, Walls, Ellis and Eastham, and is very grateful to be able to give back.
- Victor Goes into 701 San Jacinto every Friday with 5 Volunteers. Meeting is in Spanish. They are spreading the word to the families about the importance of meetings and Grapevines and La Viñas.
- David Got his driver's. license back, but isn't yet an Approved Volunteer. He can still go in as a Special Volunteer.
- Cliff Is a Public Safety Advocate and glad to be part of the meeting
- Marcial Visits Baker St. Jail on Tues., Sun. & Holidays. Holliday Unit turned him down and said he needed to be retrained, but he just completed training at the September Convention. Richard gave him Lisa Langley's phone number at Volunteer Services in Huntsville.
- Larry/District 20 CFC Rep. Someone contacted District 20 regarding 3 or 4 orders of La Viña. Who would be placing that call? No one knew. Also, there are 60-70 meetings in District 20 alone. They are trying to get CFC Reps to go out and announce how to volunteer for the CFC cause. There is a training session scheduled for Harris County Jail on Jan. 11th at 1:00 PM.

- Jim/Chair Made most all his meetings this month, with the exception of Holliday because his sponsee wore shorts. Ramsey Anniversary was awesome! With a theme of Bridging the Gap. But the situation at Harris County Jail has gotten so bad, that he's loosing his partner, Machete Eddie. We need more folks to step up for Harris County Jail.
