- 3) Contacted Jeff at CFC GSO to introduce himself and check on how things were going in NY. Jeff stated there is a backlog of around 100 letters from inmates asking for AA members to correspond with them. Chris asked the Committee if there is an interest in helping out. **TREASURER'S REPORT (Informes de Tesorero) – Amy E;** (Note, detailed financial reports are on the SETA CFC website aa-seta.org) Treasurer's Report was unanimously approved. There was discussion on "current to date funds" available. The Treasure agreed to subtract the current Intergroup invoice from the blue can total to give a more accurate book allowance dollar total. There was a concern about postage expense deducted from the Blue Can monies contributed. Tammy Z will research the uses of Blue Can funds further.

### OLD BUSINESS (Negocio Viejo):

<u>Book Orders</u> – Larry L called GSO regarding the cost of ordering literature directly from them. He found there was not a significant savings unless it was a huge order. In 2017 Houston Intergroup accessed an additional 10% fee to cover cost of handling literature orders. Chris D spoke with Dick at Intergroup and they are unwilling to budge. Much discussion. Item was tabled until Committee could get addition information aka hard numbers to use as a comparison. Larry L agreed to take this month's book order and calculate the actual cost of same order through GSO. He noted that backorder Grapevines were substantially cheaper through AAgrapevine.org than Intergroup; \$75 vs \$51 for a bulk order.

<u>NETA Workshop</u> – **Roy E** – Both Chris and I attended the Clear Air North Group Workshop in Dallas. This is our NE area. We gave our presentation on CFC SETA which goes over our history and positions within our Committee. The Workshop was well attended. We are very blessed to have such an active Committee. NE Texas Area CFC Committee meets at their quarterly Assemblies with a Chair, Alternate Chair and Treasurer. The Orange Can raised about \$7,000. They have trouble getting volunteers and are reaching out to the Districts through Workshops. Chris D presented sign-up sheet they used at the Workshop. He would like to incorporate in our upcoming Workshops. The sheet was in a chart form
