CALL TO ORDER (Llame Pedir) on 3/15/17 at 7:30 pm by Chris D at the Delta Club (6400 Westpark Dr #355, Houston, TX) with a moment of silence followed by the Serenity Prayer. All were welcomed with a special recognition to Jose who was attending his first SETA CFC meeting. 17 people were in attendance.

CHAIR REPORT (Coordinador Informe) - Chris D; (cfc-chair@aa-seta.org)

- Passed around the SETA CFC Master Roster for the Committee to update contact information.
- Attended the SETA Finance and Budget meeting last month and proposed a SETA CFC Budget increase for 2018. The increase was primarily due to expected shipping increases and CFC Chair Conference travel. Shipping line item of \$750.00 was calculated to cover the cost of mailing literature to inmates. Much Discussion. The Blue Can postage cost will no longer be deducted from the Blue Can monies collected per a vote at our last SETA CFC meeting. The Committee voted to begin subtracting this Postage expense from the CFC General Fund. The 2018 Budget will go to the Floor at the Assembly for a vote.

TREASURER'S REPORT (Informes de Tesorero) – Amy E; (cfc-treasurer@aa-seta.org) (Note, detailed financial reports are on the SETA CFC

Treasurer's Report was unanimously approved with a couple of corrections. There was some discussion regarding depleting the General Fund to cover the expense of mailing literature to inmates.

OLD BUSINESS (Negocio Viejo):

Book Orders Larry L reported that he had spoken with both Intergroup and GSO to compare the overall prices of AA literature from Intergroup verses buying directly from GSO. We would save about \$2,000-\$2,500 a year buying directly from GSO, largely due to volume discounts and free shipping for the large number of popular items like the BB and 12 & 12. We do not purchase so many of the other books and pamphlets which would not be discounted. Intergroup does pass along to us the volume and shipping discounts for the most common items, though they charge more for other literature; and considerably more for GV back issues. Larry added that the additional cost through Intergroup comes to only about \$200 a month, for which they have real "business" expense to order and receive the books, stamp the SETA CFC contact info in each book, box the books separately for each of our orders, and hold them for pick up. If we buy directly from GSO, we would have to do all those things. One item that may be worth ordering separately is the GV and La Viña. Intergroup charges \$75 per package of 30 back issues compared with only \$54 buying directly from the GV. Roy E also noted that direct order of \$1,000 or more adds additional discount and get a better selection from GV. It was voted to continue buying regular AA books and literature from Intergroup and to start ordering GVs directly from the GV at least \$1,000 per order and distributing them at the monthly CFC meeting.

Committee voted to continue purchasing literature through Intergroup 10 Yes; 2 abstained; O opposed. Back issues of GVs and La Vinas will be periodically bought in bulk from GV directly.
