InterGroup charges \$75 for a box of 30 back issues; GV charges \$54 the same order. Confirmed a 20% discount for orders of \$500 for the more recent issues. The main constraint is that we could not set up a charge account. The Committee voted to authorize a purchase of \$1,000 of most recent GV when there are available funds.
