**Finance Report-** 2018's Budget is: \$1310 Total, \$560 for Lodging, \$125.35 in lodging expenses have been spent, leaving \$1184.65, \$434.65 for Lodging, \$750 for other items.

#### **Chair Report:**

- Attended the 2019 budget committee meeting, requested budget is \$1490. Room rental was changed from \$180 to \$200 due to IT being \$200 now. There was a lot of discussion (and some push back) about this. The IT, PI, and CPC agreed we should talk to Betsy about \$150, being as that's what a membership to SBMC for a year costs. We also agreed we should be aligned on the same amount. For 2017 & 2018, IT was \$180, and PI & CPC were \$100, for \$380 total. If we all went to \$150, we'd be paying \$450 total, an increase of \$70. We voted at the March 05 CPC meeting, to leave this at \$200.
- Approached District 31 to get on their schedule for a presentation on PI/CPC service.
