 - a. Cost

 - d. Possibly post tax season or done simultaneously with tax prep
 - e. Doug D. was of the minority opinion that this would be a tradition six violation
- 3. The committee decided to gather the above facts and present to the JAN Area Assembly for vote.

AREA INVENTORY FEEDBACK – Item I

Area not fully funding the Delegate but continuing to spend money on hotel rooms at Assembly

- 1. Kris H., will provide a chart explaining "fully funding the Delegate" to be posted on Finance Committee website.
- 2. Committee will work on a 15 minute Power point presentation to be posted on our website and given at each district.
- 3. Will determine at a later date when the "workshops" will commence
- Debra B. will create a flyer for Finance Committee website and for distribution to substantiate the committee's commitment to transparency

New Business:

- The committee discussed the 2021 SETA Convention budget/hotel contract review process. The contract was approved and has been signed.

 - Lesson(s) learned, the committee will need to review the venue budget along with the contract and pay special attention to the room block, coffee requirement and the reserves set aside for loss
- Melanie G. will give a full accounting of Grapevine Committee funds for 2017/2018 during the October 5, 2019 Finance Committee meeting to clarify any concerns the Area may have regarding the appropriation of funds.
- The remainder of the meeting was used to discuss Drop box tracker that list "action items" for our Finance committee.
 - Workshops for next year, either January or April, to simplify the budget process and increase transparency.
 - The committee will submit a motion during January Assembly both removing/adding line items in our budget in preparation for February 2020 budget meeting.
 - Each committee member is encouraged to review the tracker in drop box and commit to completing an action item during 2019/2020 term.
 - Check Area Secretary minutes for pending/passed motions that may affect the committee actions.
