## **Ongoing Business:**

I. Convention Loss Funds: Betsy G. reviewed the Convention Loss Funds line item along with the Treasure's Report and stated there is a \$4000 line item, a reserve of \$15,000 and there is a state convention reserve fund. At this time, no one knows where the \$4000 came from and maybe a mistake. It started around 2007. Paul made a motion to reserve money incase something would happen to the SCAP funds. The SCAP funds are not part of the Area money. The committee reviewed an old treasurer's report; convention lost reserve and the convention fund. This may be a case of "relabeling" the line item.

Ron S. reported that the SETA Convention Fund Box for the 4<sup>th</sup> quarter report will have a "new box design" will break it down to income, expenses net for each quarter. This will have a beginning balance of Jan and ending balance in Dec. It will be broken down to make it clear to everybody and transparent.

Michelle H. addressed "online contributions" portion of the report and would this fall under "group contributions (possibly put a foot note on group contribution sheet). Ron S. stated only one group has used the "online contribution." The committee agreed a footnote at the bottom of the report would suffice.

Betsy G. addressed the question, "How did the convention reserve fund get below \$15,000?" as the Area has not lost any money on conventions this year. The committee referred to the \$11,000 balance in the convention fund. Ron S. stated \$500 went to the deposit on the hotel, \$1600 went into the convention fund bank account and there was a return of money from the 2019 convention.

II. Committee Table Display Project: Deborah B. ordered from GSO: 100 Self Supporting cards – English & Spanish, 100 Finance Committee Guidelines – English & Spanish and 100 Self Supporting Where Money and Spirituality Mix – English & Spanish. The total cost was \$34.00. Deborah B. was able to purchase a trifold display board.
