OLD BUSINESS:

A. Grapevine Workshop at SETA Assembly

Kimberly L. reported she has spoken with Michelle and there is a place on the July Assembly Agenda available. The October Assembly Agenda is full.

Discussion: There was discussion as to the content of the Workshop. Kimberly L. and Cindy J. reviewed some of the content District 81 used during a Grapevine Writing Workshop presented earlier this year. The type of workshop and time frame was also discussed. It was suggested we have a give-away for attendees who submit stories or pictures during the weekend.

Actions:

Kimberly L. will contact Michelle and request that a Grapevine Workshop be placed on the July SETA Agenda. The **Goal** of the workshop is to raise awareness of Grapevine and LaVina Magazines, areas of possible participation to increase involvement in the magazines and increase subscriptions to the magazines in print and online.

C. Grapevine Gifts Baskets from Area Funds

Melanie M. explained that very little money has been spent on the grapevine gift baskets she has given out in her district. Members in her district had requested Grapevine materials to uses as give-aways. Her district does not have much money so this was her way of helping to spread the Grapevine Magazine. She feels other districts are better equipped financially and do not need area funds to provide give-aways nor have requests for give-aways been made in other districts.

Discussion: There was a lengthy discussion regarding the needs of other districts. During the discussion several points were made:

D. Updates

a. District 52, Ricardo D.

Ricardo D. reported District 52 that District 81 has not made a decision on having a Grapevine Workshop.

b. District 31, Nicole L.

They are planning a Grapevine Workshop in September for District 31. She will send out an email when plans are finalized.

c. District 82. Teri V.

Teri V. was not present at meeting. Cindy J. reported subscription forms/cards have been ordered from Grapevine however she has not yet contacted Grapevine to verify we would not be breaking any traditions by placing them on public bulletin boards.

New Business:

I. 2018 Area Grapevine Committee Budget Spending

Kimberly L. informed the committee that she was approached at the April SETA Assembly and asked how this committee has spent the allotted budget. Kimberly couldn't answer this question. It was then brought to her attention that the current SETA budget reflects that the only funds still available to this committee are those for

accommodations. Melanie M. explained that she had requested the Area Grapevine funds in order to purchase literature. She stated if committee members needed money for committee work she would reimburse them with a receipt. The committee had several questions:

- ➤ How much did Melanie withdraw from Area funds?
- ➤ How much of these funds are still available for use by the committee?
- > What have funds been spent on?
- > It was questioned as to why funds were withdrawn before they were needed?
- > Shouldn't the committee approve what funds are being spent on?
- > Should we return available funds to the Area Treasurer until the committee decides what they are to be spent on?
- > Has literature been purchased and, if so, what literature was purchased?

Action: Melanie M. will bring an accounting of all committee funds to the June meeting. The committee will further discuss this at that time.
