Letters from the General Service Conference - Panel 67 Delegate

Well I made it to NYC on Monday and after tour sting all week I am ready for the start of the GSC tomorrow. I sent Karen and Rachel home today and got down to business. This morning I went before the International Committee to present information on Houston hosting the 2030 International Committee. The committee was a combination of Trustees, Non Trustee Directors and Delegates. The total number was about 20-25 people. The Committee expressed some concern about the distance between the Convention Center and NRG stadium. But we will see what happens. On Wednesday they will announce who moves on to round two. Phoenix dropped out and decline to present so now it is St. Louis, New Orleans, Indianapolis and Houston.

Also tonight I gave a presentation at the Delegate's only meeting about the "full Conference Process" It was very well received and I officially won the worst joke of the night contest, who knew I had such talent

What was really nice this week is that both Patrick (and Trae) and Deborah (and Katherine) took me out to eat. It is great to have such wonderful past Delegates and friends that take the time to show their current Delegate support.

I was talking to another Delegate over dinner and he says he sends e-mails to update his Area so I thought I would give it a try see how it goes.

#### Day 1

Today marked the start of the Conference and it is truly touching to have your name called as a voting member of the 68th General Service Conference. This year there are 136 voting members and two are from Area 67.

Another interesting thing also happened they were calling the names of the vote counters at the

Conference. They had called my name because I had accepted the duty. Then they corrected it and Rick (Conference Coordinator) apologized and dropped me from the counting duty. He came up to me later and explained that they had made changes and forgot to notify me. I told them no problem but that I was going to tell my Area that Rick said "I don't count".

Also today I had a working lunch with the 10 other Delegates from the Southwest region to discuss Regional business. The 2021 Forum will go to North West Texas Area (Area 66).

The Delegates Trustees Committee met with the Trustees Nominating Committee today. This serves as an informational meeting where the Delegates can ask questions of the Trustees concerning the business they have conducted for the year. Interestingly the Trustees Nominating Committee did not discuss the censure or the reorganization of the Board in their Committee meeting. They decided to pass it on to the Delegate's committee with no comments.

Tonight we had a Banquet followed with an AA speaker meeting. Even though I was dateless again, it was enjoyable and I had a chance to talk to people I hadn't talked too previously. It has been a long day 9:30 - 9:30 but extremely productive.

#### Day 2

Another busy day today. We started our Committee meetings. They are normally 3 hours on Monday and 3 hours on Tuesday. But we did 6 hours today and still haven't finished our first Agenda item. We have a total of 7 to do by

Wednesday. We have spent 6 hour talking about censure. We worked thru lunch and dinner and also met for another hour after the final session. But it's been fun we questioned 4 trustees and the General Service Board President about the actions taken concerning the Publisher's copy of the Big Book. I can honestly say they know our names now. We have 9 members on the committee and 7 of them are very outspoken. I was only in the minority one time out of five votes, so our Area is being heard.

Also today they had Board reports from the General Service Board, The Grapevine Board and the AAWS board. The board reports are about what the Boards have been doing this past year. Also David Morris gave his Treasurer report, the total report was around 150 pages but he only covered about 25 pages total and then answered questions.

I'm really glad I got here early I didn't even get a chance to look out the window today. 9:00 - 9:30 today and in most cases the Trustees are here longer than anyone else. Hope yawl are enjoying the emails because I haven't had time to write my postcards yet .. So if you get one with no writing on it just remember you are my favorite person in AA and I didn't feel the need to express it in writing. :-)

#### Day 3

Well after 6 hours and 15 minutes we finally finished our first Agenda item concerning censure. It then took only another 3.5 hours to finish the other 6. I can't discuss it at this time until it is presented to the GSC. But there was intensive discussion and every opportunity was explored.

In the afternoon we had presentation and workshops. The workshop is split into 10 sections with 13-14 people per section. This includes all GSC attendees including Trustees and non-Trustee directors. This year workshop was on "Getting the AA message out". In our workshop we discussed different ways Areas are using to carry the message. Not only directly to the alcoholics but also through the professional community and into the treatment centers and the correctional institution. Technology can play a role but in most cases the one-on-one communication still works best. Another interesting tidbit is that the 71st Translation of the Big Book has been finished and it is in Navajo. Navajo has no written language so the translation is an audio version. In May or June it will be presented to the

Navajo Nation by the President of the General Service Board.

In the evening we had a Delegates only meeting where I was requested to tell a joke. It's nice to know that my fellow Delegates appreciate me. (At this rate I may never come home) After the Delegates only meeting ended, Yolo our Regional Trustee took the regional Delegates out for ice cream at Ellen's Stardust. Ellen's has singing waitress and there were Delegates from 6 of the eight regions in attendance except Pacific Coast and East Central (approximately 60 delegates). So today was 9:00 -10:30 but I wouldn't miss a minute of it.

#### Day 4

Today we visited the General Service Office and I took my first subway. It is amazing what they manage to do with so few people at the GSO. The Archives were amazing.

We also had our Regional lunch the 2020 SWRAASA will be in Amarillo and the 2021 Forum will be in North West Texas Area.

Tonight we started report outs and the voting process is electronic voting. It took about 45 minutes to explain and work out the kinks. But the entire General Service conference is finally voting on something. The next two days will be voting on recommendations from the Committees.

Received some bad news tonight. Houston and New Orleans did not move on to the second round for hosting the 2030 International convention. The two finalist are Indianapolis and St. Louis. The concern with Houston was the distance from the Convention center to NRG and being able to transport the older/disabled that will be attending. So I guess we have an accessibility issue. I sucked up to the St. Louis Delegate and told him Area 67 would be happy to help out since they are in our Region.

I'm going to drown my sorrow in chocolate.... Luckily Troy sent me 6 pounds of chocolate and I have 3 pounds left.

#### Day 5

Well today I got to live my AA dream. Every day a Panel 67 Delegate gets to open and close the General session of the General Service Conference.

The Conference Coordinator selects the reading so all the Delegate has to do is go to the podium introduce themselves and read the reading. Today was my turn. So one of my AA dreams has been to tell a joke in front of the entire General Service Conference. The jokes I told before was at the Delegates only meetings so no Trustees, No GSO staff and No GSB members. Well I had thought about it and decided just to follow the script. So I got to the microphone introduced myself and explained that my Area instructed me not to tell a joke so I told them the pizza joke and they loved it. I have officially told a joke at every service level of AA. My new goal is the International Convention. We can apply again in 5 years so all yawl potential Panel 73 Delegates don't forget!!!!! If yawl forget me I talked to the Indianapolis Delegate and offer our (Area 67) help with the Convention.

Interesting side note the GSO staff who handled International Convention bids, interviews etc. She also gave me the bad news is rotating to the Regional Forums desk this year. So I informed her that she couldn't escape Area 67 and I will see her in Houston in 2019.

The Committee reports started last night and continued today, we have finished 8 of the 13 committees. We have finally finished the Trustee Committee report out so I can talk about the deliberation. My Committee took no action on the censure and the reorganization of the General Service Board. We added some strong additional comments to the Boards and receive the most questions of any Committee so far. You would think the issue was over but two floor actions were submitted after our report out dealing with the issue. One was to censure the Board and the other was to require the board to notify the fellowship before taking any legal action. Floor actions will be handled after all the Committee reports are done, so Friday will be another long day. Today was 9:00 am - 10:00 pm. It's looking more and more like all my favorites will be getting blank post cards from New York....

Day 6

Well the day started off on the wrong foot. The first meeting is at 9 am and every day normally I get up about 7:30 and prepare for the day (prayer, meditation and morning chocolate). I head down about 8:30 and say hello to everyone and choose my seat. Normally we try to rotate where we sit so that we can meet different people. I was so tired that I didn't wake up until 8:30 am. I never knew I could

shower, dress and get out of the room in 20 minutes. I got there before 9:00 but just barely and if you are not there a least 15 minutes before the section you are late and the good seats are taken. We spent most of the morning session discussing the Young People Video, The LGBTQ alcoholics and Alcoholic with Mental Health issue pamphlets.

At the break the Editor from Grapevine came up to me and said he loved the pizza joke and asked permission to use it in Grapevine. I told him it wasn't an original joke so they will use it in the section "things heard in meetings". Also Grapevine gave a presentation and they have definitely done an amazing job. I have drank the Grape juice!!!

We finished the Committee reports early about 8:00 when the International Convention Committee reported I did express our Area's disapproval of them changing the bid acceptance date. Also I stated that Area 67 would be more than willing to help in any way possible in 2030. After the Committee report a couple of the Committee members did offer some suggestions on how our Area can do a better bid for the 2035 International (if we choose to bid) which will be the 100th Anniversary of AA. The bid will be in 5 years.

The floor actions took a while and we had multiple discussion about censuring and trusting the process. Some Areas wanted the GSB to make amends for the legal action they took. But the Conference officially ended at 11:30 tonight more unified than divided.

Tomorrow is Stepping Stones....

Sunday I fly home.

So this is my last report and I will see you in Houston

Thanks for the opportunity to serve. It was one of the greatest experiences of my life.

#### **Adopt a Literature Rack**

Some Ideas are, but not limited to, an emergency clinic, a laundromat, a school or a library. It will be your job to check back frequently and refill the rack. We will place information on the rack about how to reach the area committee for presentations about AA and the information about who is in charge of refilling the rack.

We could really use your help with this project! The committee is small and Area 67 is very large, but if each one of us decides to become a part of spreading the word, we can reach many still-suffering alcoholics.

## COOPERATION WITH PROFESSIONAL COMMUNITY

Use the Grapevine to Carry the Message at your Doctors', Clergy's', Therapists', or Lawyers' Office!

- Let the professionals in your life that might deal with other alcoholics or potential alcoholics know that Alcoholics Anonymous has a solution that's worked for you and 2+ million other people.
- Ask them if you can leave some Grapevines in their waiting room for their clients that have or know someone with a drinking problem.
- · If they seem interested, you may also wish to bring them some pamphlets
- for themselves (such as "AA as a Resource for the Health Care Professional", "Members of the Clergy Ask about Alcoholics Anonymous", "Alcoholics Anonymous as a Resource for Drug and Alcohol Court Professionals")
- o or for their clients / patients / congregation ("AA at a Glance", "Information on Alcoholics Anonymous", "Is AA for you?", "This is AA", "A brief Guide to Alcoholics Anonymous")
- Let the professional know they can refer people to the local intergroup number for meeting information, that
  you'd be willing to be a contact as well (if you are), and that the CPC committee can be reached at <a href="mailto:cpc@aa-seta.org">cpc@aa-seta.org</a> to put on presentations about AA for their staff or peers. Our website for professionals is

- If you could do any or all these things, you might reach still suffering alcoholics through a non-alcoholic professional!
  - Q: What's CPC?
  - A: CPC stands for Cooperation with the Professional Community, it's a standing committee at the Area level and often in Districts as well. Individuals can do CPC work with simple but important activities like the one above.
- CPC Committee Purpose "Members of C.P.C. committees inform professionals and future professionals about A.A.— what we
  are, where we are, what we can do, and what we cannot do. They attempt to establish better communication between A.A.s and
  professionals, and to find simple, effective ways of cooperating without affiliating." reprinted from Cooperation with the Professional
  Community Workbook, page 5, with permission from A.A. World Services, Inc.






