

TREATMENT FACILITIES COMMITTEE MEETING MINUTES

August 15, 2024, 7pm, Meeting

Summary

The meeting transcript covers discussions related to the Treatment Facility Committee (TFC) of Alcoholics Anonymous. The main topics discussed include sharing and approving July Meeting Minutes, treasurer's report, upcoming convention and district visits, treatment facility visits and meetings, volunteer recruitment for bridging the gap program, literature distribution, open committee positions, and action items from the previous meeting. Key decisions made include approving the previous meeting's minutes and treasurer's report. Numerical data mentioned includes the actual year-to-date spending of \$541 and a remaining budget of \$1,374.56. The participants also discussed challenges faced in sharing screens and presenting documents during the virtual meeting. Overall, the meeting focused on coordinating efforts to carry the AA message to alcoholics in treatment facilities and ensuring the committee's operations align with the AA traditions and concepts. The importance of institutional knowledge and experienced members to guide the committee was again highlighted as a challenge.

Business Discussed

Opening and Minutes Approval

Christopher G. shared the meeting minutes from the previous meeting, which were approved by the participants.

Treasurer's Report

Donald M. presented the treasurer report, which showed an actual year-to-date spending of \$541, including \$107 spent on purchasing TFC workbooks. The remaining budget was reported as \$1,374.56. The participants discussed the need to pay the web hosting bill and approved the treasurer's report.

District Reports

No representatives from the District to report.

Committee Reports

Donald M. provided an update on the Bridging the Gap program, mentioning a few new volunteer additions in the last month. Christopher G. discussed his efforts to recruit more volunteers from districts with deficits and shared a document highlighting the volunteer distribution across districts.

Open Positions and Committee Continuity

The chair acknowledged the open positions of secretary and alternate chair within the TFC committee. Concerns were raised about the lack of institutional knowledge and experienced members to guide the committee's work. The importance of sponsorship and service sponsorship in encouraging members to step up for service positions was discussed.

Incorporating Traditions and Concepts

Tradition One by Diane L - Postponed to September Meeting

Concept Three by Chris G - Postponed to September Meeting

(Based on inventory suggestions, the committee decided in July to incorporate the study of AA traditions and concepts into their meeting agenda. Volunteers were assigned to present on a specific Tradition and Concept at the next meeting, with the aim of aligning the committee's work with the principles of the AA program).

- 5. Incorporate a tradition study and explore incorporating a workbook study
- 6. Continue efforts to establish AA meetings within treatment facilities and facilitate bridging the gap for individuals leaving treatment.
- 7. Diane to present on Tradition One, and Chris to present on Concept Three at the next meeting
