- At the January SETA Convention, provided support for laptop, projector & screen setup for the Saturday morning GSR Workshop, a PI Committee presentation and the Saturday night Spanish LaVina speaker presentation. Experienced technical difficulty with the GSR Workshop (no electrical power readily available), therefore, could not utilize projection equipment.
- CFC Chair, Richard D., dropped off his laptop with Marshall for upgrade to an IdeaPad S405 #CB18843385 - laptop was turned over to Richard B. to wipe the drive and load Windows/Office.
- Attended the GSO Inventory workshop presented by Don M.
- Attempted contact with Waco M. (Alt IT Chair/IT Support). Dan P. indicted his desire to step up to fill this position. Betsy G. motioned that, if no response from Waco M. in 3 days (01/27/16), Dan P. to assume the IT Support position – Marshall M. second. All present agreed.
- Need to submit the GoDaddy payment receipt to the Area Treasurer and needs to finalize the GoDaddy administrator transition from Mike W. (former IT Chair).
- Will pursue printing additional IT Committee flyers
- Goal for 2016 is to purchase another laptop
- Will get reimbursement check to the Postmaster for Gossimer payments.
- There is an urgent desire to have someone fill the Alternate IT Chair position in order to start the learning process
- Utilization of GoTo Meeting continues to expand with CPC Committee, PI Committee, TFC, IT Committee and considering use during the 2017 Convention

**Webmaster:** Jeff H. –

- The SETA website was last back up on 01/22/16 with 767 MB (77%) and 4,983 files. Since the December meeting, there were 33 site postings consisting of 15 meeting minutes, 4 flyers, 8 page contents, and 6 other (policy, agenda...etc.) - only a few documents required scrubbing.
- The “aa-seta.org” domain registration was renewed with GoDaddy by the IT Chair for a 5 year term
- I received a replacement laptop from the IT Chair – currently migrating from old to new computer

- The SETA Convention IT Committee display table was set up with the new display board and laptops for presentation and hands-on site navigation. **Support/Alt Support:** Waco M./Richard B. – not present - no report

**Review:** Betsy G. – There were 20 SETA Announce requests accepted and 1 spam requests blocked. All posting requests were in good shape.

**Finance:** Betsy G. – The finance report for December and January were reviewed. The December report stands approved as modified. Betsy communicated the 2017 budget adjustments to Marshall W. to include the Regional Forum line item and Rent for \$100 as well as increased email account pricing.

Proposal – Change the Gossimer (<https://www.gossimer.com/window-hosting.php> or <https://www.gossimer.com/linux-hosting.php>) e-mail hosting package to a web hosting package and leave the DNS records for the website pointing to the 1&1 site.

Advantages – Depending on the amount disk space required for the e-mail we have 2 choices

1. The Economy package which is \$59.88 a year for 100MB disk space and 250 email accounts
2. The Business package which is \$25.20 per quarter or \$100.80 a year for unlimited disk space and email accounts.

This would be a significant savings and everything could stay as it is. The current cost is \$61.10 per month or \$733.20 per year.

Possible Issues – They may not allow the DNS to remain pointing to 1&1. Name servers currently hosted by 1&1. Further research would have to be done to see if this is the case.
