- Much discussion on moderating group mail lists
 - Will moderate only these five mail lists: SETA Newsletter, SETA Vote, SETA All, SETA Announce, SETA Roster. Moderator for other lists to be turned off.
 - Follow up correspondence concerning SPAM mail via the CFC list indicate additional moderating may be implemented – yet to be decided upon
 - Jeff H. motioned to include IT Chair and Postmaster be included on all SETA mail lists in order to monitor traffic, Kyna D. second - passed

OLD BUSINESS:

- SETA IT assets –
 - Equipment is now with new Marshall W. with a few exceptions
 - Need to determine how to disposition antiquated equipment, i.e., e-cycling disposal. Some old equipment stored at SETA Archives facility
 - Remaining assets from Mike W. to be delivered to Mark Dube via Mike's sister.
- SETA Ad Hoc Committee - Cooperation vs. Affiliation – Betsy G.
 - The committee met on August 3, 2013, via Go-To-Meeting. Harold announced that I would be representing the SETA IT Committee.
 - Harold has selected participants from the entire SETA area, including Beaumont, Bryan/College Station, Lake Jackson, Katy and other locations closer to the center of Houston.
 - There was a lengthy discussion concerning the scope of the committee and the topics we would cover during our discussions.
 - There was a lengthy discussion related to the web site and several links and flyers to outside organizations, such as Intergroup and other entities with whom SETA committees cooperate. No decisions were made at this meeting.
