Reports:

Secretary – minutes reviewed and accepted w/2 corrections: Feb 25^{th} is the firm date for the Traditions workshop, and District Newsletter articles are accepted through January 15.

Treasurer – total undesignated funds \$2,205.01 – Brian asked for ideas to utilize the funds for our district service.

IT chair Toby B – plans include updating the District 32 page on the SETA website, posting newsletters, flyers, archived materials.

Treatment chair Quin A – First committee meeting will be Feb 14, 8PM, and Duncan Road Group. The name of this committee is changing to include Special Needs population – Quin will confirm what name the Area is using.

Business:

<u>Newcomer packets</u> – Brian will bring materials to the February 12 meeting (NOON at Champions). Two groups' GSRs expressed interest in receiving packets. Ginny will send the label template to Brian.

<u>Policy & Procedures Manual</u> – Adam F reviewed the changes suggested by the ad hoc committee, which were approved by unanimous vote – will email the final version to all committee members – Toby will post it on our webpage. Only point to confirm is the current name of the TFC – Quin to follow up.

Ginny will email the script to all committee members.

<u>Group Outreach</u> – Brian proposed that our District make a strong effort to visit all listed AA groups within D32 at least once this year, and invited the committee members to join him.
