## February 2014

#### 12 Traditions & 12 Concepts Reading and Summation

*February 2014 Tradition 2 / Concept 2* Kyle M. / Peter C. March 2014 Tradition 3 / Concept 3 Nancy R. / Jackie V.

*Tradition Two:* Four our group has but one ultimate authority-a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

*Concept Two:* The General Service Conference of **A.A.** has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

#### **History Corner**

*Nelson Newcomer:* In 1955, the groups delegated their authority to manage the day-to-day affairs of A.A. to the General Service Conference. How and why did they do that?

Angela Archivist: The groups delegated administrative and operational authority to the GSC and to the service bodies – the General Service Board, AAWS and the AA Grapevine. By confirming the permanent charter for the GSC, the groups delegated their authority for the active maintenance of the fellowship to the Conference, with the exception of any changes in the 12 Traditions or the General Warranties (Article 12 of the Conference Charter and Concept 12), making the Conference the actual voice for the fellowship as a whole and effective conscience for the entire fellowship. By approving the Conference Charter, the groups did not give up their ultimate authority as outlined in Concept 1. The groups can elect their delegate, who serves as their representative to the Conference, to serve on their behalf. The delegates approve the slate of Trustees who serve on behalf of the Conference, and thus the groups, during the entire year. The

This granting of authority by the groups in 1955 was not the first time the groups granted authority to others. Prior to that, in 1937, the Akron and New York groups delegated to <u>Bill and Bob</u> the authority to create AA's overall services so that AA could spread worldwide. <u>Bill and Bob</u> found trusted servants who could help them (<u>the trustees</u>). <u>Bob</u> then delegated responsibility for creating the structure to <u>Bill</u>. <u>Bill</u> gave responsibility for finances to the <u>trustees</u>, and the <u>trustees</u>, through the General Service Board and the two subsidiary boards, were then given control over the General Service Office, our public relations and the AA Grapevine, and so on.

But, Bill and Bob continued to feel that they held ultimate responsibility because the groups continued to look to them. Their big concern was what would happen when they were gone? By this time, Bob had developed terminal cancer, and subsequently passed away in 1950 after the 1<sup>st</sup> International Convention. So, <u>Bill</u> proposed that the ultimate authority be passed to all the <u>groups</u> in 1955 at the 2<sup>nd</sup> International Convention (Concept 1), and the <u>groups</u> then passed the active responsibility to the <u>Conference</u> which became the active voice and conscience of the fellowship (Concept 2).

So, today the collective voice of the fellowship resides in the groups, who, through their General Service Representative (GSR), delegate the authority to act on behalf of their group, to the delegate, who then represents them at the annual General Service Conference. <u>Clearly</u>, the General Service Representative is a very important link, without whom there would be a serious break in the chain of service. I hope each of you feel that responsibility and take it seriously. Betsy G.

Harris County, TDCJ and Federal prisons all require their own training and generally volunteers need a year sobriety.

# The Change That Comes

Service was something I thought I HAD to do in Alcoholics Anonymous. In my twisted mind, it was almost as if I had to be of service in order to continue as a member of AA. That was one of the reasons I didn't say no when I was asked/told that I was the Alternate GSR for my home group. I went to the district meetings... most of them. I half-heartedly participated in the district events, committees, etc. I wanted the pat on the back that I was doing my part. I remember being somewhat excited about it on occasion, but for the most part I just went through the motions. And I certainly had no sense of putting God in the middle of it.

I had to hit a Service Bottom! Which was incidentally just a small part of my own spiritual, emotional and mental bottom. It's amazing how even after almost 3 ½ years sober (or free of alcohol); I was still completely insane!

One night after a group conscience meeting, I asked a fellow district committee member a rather simple question about an upcoming event; I didn't exactly get the answer I was expecting. What I did get was a figurative slap across the back of the head! I was basically read the riot act on how poorly I was doing my service job and if I wasn't able to perform the job as the Alternate GSR, maybe I should think about turning it over. Not those exact words, but it gives a general idea of how I perceived it.

I was stunned! Then embarrassed, then hurt, then incredibly pissed off and every other "poor me" feeling that I could come up with to take on the victim role! Needless to say, I was totally DONE with that committee member. How dare they!

Of course I instantly had to tell someone about it! Luckily there was someone that actually listened to me. When all my complaining and whining was over, I realized it was me that wasn't OK. I needed something more for myself, something I had been denying myself for a long time. I needed God. I needed the Steps. I wasn't at all spiritually fit and my personal program was non-existent. How could I possibly be of service to anyone else if I was doing such a disservice to God and myself?

This "bottom" led to many changes in my life, most of which were internal. After all, that was the root of all my problems...me. I found a new sponsor. I worked ALL of my steps fully! I learned what it was like to be quiet and listen to others as well as God, rather than just being quiet and listening to my own thoughts. I still threw a few pity parties, had a few "poor me" moments and trudged through my service work half-heartedly. But I did what I was told. I didn't have to always like it or agree with it, I just had to be willing, and I was. That was the difference I saw in myself. I was done with My Way. It hadn't worked for me and the only person I had still been trying to convince was the woman starring back at me in the mirror.

When I started to feel as though I was allowing God to work through me instead of doing everything my way, I had a discussion with my sponsor about that particular committee member who had given me the "head slap." My sponsor pointed out that instead of being defensive at what had been said TO me; perhaps I could approach this member and ask what I could better do to be of maximum service in my position. Holy Cow! There's a concept... Asking others for help! So my sponsor was *suggesting* that I set my pride aside and ask for assistance?

After lots of prayers and lots of deep breaths, I swallowed my pride long enough to approach this member after a district service meeting and do what was *suggested* to me. I was a little scared and intimidated to ask such a simple question again. Last time I did, I was given a "head slap." But THIS TIME, I didn't get the same reaction. I wasn't read the riot act. I wasn't told I was doing a poor job as an Alternate GSR. What I WAS informed of is that it's okay to ask for help. It's okay to admit if I was struggling and couldn't fulfill my duties to the best of my abilities, I just needed to reach out to someone for guidance. This member was all too willing to share their experience as well as suggest several other members that would be happy to do the same, all I had to do was ask.

To this day, I'm still blown away at how different those two conversations were with the same person. The only way I can explain it is God! I brought Him into my life, worked my steps, and worked on me. The other person didn't necessarily change, the situation didn't really change, but I did. It was because I had worked MY program first. My attitude and outlook had changed.

Since then I've relied a lot on this particular district member to help guide me in many facets of service. I've gone from Alternate GSR to GSR. I've had to step up in some of my roles as a district service member. I've confidently volunteered on sub-committees in places that I know I can be of maximum service or places where I feel I could learn more. What better way to learn than to dive in the middle? I have a slight fear of going too high up in service roles, but that isn't for me to stress about. God will lead me on that path if that's where He wants me to be.

One of the most profound moments I had in my attitude change towards service came on a day when I was *just doing my job*. Nothing more or nothing less. I needed assistance and I reached out in an email to that once intimidating committee member. I was blown away by the message I received back. The first paragraph said, "...thank you for being responsible in your commitment... I am very proud of you!" I had to read that same sentence several times. This person who had only months ago given me that "head slap," who intimidated me, whose standards I thought I could never live up to, just told me they were grateful and proud of me. Tears welled up in my eyes, I was shocked! And I was tremendously grateful. I also felt pride in myself; the kind that comes from simply doing the 'next right thing.' All I had done was follow directions or suggestions; God's directions, my sponsor's *suggestions*, those suggested in the Big Book and of course, the ones I asked for from that particular member.

Today, I don't HAVE to do service 'work'... I GET to be of service! It's an honor, a privilege, and a blessing!
