History Corner

Nelson Newcomer: The long form of Concept Six tells me that the General Service Conference has the principal responsibility for Alcoholics Anonymous, and that it has the final decision in large matters of general policy and finance. So, why do we need trustees?

Angela Archivist: The General Service Conference (GSC) does, in fact, have the <u>principal responsibility for our fellowship.</u> The fellowship voted to give the GSC that responsibility at the 2nd International Convention in 1955, when Bill W. declared that we had "come of age." For the five years previous to the 2nd International Convention, the GSC was merely an experiment to see if it would work. Well, it did, and we, as a fellowship, agreed to move forward with that type of organization.

Up until this point, the Trustees of the General Service Board were our main policy makers, guided by our founder, Bill W. In Concept Six, the GSC recognizes that, although GSC has the principal responsibility, they only meet in session for one week a year, and are spread across the entire United States and Canada, making it difficult to manage the day to day operations our two publishing corporations, the General Service Office, and the various service committees that do a large part of the work.

So, in Concept Six, the General Service Board is given the authority to act **for us** by taking <u>active responsibility</u> (rather than principal responsibility), as well as being the chief policy makers for operation of the General Service Board (GSB) and the General Service Office. Concept Six outlines just how Trustees, through the GSB, will relate themselves to the GSC and to their active service committees. These policies are laid out in our Conference Charter and the By-Laws of the GSB, through which the Trustees are granted the traditional Rights of Decision, Participation and Appeal.

We give our Trustees this power to act for us because we, in turn, hold them mainly responsible for all our service activities, A.A. World Services, Inc., and The A.A. Grapevine, Inc. They are also the Active Guardians of our Twelve Traditions, and they are A.A.'s bankers and charged with safeguarding our Treasury.

At all times, however, the Trustees must operate under the close supervision of the GSC, through the various Conference service committees.

We have found that the basic corporate structure works the best for our operations. The A.A. groups act as stockholders, the Delegates are their representative and carry their proxy vote, and the Trustees are the Directors of the holding companies. So, just like any large corporate Board of Directors, the GSB and its two subsidiary boards must be given large powers in order to operate in a efficient manner to handle A.A. business and the principal world affairs of Alcoholics Anonymous. Normal Business:

- Secretary's Report Correction made on Current Items #2d to read \$100 budget approved for literature and printing costs from Misc. line item; Minutes approved as amended.

- c. Public Information/Cooperation with Professional Community PI/CPC

 Kate E. reported that at the March meeting they discussed plans for the Breakfast with the Clergy meeting in May. At the meeting this month they will do a practice presentation and stuff literature in preparation for this event. Area CPC met last night and discussed those items that are on the General Service Conference agenda that relate to pamphlets they distribute. They will take those recommendations to the assembly this weekend. Area CPC and PI Committees will be meeting this Saturday, April 12th at 4:30 at the Assembly. Please come to their next District 40 PI/CPC committee meeting on April 26th, 1-3 PM, Spring Branch Memorial Club, and see a presentation as it is given to Professionals who have contact with the still suffering alcoholic.
- d. **Correctional Facilities Committee CFC** Paul W. was absent; No report.
- e. Grapevine OPEN
- f. Intergroup Peter C. reported that 170 people attended the two meditation workshops, 70 on Friday and 120 on Saturday. The Intergroup Appreciation Dinner is Saturday, April 26th, from 6:00-9:00 PM at the Intergroup Conference Center. Speaker is Rev. Bill W Round Rock, TX. Suggested donation is \$50 and seats are available. Intergroup Open House is Saturday, June 14th from 10:00-3:00. All sales are tax free. Intergroup is asking for cash donations instead of desserts and sides.
- g. Information Technology IT Jackie V. reported that several positions are still open: Alt. Chair, Alt. Postmaster, Secretary, and Alt. Secretary; With Donnie/IT Support stepping down due to work load, there's a very good possibility that Waco M. new Alt. Support will be stepping up to the plate to be their IT Support person. Official voting in of Waco will be at their next meeting 4/26/14 which will leave the Alt. Support position available to anyone who has knowledge of computer hardware. Because their hot spot for GTM's is not working properly at The Post Oak Club, and because it does work at SBMC, they may very well be changing their meeting place to the latter. They will discuss this in more detail at their next monthly meeting.
- h. **Literature** Taylor K. reported that the next Area Literature Committee meeting will be at the April Assembly where hopefully a new Literature Chair will be voted in.

The Management of Change

To be completely honest, I saw this Title on a book and it started a string of random musings in my head. We get here with lives unmanageable, and are quickly told we must change everything. This is a sad realization and a daunting challenge. Without tried and true AA guidance, this would be impossible for most alcoholics (I would say all, but to honor our Traditions, I won't pronounce our way as the only way).

In AA's well tread path, this happens fairly quickly, even from the perspective of one day at a time. We stop pouring alcohol into our bodies. We concede that by ourselves we are doomed - that outside help is necessary. We commit to accepting that help. We launch a relentless attack on every dismissive and rationalized nook and cranny of our past, looking for our part in the disaster our lives had become, and we share our admittedly feeble first results with another person. (Gasp!) Let's take a moment at this point just to reflect: who would have thought we could, or would, embark on such an endeavor? Change is happening by the truckloads already.

Oh, but we're not done. We seek to recognize and willingly leave behind the most egregious of our character defects, many of which we actually liked! We like them no more, as we see their fabric woven into our own destruction. We compile a list (often a long one) of people we must humbly approach to perform restitution and acts of contrition, and we get right to it, delaying only if circumstances demand it, knowing by now that our lives are becoming whole, our relationships are becoming healthy, and our continued progress depends on this steady forward march. We continue to watch for new instances of hard to shake habits in perception, speech and conduct, we seek peace in prayer and meditation and we start helping others (Gasp again!) as we work to make all of the above a regular part of our new lives.

Phew! Makes me tired thinking about it. But in these thoughts, I reach an unmistakable conclusion. We came here with lives unmanageable, but with AA's help, we become first class managers of change. When we look back at our progress, the results are outstanding. Then we look around at our friends and their progress as they employ the same formula. How many times have you seen a member in a meeting, sharing about a lost job, a death of a loved one, a serious illness, on an on I could go, and yet, difficult as the events may be, they handle their situation with grace, courage, calmness, even optimism, and most importantly, without alcohol? It seems amazing, but when you consider what we do to create a new life, it is understandable. Change is no longer the harbinger of dread and depression; it is the herald of opportunity and growth. I don't fear the unexpected, the unknown, and the unexperienced event —bring it on! Recovery is like that, ready for anything. Are you ready?

As Kids See It

As I submit my newsletter article on this day, I also celebrate my 40th birthday. Magical for someone who came into AA just wanting to stop the pain & die, the will to live was gone. Today all I want to do is live! I talk a lot about my kids & the impact they have as my healthy motivators & the unique ability they have to teach me all the lessons that are so important. Mostly they teach me who I really want to be. Today I invite you into how my kids see our legacy of service...

As a child of two alcoholics I've had a lot of chances to be unstable, unhealthy, and unwise. Eleven years ago, however, my family and I were blessed with the gift of sobriety. I have lived more years in a sober home now than in a drinking one, so I've seen a lot of my parents' ups and downs. Most of the time, I only understand about ten percent of what my parents go through as active members of AA, but one of the most outstanding things they have experienced- that I am aware of- is the service facet of the AA world. It truly is a different world to me too. Despite that, their commitment to service has been equally inspiring and exasperating. As service and commitment is not unique to AA but is a part of everyone's lives, I believe that the work that my parents do has enriched their experience as active members of AA. In a way, they really have put truth to Gandhi's words, "The best way to find yourself is to lose yourself in the service of others." Service can often be a tumultuous adventure but it is often so rewarding that we forget the struggles we faced in the process. While my parents will maintain composure (sometimes) in front of other members and for the cause, they will often vent their frustrations to each other and to their incredibly patient children. It reminds me that they are, in fact, human beings who are entitled to emotions and feelings. Apart from that, what my parents have taken away from service these past years has been translated into my life as a young adult more than I realize. Their ability to teach lessons, with me begrudgingly learning, never ceases to amaze and inspire me. I fear that I would have no understanding of being selfless and giving if it wasn't for watching my parents work hard for themselves and for others in AA. I don't spend enough time reflecting on the joys that sobriety has brought to me and my family and I truly believe that their commitment to the program and service has enriched our lives in ways that no amount of material or monetary possession can allow. Because of their hard work and dedication as parents, what could have been unstable, unhealthy, and unwise is wholesome, mature, and loving.
