# **My Spiritual Bank Account**

My Grand Sponsor was a very spiritual mentor. Not that my sponsor wasn't a great inspiration for me spiritually, either; but, his sponsor seemed to explain things to me in a way that would make me stop everything that I was doing and reflect for a moment on what he'd just said. In fact, they usually turned into being long moments. In other words, he made me think. Today, I know that was exactly what I needed to learn how to do, allover again- relearn how to think.

The third step is like my spiritual bank account -I can use it however I choose to. Just like a real bank account that lets me make deposits and take out withdrawals, a spiritual deposit is necessary if I ever want to make a withdrawal from it. That was the one of many concepts that Allen, my Grand Sponsor, would suggest for me to think about. Again, I was learning how to change my way of thinking. When lead by my own way of thinking, doing, and acting my will alone produces destruction, alcoholism and with addiction as my only means of existing. My new found family in A.A. and the many mentors I have met here helped give me the perspective I needed in order for me to realize that it is not about me as much as it is about what I can do for you, and you... and you! When I can put myself last, others second, and God first, in return I am able to put some deposits into that "Spiritual Bank Account." That was what my Grand Sponsor had wanted me to see all along. But, I didn't know that at the time. He would be telling me these things and I was willing to try and listen.

Willingness is a vital beginning for me taking the third step. Also, continuing to apply so many unfamiliar principles like honesty, open mindedness, and willingness in my daily living was the only way for me to learn how to live those principles.

Making that decision early in my recovery to listen to people like Allen B., Mark B. (my sponsor), and others who had shown me love even if I didn't quite know how to love myself, gave me the hope that I needed in order to practice that having courage means having faith.

My decisions to want to try listening to the similarities and not to the differences, to taking others' suggestions, to getting a sponsor, to calling my sponsor, and to many more were made in my first thirty days of sobriety and would have a greater effect onto me than maybe the next twenty years of whatever I may decide to do. They were THAT POWERFUL!!!

Made a decision to turn our will and our lives over to care of God, as we understood Him is our means of making a spiritual deposit into a priceless bank account. Yet, it was only a decision. If I wanted to experience true satisfaction that comes with recovery, I have to work the rest of the steps.

Finally, before concluding the topic with Step 3, I'm also much happier knowing that when I have to make a spiritual withdrawal, when all my options were up and it seemed the only thing left to do was to surrender to Him and pray, I'm grateful to know that there was a deposit left and that was made.

# "There seemed to be no way around this God thing..."

Sitting in my small car, finishing a cup of coffee, I had one foot on the asphalt pavement and the other foot on the floor, when a thought crossed my mind. I had driven there on that morning because my wife of 12+ years said, "If you don't do something about your drinking, I'm taking the girls and leaving." It scared me into going to a club where AA meeting were held. Maybe I could get a grip on my drinking and just enjoy a few drinks now and then and not get arrested or fired or asked to leave places or lose friends. Maybe these people in AA could teach me how to drink like a gentleman. But another thought arose: What if they tell me I can't drink again? And then I began to remember all the times I had tried to manage my drinks, and it seemed like everytime I did, things and situations fell apart.

So I had to make a decision, and I said to myself, "Nothing else is working. Might as well give it a shot. And since drinking is not improving my

marriage, I'm willing to do whatever they tell me in AA. Maybe that will save my marriage." So I went into the club. Looking back, it was a the best choice I could have made.

But when a guy named Paul spotted me, and began working with me, right out of the Big Book, I began to shy away from this God thing. I'd had enough of that old-timed religion growing up, and I wasn't to happy with this thing called God. In fact, I was angry at It. Very angry.

In a couple of weeks, I had found a sponsor and he put me to work on the Steps immediately. And I was like a kid in a candy store, I wanted all I could get, so I went to work on the Steps. One and Two were not too hard to swallow, but number Three set off an alarm inside of me. There seemed to be no way around this God thing, no by-passes or short-cuts or Cliff notes to steal from. So I went into my bedroom and closed the door. And I intended to have a talk with this God who had disappointed me and allowed so many things to go wrong in my life, especially my childhood. And I tore into God with all my anger and profanity, starting off with, "If you want to strike me dead, give it your best shot, because I am very angry with you!"

I ranted and raved and found myself still living, un-zapped by God. So I continued with a little less fervor. Then it dwindled down to a talk. God never responded with a reply. I obviously knew there was a Creator and now I knew It would not argue with me or strike me dead for cursing It. So I decided, what the heck? I surrendered, after four hours in my bedroom, got on my knees, and read the Third Step prayer out of the book. And something funny happened when I did that. I felt that urge to drink, which had been hounding me for two weeks, slip away. It took a while to figure that one out.

So I called my sponsor and he said I hadn't followed instructions, that I had to do the prayer with someone with me. I considered it a mere formality, and did it with him later. But, looking back, that was in 1983, and I have only had one urge to drink since then. I think that little miracle that occurred while on my knees happened because in my anger I was being dead-level honest with the Creator, making what was probably the most sincere connection with It in my life. And I also learned that anger doesn't bother God at all. That is a human problem. Nor does profanity.

At this point in my life, I didn't have much else to lose. So I just tried it. While sitting in self-pity one day, I was on my way to a conference by myself. I remember talking to a friend, and suddenly, I felt this calmness. I asked him what this feeling was. He, of course, was not much help in giving answers; he just stated that I should pray about it. Obviously, not the answer I liked; however, that's exactly what I did. What I found was that on my trip to a conference where I knew no one, I was turning the outcome of this trip over to my Higher Power. I was letting something else guide me. I wasn't letting fear deter me from going to the conference. I finally understood what the calmness was. It was serenity of finally "letting go and letting God". There have been many instances like these in my sobriety. They have always come at times when I can't see anything past the fear. I may not like going through this sometimes, but at the end of the journey, I grow closer to my Higher Power as long as I'm not fighting it. The one thing I do know now; is that a lot of times, my Higher Power makes these decisions for me. It is a matter of me choosing whether I want to follow through or not. Today, although it may take me awhile to accept it, I choose to follow.

Before entering the rooms of Alcoholics Anonymous; I knew very little about a personal relationship with God or the God that I was introduced to as a child in Bible Study. I believe that lack of knowledge was a gift when I began my journey in recovery. I did what I was told to do; I did not know any other way. I am grateful you all steered me in the right direction. I was so desperate that I would have done anything at the time, if it meant the pain would stop. Like many other experiences that I have heard in regards to the third step, I took mine while kneeling and holding hands with my sponsor because like I said, I did what I was told. I had no idea what it meant at the time; I now know I didn't have to understand it to do it. It wasn't until I had four years of sobriety, can I say I actually had what I recognized to be a spiritual experience with the 3<sup>rd</sup> step and now my most cherished relationship with God. During a step study with some of the most beautiful women I have crossed paths with in these rooms, we were reviewing the 3<sup>rd</sup> step and I was given a gift that has not left me to this day. experience was enough. I got chills as I typed that and remembered the feeling of relief that washed over me that day. All I remember thinking is "my experience was enough." I wrote it down in my Big Book and still use it as a reminder today. The feeling behind that thought was freedom from alcohol. My experience with drinking was enough for this lifetime. God is in charge and the journey I am on is not one of running from alcohol; it is simply a journey to becoming closer to God. God is Everything. No exclusions or examples necessary. The freedom that comes with that belief allows me to be human today. Live life, as I am, on the rollercoaster, with an unlimited amount of Faith in God that can't be broken. This is a gift worth staying sober for, a step worth practicing, a prayer worth repeating and a principle worth living.




