Step Four: Vigorous and Painstaking Effort

My first thoughts about my 4th step experience ran the gamut from "Great! I'm moving forward on my steps...progress!" To "Crap...I know where this is heading. I'm going to have to be thorough and completely honest and I've heard all about the fifth step. I'm gonna have to share with another person the truth about some stuff I'm not very proud of." But somewhere in-between was the thought that I had committed to being willing to go to any lengths, as if my life depended on it, and that scores of alcoholics just like me had done a 4th step and it didn't kill them. In fact they said it saved them. So, onward I trudged pencil in hand, armed with strength from lots of prayer and encouragement from my sponsor to recount the most unpleasant moments of my life one by one. I truly started the fourth step thinking I had all of my past neatly complied in my brain ready to jot down on paper with ease. Wrong! When it came to writing it all down, one memory jogged another memory and suddenly I had more pages than I'd imagined possible. It was worse than I'd thought! Apparently I had buffered my shame and embarrassment with loads of denial and forgotten a few things along the way.

Sometimes when writing I was all fired up to be able to list all the things people had done to me

to deserve my resentvery difficult time writing towards others I loved and fear, unleashing character defects... rationalization which set down pencil, my coffee. get а better



ment. Other times I had a down resentments I had deeply. I felt annoyance some of my biggest procrastination and looked something like this: make another cup of pencil, check emails, and

ask myself do I really need to do all this writing to stay sober?? More prayer! Only the grace of my God could save me from this crazy thinking.

Looking at the progress I was making line-by-line and focusing on the promises in the BB also helped me keep going. Reading Step Four in the BB and 12&12 reminded me why I was doing this. I absolutely needed to come to an understanding of my part in past failures. How could I do that if I didn't have a clear picture of what those failures were? Finally, after 2 weeks and a thorough review, I was done. My thoughts were now ones of total relief and hopefulness. Relief that the painstaking process of remembering and writing were over. Hopefulness that once I shared this inventory with someone else I could finally let go of the bitterness, shame and feelings of powerlessness that had driven me to the dark side of drinking. I was one step closer to those demons being replaced with love, tolerance, and usefulness to others.

For me, willingness, prayer, and encouragement from my sponsor were essential to completing this step. And for all of that - I am grateful.
