SECRET SERVICE SECTION

Hello SETA Friends!

I am hoping that each of you are doing well and looking forward to seeing you soon and sharing in our journey of love and service. I thought that I would take some time to tell you about a service event that I was privileged to participate in this past September. We have such great areas in Texas and one in particular hosts an annual conference devoted specifically to Public Information (PI) and Cooperation with the Professional Community (CPC) service work. Yes, a whole day and a half of learning, training, laughing and interacting with AA members and members from the local community. The area I am talking about is the Southwest Texas Area (68).

This area has a strong lineage of performing service with these two service activities. I was privileged to be asked to attend and participate in the two-day event. They even asked if I would share my experience, strength and hope on Friday evening. Their annual event begins on Friday with a luncheon at a local restaurant. Members of the community were invited and attended that represented many professionals that CPC committees typically try to visit. I sat at a table with the local District Attorney and members of his staff. Other professions represented were; Probation Officers, Doctors, Dentists, Teachers, Ministers to name a few. The local CPC members put on an informative presentation and then allowed for a solid question and answer session. I was impressed with the turn out!

There was a break and then the event moved to a local church hall where the remainder of the weekend events took place. After the Friday evening speaker we all had great fellowship and retired for the evening. Saturday was a day packed with presentations, PSAs viewings, games, and most importantly reporting on specific service activities that were being acted out in the various districts across the area. This was the most exciting part of the weekend.

The first speaker shared her personal experience that even as a one women committee; she could take actions that had far reaching results. She literally stood from her doorstep and reached out to her local doctor, librarian, school and dentist. This really hit home with me that sometimes we are always looking for a strong full committee to do many activities, when the reality is the work can start small and still be impactful. While I am waiting for the committee to build, what am I doing to perform the service I want others to help me with? It is a good idea to have experience to share with the folks you are trying to inspire to walk with you in service.

Later that day another part of Area 68 had gone to the other extreme and had put together a comprehensive "Adopt a Rack" program. The committee had created Plexiglas racks that had labels on the inside for when the pamphlets ran out. The instructions shared who to contact for a refill on the pamphlets. The committee had a strong inventory of all the racks, where they were placed and who was responsible for refilling them. In addition, they had implemented a QR code on information pamphlets that when scanned with a smartphone took a person to the area's Public Information Website to obtain all kinds of information about Alcoholics Anonymous. Pretty cool I thought!

I was able to participate in a workshop session with another Past Delegate from Area 68. The focus of our discussion related to being assigned to the General Service Conference Committees for Public Information and Cooperation with the Professional Community and the service we performed on those committees as delegates. We took our local SETA PI Committee's "Truth or Dare" game and had a lively and fun question and answer session using the questions that were created by our Area members. An Area 68 member wrote to me after the weekend and shared that he wanted to use the game and actually add DARES for people to take if they did not want to answer the question or got the answer incorrect. He challenged me to come up with several dares that he could use during his game. One dare idea was to have a person running

around the room three times shouting as many things you are grateful for as you can. Another was to stand on a chair and say the Serenity Prayer to the tune of a favorite song (i.e., Happy Birthday). I thought this a great example of one person coming up with a great idea, the original game itself, and someone else building on that idea and taking it to a new level.

I loved this weekend service event and encourage others to attend next year in September 2016.

Visiting "Stepping Stones"

I visited the home of Bill and Lois Wilson almost 3 months ago and it is still a vivid and memorable experience. It is a visit I had to plan ahead. The home is nestled in the woods in small а neighborhood, so they only allow a few people to take the tour at a time. So even there is (donations though no cost appreciated) have to make you а reservation for the tour. It was about a 2 hour drive from where I was staying in CT but it was on beautiful back roads that made the drive very enjoyable and peaceful.

I have always been very interested AA in History so I had long known of the place where Bill and Lois lived out their lives, starting about about 6 years into Bill's sobriety. The place has been preserved just as it was when they lived there. When you enter the kitchen in this quaint house you have the opportunity not only to see the table where the Ebby brought Bill

message, but you can actually sit there. I was overwhelmed with God's presence in our program as I sat at that table and thought about how that moment occurred. First, Roland really wanted to go see Sigmund Freud about his drinking problem but Freud was too busy. Instead, he went to see Carl Jung. I am not sure that Freud would have suggested he seek a spiritual solution to his problem as Carl Jung As a result, Roland found suggested. sobriety with the Oxford Group and shared that with Ebby who ultimately sat at that table and told Bill there was a solution. It was another spiritual awakening for me that

I won't soon forget, nor the feelings I had at that moment.

Upstairs is where Lois preserved a lot of the history of events she and Bill were a part of. There are pictures with small notes on them and articles about places they went and spoke. It is also where Lois had her desk and did much of her writing and work on the Al-Anon program. There is even the story of the shoe she threw at Bill, which convinced her that she needed a program of recovery herself.

I enjoyed the short walk to "Wits End", the

writing studio Bill had built for himself. It was just far enough away to make you feel like you were in a different place.

When I sat at the desk where Bill wrote the Twelve and Twelve and the 12 Concepts for World Service and many Grapevine articles, I recognized what a dedicated writer he was. I appreciated all the hours he must have spent in this rather small space with only a fireplace for warmth in the winter, to share his ideas

for the future of our fellowship. Once again, I knew God's presence in our program with Bill as a gift to our society. I have to admit that I did place my hands on the desk and asked Bill to enlighten me as to the meaning of the 12 Concepts. I didn't have any flashes of wisdom, so I guess I will have to persevere in what I am doing with the steps and the traditions. Specifically, that is studying and praying.

I hope that anyone who gets remotely close to this amazing place will take the opportunity to visit. It is well worth the effort!

Greater than Alcohol but EQUAL IN AA

As a newcomer thrown into the foreign world of Alcoholics Anonymous; I couldn't help but imagine the worst case scenarios when exposed to the words found in the Steps, Traditions, Preambles & Prayers I commonly heard around meetings. As I look back on the alcoholic paranoia that consumed me in the early days of sobriety; I realize that it was that fear that opened my eyes, mind & heart to this new way of living.

I was terrified of you finding out the things that I had done in my drinking life. I was afraid to say I had no car, phone, money, friends or family. I was afraid if you sat next to me in a meeting you would hear the beast that was screaming loud in my ears, saying "DRINK". I was afraid to tell anyone I didn't know the Serenity or Lord's Prayers. I was afraid if I asked what something meant you would think I was stupid. I was afraid to tell you I did drugs too or that I had been arrested. I was afraid everyday that I wouldn't be allowed to come back even though I didn't want to be here. I was afraid to tell you I just wanted to die. The beast had destroyed all self worth & yet I still didn't want to stop drinking, I just wanted out of the pain.

The only requirement for AA membership is a desire to stop drinking meant absolutely nothing to me. I sat in meetings & said the words "I'm Michelle & I'm an alcoholic" & it felt surreal. I would listen to people talk openly about all of the demons that haunted me day & especially night. That led me to the next meeting, then the next & by week 3 of being led by the fellowship, God led me to a sponsor who led me to the prayers, to the Big Book, which led me to the steps that led me to the certainty that to drink is to die, which led me to the desire, the desire to live; that was 13 years ago. Not once in all of this time has my sponsor ever made me feel less than. I remember the day we did my 5th step, how she matched me story for story, emotion for emotion, fear for fear. She never looked down on me, away from or disgusted with me. She told me to lift my head up because from this day on I could walk with God through these spiritual principles to a true freedom, she continued to offer me a way out. What I know today is that as long as I was a slave to alcohol, I would never be enough, I could never measure up & I certainly would never be considered an equal to any of you. You



all appeared to be better than me because you were happy about being sober, you were enjoying life, and you had a desire.

I was sure that this AA thing was simply not going to work for me, I had done too many terrible things, and I didn't meet the requirement... sometimes it's good to be wrong!

On Tradition Three "The only requirement for A.A. membership is a desire to stop drinking." Editorial by Bill W.

"Our membership ought to include all who suffer alcoholism. Hence we may refuse none who wish to \square recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics 🖥 gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation."

This is a sweeping statement indeed; it takes in a lot of territory. Some people might think it too idealistic to be practical. It tells every alcoholic in the world that he may become, and remain, a member of a Alcoholics Anonymous so long as he says so. In short, Alcoholics Anonymous has no membership rule.

Why is this so? Our answer is simple and practical. Even in self protection, we do not wish to erect the D slightest barrier between ourselves and the brother alcoholic who still suffers. We know that society has been demanding that he conform to its laws and conventions. But the essence of his alcoholic malady is the fact that he has been unable or unwilling to conform either to the laws of man or God. If he is $\frac{1}{2}$ anything, the sick alcoholic is a rebellious nonconformist. How well we understand that; every member of $\frac{1}{2}$ Alcoholics Anonymous was once a rebel himself. Hence we cannot offer to meet him at any half-way -mark. We must enter the dark cave where he is and show him that we understand. We realize that he is $\frac{1}{2}$ altogether too weak and confused to jump hurdles. If we raise obstacles, he might stay away and perish. • He might be denied his priceless opportunity."
