Much More Than A Workshop

It was quite an exciting weekend in Winnipeg, Manitoba for the 21st annual NAAAW workshop. That stands for the National AA Archives Workshop. I took with me a display of AREA 67 Archives showing the history of early AA in the Houston and Texas area. This was skillfully put together by our Archivist Sarah D.

Much of the focus of the workshop was on Anonymity and the fact that any Archive material available to the public should be divested of last names - even posthumously.

As usual at an AA workshop the days were long and full of information. They began with an AA recovery meeting and ended with a special presentation to the full group. During the day, there were multiple break-out sessions on various topics with special care given to the focus on how to manage Archives. There were also sessions on the history of Canadian AA and Manitoba and Winnipeg AA.

What I personally found the most helpful were the sessions on Introduction to Archives -Basic Standards, Practical Preservation presented by two non-member friends with extensive experience in Archives. This gave many practical suggestions, unfortunately many of them are quite beyond our budget. They also gave us a list of resources that could be very beneficial in our efforts. The second was presentation Digital Archives: Why, Why Not and How. This provided so much information on the digitization of materials that I got a second CD of this presentation for our committee member in charge of digital media.

I could go on and on but the record of what occurred is going to be available online at the NAAAW site and in the Area 67 Archives.

In 1957 Bill W. reminded us that keeping accurate records of our history was of extreme importance so that our message would never be diluted or distorted. If you are interested in joining us in our efforts to fulfill this mandate contact us.

History Lessons!!!

The Just For Today group was formed because there was "nothing in the neighborhood" in Waller, Texas (population according to 2010 United State Census: 2,326). Many alcoholics had to drive to Tomball to find the nearest Alcoholics Anonymous (AA) meeting before Jim O. founded the Just For Today group in the summer of 2008. Jack E. is credited with making the first contact with the Español AA group in Waller that helped Just For Today become established on Sunday nights at 7 p.m. Roughly 15 people attended the inaugural Just For Today meetings at 2412 Main Street in Waller. The group initially dwindled to only a couple regular attendees when Just For Today moved to First United Methodist Church in 2011 but has since grown to about 20 regular attendees. In the spring of 2017, First United Methodist allowed the Just For Today group to begin holding meetings in the church's parsonage, which was going unused by the minister. The Waller Survivor's Group (which meet on Saturday mornings at the 2412 Main Street location) and an Al-Anon meeting (which also meets at 7 p.m. Sundays at the same current Taylor & Smith AA location) spun off from Just For Today, and the Just For Today group not only continues to meet Sundays at 7 p.m., but also has a Big Book Study on Mondays, a women's meeting on Wednesdays, and an open discussion meeting on Thursdays (all also at 7 p.m.).
