The Evolution of My Self-Support

The 7th Tradition was one of the first tradition that I ever understood when I came into the rooms of AA. I put my dollar (or more) into the basket; I help pay for the room in which I get to learn how to stay sober. I used to say it was the cheapest form of therapy I have. Over the years, my understanding of this tradition has evolved and grown to mean so much more.

The idea of Self-Support is more than just being financially responsible. Yes, the money that I put in the basket goes to the group for coffee, rent, literature, etc. It also goes to the district, area and GSO which all play various roles in my service and my sobriety. Without the money, AA wouldn't function. Money is needed to print Big Books. It's needed to make sure that GSO stays open and run the day to day business of our program. Our districts and areas need money to rent a facility to hold monthly meetings and quarterly assemblies.

But what about the other ways I can be Self-Supporting? I've grown to learn that it means listening to my GSR give her report every month at the group conscience meeting; listening to the district committee reps report what is going on in the various committees on all levels; taking notes to share with my district when our delegate informs us about happenings throughout our organization. Supporting my fellow servants is another form of self-support. I trust them to do a job that I may or may not be able, willing or qualified to do. It's important that I support their efforts even if it's just by being present and hearing what they have to say.

In my house, I don't earn the income but I can certainly be self-supporting in financial ways. I don't spend money frivolously. Especially if it means that my family won't have food or a roof over their heads. By not creating a financial burden, I am financially supporting my family. My job is to maintain the day-to-day chores around my house. Shopping, cleaning, carpooling, cooking, laundry, etc. If I don't do my job, someone else in my house will. That puts more on their plate than is fair, making me a drain on everyone else. I must do my part so they can do their part.

The 7th Tradition is so much more than monetary concerns. It's about us supporting our fellowship in all aspects. It's ensuring that the doors stay open for the newcomer who is just waiting to walk through. Without the money or the servants, the doors would close and those still suffering will be unable to find a way out!

Most conscientious AA members should quickly grasp the idea of being self-supporting. Many of us in the throes of our disease were quite poor managers of money. We have lied, cajoled, & begged our family, friends, and even those we didn't know well in order to get what we needed to feed our addiction. Those we have victimized are surely part of our Step 9 amends and restitution. Now that we are sober, we accept that from now on we will pay our own way.

But why shouldn't AA accept monies from generous benefactors who wish us well and want to help? Certainly in cases where the money comes with strings attached we can understand why such contributions should be declined. We alcoholics don't want to be told what to do!! But contributions made free & clear of any encumbrances should be okay, right? What could possibly go wrong?

Plenty can go wrong when a bunch of sober drunks start to debate/argue over the best use of a pile of money.

Such disputes would destroy the fabric of our program. We would lose sight of our simple singular mission which is to help the alcoholic who still struggles. Instead, our energies would focus on grandiose ideas/plans for spending the money.

Each AA group needs enough money to cover basic expenses plus a prudent reserve. Period. This stance of financial independence shows outsiders that we are not a charity who needs to endlessly raise money through drives, car washes, bake sales, etc. Through Tradition 7 we proclaim to the world that we who were once haplessly irresponsible where money was concerned are now financially responsible members of society.



2017 Challenge Program - Intergroup would like to send a representative to District meetings to explain Intergroup financial status, plans, and restructuring

Urging group participation in sharing the 7th tradition basket, the suggested average donation to your local intergroup is 50% after group expenses.

Group contributions have increased over 50% comparing the 1st quarter of 2016 to the 1st quarter of 2017.

Prudent Operating Reserve Goal - the board of trusties have agreed that Intergroup would need \$20,000 a month for a six-month period to responsibly adjust operations to serve the fellowship in a catastrophic scenario. This decision established the Prudent Operating Reserve Goal at \$120,000 minimum. Currently at 59.7% of Goal / 40.3% under reserved.

(YTD Income) - (YTD Cost of Goods) - (YTD Expenses) = (YTD Total Profit) (\$129,355.82) - (\$55,975.64) - (\$54,215.69) = (\$19,164.49)

Bookstore pricing increase effective March1st (Averaging a price increase of 5%)

Decision was made at the Feb meeting to limit the hearing-impaired signing Program to one meeting per month due to budgetary constraints.

Hosting Report for SETA Assembly, April 8-9, 2017

D40 hosted the Area Assembly providing the following services:

Overall the weekend was a huge success. We had a great group of volunteers that showed up and were accountable to our area service committee. In the hospitality suite we served breakfast, lunch and dinner on Saturday and breakfast again on Sunday. Total spend for the hospitality suite was \$755 for food + \$25 tip, beverage and service supplies. Volunteers were available to man the registration desk all day Saturday and until roll call took place on Sunday. The volunteers sold coffee badges and collected \$365 on behalf of SETA. Volunteers manned Intergroup's literature table most of the day on Saturday and till close on Sunday. Total sales equaled and we were only off by \$.05. Finally, Jackie S. and Cindy M. put on the new GSR

workshop and did a fantastic job explaining the basics! Total spend on literature for packets was \$49.

We collected quite a bit in 7th tradition for the hospitality suite but had to spend a portion of it to keep up with demand, as well as to replace utensils that were noted on the inventory list that were not in the bins. Returning \$246 back to district.
