
I was told that the drinking was not the problem, it was only a symptom. The real problem was centered in my mind, my thinking. I felt pretty screwed at that point. I was told that total abstinence was the key and that I had to change everything. I started to get the sucky feeling that I had over shot the mark on this help deal. Then they said just worry about it one day at a time or in smaller time increments, if needed, during the day.

I still had very little appreciation for the help that was being shown me. I had to want this deal. It could not be given to me. I was told that his disease is a progressive illness and that I'd start from where I left off if I went back out. They said my long term alternatives were live miserable, get a wet brain, be institutionalized, go to prison, or death. I figured that my negative attitude might not be that bad and that those options were not a very positive outlook for the future. So I stayed to check out the help being given to me.

Through sponsorship, having a home group, studying the literature, working the 12 steps and being of service, my attitude, thinking, perception and self-worth have been transformed. As a result of steps and getting in contact with my Higher Power, God, my thinking and perceptions are on a more positive plane. Being of service has changed a lot of my perception of life.

I can appreciate people, places & things in my life on a more positive and deeper level as time passes. As a result I am more grateful for the place I find myself and my life now. I have more of an attitude of gratitude. This attitude has been given to me over time and by applying the principles that have been shown to me through the program of action.

I have been known to criticize, judge, give my opinion and take other people's inventories. This is not the way to live the principles of the program. When I got discouraged, I was told to write down the things that I was grateful for at that moment. What good would that do, I thought? It pays very helpful and worthy dividends. As time goes on I have found myself now grateful for people, places and things that I had previously put on my resentment list. Over time the attitude and perception changes. I guess that I have



acted my way into an attitude of gratitude. I could not have thought my way into that attitude.

I had spent my life thinking that I wanted to do better, that my life was not going in a good direction but I never took any actions to change my behavior. The program in the AA fellowship has given me the way to act so that I have this attitude of gratitude and can feel it in my heart that this is the easier softer way to live my life. Hal M from Washington DC had promoted the attitude of gratitude that he found in the fellowship. If I am grateful for what God has given me, and accept who I am, then there is very little room for negative thinking to be in my keen alcoholic mind.

I hope that I will be

forever grateful for AA helping me to have a change of perception and an "ATTITUDE of GRATITUDE" and feel that it can be with me if I continue to work for it.
