#### In AA or Around AA - Reino F, DCM

When I came to wanting help I went to a treatment facility. There in the first week I was introduced to AA. After, treatment I went to a halfway house and continued to attend various AA meetings. When I got out of the 3 month halfway house two other guys and I rented a house. After approximately 9 months of sobriety I got a home group. Through these early months I had mentors, old timers and elder statesmen showed me by example and suggested things to do and ways to live so I could learn to live in sobriety.

I was told that I came into AA and I know how to drink but I do not know how to stay sober or I wouldn't be here. They led by example how to live sober and gave me ways to do that and to help change my thinking. Somedays they even hurt my feelings.

At 15 months sober I moved from Minneapolis to Raleigh, NC. Then when I was 18 months sober I asked a man to be my sponsor. He asked me if "I wanted sobriety and to stay sober more than anything on God's green earth?" I said,"Yes." Then he asked me if "I was willing to go to any length to get sober?" I answered "Yes", not knowing what this REALLY meant.

I followed this man like I was in his back pocket. He kept saying there were certain things he needed to do to stay in AA.

It was *suggested* that I get a home group, get a sponsor, get a network of AA members, work the steps of the program in AA, study the Big Book, get a Power greater than myself, learn to reach out to the still suffering alcoholics in and out of AA, be of service and somedays just 'hang on'. It was *suggested* that I be honest, open minded & willing. These things would keep me grounded in the program and fellowship of Alcoholics Anonymous.

Over the days, months and years I have found this still to be true for me. I need to be in the program of AA and not around it. If I'm only around it I am most likely still trying to be in too much control of the very stuff that brought me to seeking help in the first place. I cannot afford to tip toe thru the tulips with this thing called my life.

The time I did this, at 17 years sobriety, I went way off the path of a positive direction in daily living that I was given in AA. I did not drink but I was not living life on life terms as I was taught. I was helping to take care of my family due to some dark non-sober living that happened to my spouse. I did not get away completely but I did those suggested things I needed a whole lot less than I was normally used to doing. I slowed down on attending meetings, contacting my sponsor and just stayed at a distance from the fellowship.



behavior I got a letter in the mail box from my sponsor. It said that when I need it that the home group is still meeting on the same two nights at the same location and they would really like to see me and hear what I had to share. When I turned the letter over there was a map showing how I could get from my house to my home group. What a thing to do to one of the backbones of the group, eh?

So, I got back on track doing the things that were suggested and now they needed

to be done so I would get back in and hopefully stay in the program of Alcoholics Anonymous. I have been doing these things ever since. I now do not want to be around the AA program. It does not help me with daily living, dealing with life on life's terms and staying out of my own head and potentially running the show called my life.

It has been a whole lot easier trudge than the other way. Now the program of Alcoholics Anonymous is the easier softer way. I now do these things because I want to do them not because I feel I have to do them. I heard my sponsor say in a meeting, when he was 30 years sober, that "he needed AA more now than when he first started" and I, at 5 years, did not understand that comment. At 33 years sober I now do understand that statement and appreciate it.


If I stay surrendered, seek contact with my higher power daily, seek my sponsor and my network to review what I am doing so they help keep me in line, my motives centered around spiritual principles, get to my home group when it meets ,and be of service to others, then things seem to go much better daily for me.

I cannot take people, places and things for granted and need to live in an Attitude of Gratitude on a constant basis then I will stay in AA.

#### Nothing Changes if Nothing Changes

Despite being one of the more commonly repeated AA slogans, this one might confuse you at first. It sounds simple, yet its meaning can elude those who hear it for the first time. Like many AA slogans, this refers to how we work the principles of the program. Do we sit around and wait for things to get better? Or do we transform into the person we wish to become by rolling up our sleeves and working at it? We can stop drinking and doing drugs. But if we continue living essentially the same lifestyle, we can't expect to make much progress as human beings. We usually hear this one when complaining about our lives. People say this not to blow us off, but to tell us that we possess a choice. We can either let go and hope for the best, or we can make some necessary changes in our lives that may better our circumstances. 
