




Tradition Two - Trust

Trust is defined as assured reliance on the character, ability, strength, or truth of someone or something. One in which confidence is placed. Something committed or entrusted to one to be used or cared for in the interest of another. To place confidence, depend. To commit or place in one's care, entrust. This was a hard principle for me to deal with when I first found AA.

I had trust in the family members when I was a kid and growing up. As I became a teenager and developed the attitude that you can't tell me what to do this changed my trust of people. I developed the ability to look like I believed in what I was hearing, tried to act as if, but I was pulling away inside all the time.



In wanting help, going to treatment, and then finding AA I saw people doing things and I was hearing things that went against what I had come, on my own, to believe in over the years. I was told to change everything that I brought with me to AA. That was what I thought was going to be a daunting and hard task. If left to my own devices it would have been just that. I had to get out of my own way.

Through getting a sponsor then a home group

and finally a Higher Power this whole principle of trust has taken on new meaning in my life. I selected my sponsor because he seemed genuinely interested in my wellbeing and I wanted what I thought that he had, at the time. I like how he walked the talk. He helped me more than I could put into words. The group was my Higher Power for the early days. I saw a group of people trying to stay sober together. They functioned better than I ever thought to do on a day to day basis. I actually found some friends there, and in the fellowship, and developed a network of AA members to share my daily life with them.

Through service work I saw this working in AA as a whole. There were people becoming treasurers that had been in prison for all sorts of illegal activity at some time. We trusted them with our money and to be responsible with it. The group has a steering committee that seemed to be able to review issues, give an option on how it might be handled and then letting the group decide for itself. This amazed me. My mom and dad were my first steering committee; they did the best with what they had to work with.

I have served at the group level for various commitments (greeter, coffee maker, steering committee member, GSR, chairman, etc), and at the district level as treasurer. People have trusted me. I have seen that things need to get accomplished that I cannot give the time it deserves to get completed and have trusted people to get it completed; maybe it could have been done better, HA!

Through the fellowship of AA I see this principle being used on a daily basis. We let the delegates take our voice to the Conference. They, and we members, allow the Trustees and the GSO office to deal with the day to day issues and business that needs to be performed. So why do I want to try to let everything run through me? The friends I have made show me to trust my Higher Power and the plan It has for me and I will be in a better place personally to pass on my experience to the next newcomer and to the next trusted servant in the service structure.



Texas AA History

Written by an Anonymous Attendee

For those who enjoy the rich and storied history of Alcoholics Anonymous, October 19th's presentation 'How AA Came to Houston', presented by Intergroup and the SETA Archives Committee, was a deep dive into nourishing waters.



Go to any conference, convention or roundup and you'll inevitably spot an old-timer recounting stories of our past, surrounded by a squad of us eagerly leaning in for more. Yes, as a society, we AAs are always up for a good story. Perhaps this is by design. Since Bill's fateful visit with the stoic doctor from Akron so many years ago, it has always been the weaving of a tale based on past experience that establishes the mystical identification required for a beginning to our journey.

It's this same passing of the historical recounting that first draws us in to the message of recovery that leads many of our tribe to appreciate 'from whence we came'. Presented by the Archives Committee, this two-hour talk was divided between a quick telling of how the message originally found its way to Bill W. – and a much meatier offering of how it arrived in Houston in the Fall of 1940 and flourished.

It is a truism that God uses the broken to get His message out; and, true to form, He brought a washed-up and tattered newspaper man to Clarence S. and the gang in Cleveland. Larry J. was found and rescued "more dead than alive", and then nursed back to what barely amounted to health in the Cleveland AA circuit. Upon doctors' declaring that Larry wouldn't survive another Cleveland winter, a collection was taken up to send Larry to warmer climes to save his life...and so the seeds were sown to deliver the fledgling society's message to the streets of Houston. His writing experience eventually led Larry to author a 6-piece series of articles on alcoholism presented in the Houston Press....and with some misgivings, they consented (Sound familiar?). What ensued would be another string in the tapestry of divine choreography that bring you and I to where we stand today.

In an odd parallel with the man that brought the message to Bill W. (Ebby T.), Larry was not able to accumulate any long-term sobriety before his eventual passing in the Spring of '44 but did establish the first group of Alcoholics Anonymous in Texas; the first west of the Mississippi. Of course, Larry's wasn't the only contribution. As is standard wherever our message is delivered and thrives, we in Houston owe debts of gratitude to local clergy (Bishop Quin), the media (Houston Press), the medical fraternity and those who came before.

Information packets provided to participants contained historical photos, correspondence between first members of AA in Houston back to Bill W. and his secretary Ruth Hock in New York, the first AA pamphlet (1940), Esther E's (First woman member of Texas AA) story, an

article on the Montrose Club from the Houston Press ('49) and a virtual treasure trove of archives giving a ground-level view of early Texas AA. From Roy Y. (First Texas AA member), Esther E. (First female Texas AA member), Icky S. (First Explosive Ordinance Expert Texas AA member), to Pop W. (Founding member of the first African American AA group in Texas), these stories and lives lived are as similar to ours as if we were all members of the same home group today.

A deeper look at the founding class of AA in Texas reveals commonalities with many, if not all, of the "pains of growing up" experienced by the original founders of Alcoholics Anonymous in Akron and New York. One can get the impression that several of the cautionary tales from the Traditions essays in the 12 Steps & 12 Traditions could have possibly come directly from the streets of Houston. We can smile at the escapades, fevered egos and group turmoil with comforting knowledge that we are all the same, our defects are no more numerous or severe than any group of alcoholics ever assembled. More importantly, the moral of the story may be that it is not *in spite of* these things that we are now joined, but *because* of these shared frailties we are joined in what Bill called 'brotherly and harmonious action'.

Many who study the history of Alcoholics Anonymous often ponder the random, seemingly disconnected events that transpire and eventually culminate in bringing about change and growth. "How", they ask, "could a guy with just three years of sobriety, surrounded mostly by people slipping back into alcoholism and fighting, write a book that would change the lives of millions of the most desperate among us, and still be studied without revision 80 years later?" "How could a tubercular alcoholic near death on the streets of Cleveland, Ohio be practically raised from the dead and sent 1,300 miles away to a place he had never been, by people he had scarcely met, with no money and only a desperate craving for sobriety, possibly hope to survive?" But survive he did. To us in AA the answer is simple. At a very deep level we know that to those who have no Higher Power, no explanation is possible; and that to those who do have a Higher Power, no explanation is necessary.

We are grateful that we have Archive Committees to remind us.
