
Spiritual Principals

We can get these principles from working the AA program of action, the Twelve Steps. Also, it is suggested that we take the Twelve Steps with a sponsor or spiritual adviser.

What are these spiritual principles? The statement "AA's Twelve Steps are a group of principles, spiritual in nature, which, if practiced as a way of life, can expel the obsession to drink and enable the sufferer to become happily and usefully whole." Also, the statement "AA's Twelve Traditions apply to the life of the Fellowship itself. They outline the

So if I work the Twelve Steps to the best of my ability and try to encompass the Twelve Traditions in my daily life then I believe that I am living the spiritual principles.


Here is a list of the principles (identifying words) that I have seen to describe each step and tradition:

I have had a lot of members of my club ask if we had another way to pay in "Pass the Basket". My group currently has 41 meetings a week so we have members coming to a meeting at all times of the day - from the Gym, Office, and Home. Most of them don't need cash on hand in their daily lives. So when they are at a meeting and the basket is passed they would like to donate but cannot. This makes it an extra step in everyone's busy schedule to run but the bank or cash machine to

have cash. I have been asked multiple times if there would be a way to utilize any current technology to enhance the "Pass the Basket". So I figured I would start to look around and was told about "Parishpay" someone was using at their church. That got me started to look around more and figured I would bring it up at the District meeting. I was told a group was using Venmo but did not get any more information beyond that. The next Area Assembly we had I asked around also and no one was using anything in their group just a few had anything setup for their club. Then I was told I should shoot a message over to the GSO and see if they had any info on this and they sent me back a Box 459 article, Vol.63, No 4 Winter 2017. This article starts off with a treasurer of a group in Manhattan dealing with 15 meetings a week and was looking to streamline the process. A few other groups followed down the same path and you can read all about them in the Box 459 article but what it boils down to is that we, as a society, are moving away from the dollar bill and sliding into a pure digital world. I think it is time to start setting up those avenues sooner than later. Now the smaller groups will come into a cost issue on monthly reoccurring charges on fixed devices but apps like Venmo seem to be working for many groups, as of the Box 459 article. You should contact your bank and let them tell you what apps they prefer to work with is my suggestion. I am working on a device based solution for my group due to us having so many meetings a week we can justify a monthly reoccurring fee to cover extra options like monthly reoccurring billing, single point sale and keyed in transactions. I hope this information enlightens you and helps you in your journey on upgrading the way we keep Tradition 7 alive.
