Group history (such as anniversaries, special meetings, outside speakers, notes about the location, etc.):

A group of individuals recognized the need for a Big Book study in Katy, as there were no others at the time, so they decided to start a new meeting to study the Big Book. They began meeting at one of the founding member's home in June of 2015. The meeting grew by word of mouth and sponsors letting sponsees know about the meeting. In September of that same year they began looking for a space to rent. They tried a few different venues, but there wasn't any interest. One of the members contacted Holy Covenant Church and the church said they had a meeting already there on Sundays, which was a men's meeting. One of the members contacted the men's meeting to ask if JTBPG could also meet in the church but wanted to insure they were not intruding and also that they were following Tradition 4. The men's meeting felt it was not an intrusion or conflict and welcomed JTBPG to the church. The group began meeting on Saturday evenings at 6:00 PM in October. The composition of the meetings was and continues to be made up of both men and women. After 6 months JTBPG registered with GSO. following the suggestion of waiting 6 months was from one of their sponsors and from the Group Pamphlet. In February 2016 JTBPG officially registered and was given a number. This same month JTBPG asked the church about adding another night and began meeting on Thursdays at 7:00 PM to study the 12 & 12 as a step and traditions study meeting. In accordance with Tradition 3, both meetings are for anyone with a desire to stop drinking. Both meetings follow a

discussion format where we read portions of the either the Big Book (on Saturdays) or the 12 & 12 (on Thursdays) and then discuss them in depth. This also provides an opportunity for participants to ask questions about what is being read. In June 2016 officers were voted in along with a chair (Jon N.), secretary (Heidi M.), treasurer (Donnie M.), GSR (Reino F.), alternate GSR, and Coffee Chairperson. In the summer of 2016 the group invited the Alternate Delegate, Troy, in to facilitate a group inventory. Group conscious meetings were held on the last Saturday of each month at 5:00 PM. In October 2018, group conscious meetings were moved to every other month, corresponding with the Intergroup Delegates meetings. JTBPG donates proceeds to Area, District, and GSO, as a way of showing our support for Intergroup we purchase all of our literature and chips from Intergroup.



On 11 April 2017 Reino F. presented JTBPG's history to District 40 meeting, it was the very first Group History given at the District 40 meetings. Deborah was the DCM at the time, and she began this as part of the monthly meetings.

In the beginning the group celebrated AA anniversaries/birthdays on the Saturday after your AA anniversary/ birthday. In October 2017 the group conscious decided to celebrate a year or multiples on the last Saturday of each month. The person celebrating their AA anniversary/birthday asks someone to present their chip to them and then will say a few words themselves. JTBPG participates in special local and regional functions such as conventions, round ups, forums, and workshops.



One Day At A Time

"One of the most common AA slogans is "one day at a time." This simple phrase carries two essential messages. First, we must focus on the present. We cannot see the future, and we cannot control the universe. But we can control our own actions right now. We often meet people with decades of sobriety, and this feels imposing. It's easy for us to wonder if we'll ever achieve the same as them. When we worry so much about the future, we can often become despondent. We worry that we may never amount to anything, and we respond by throwing in the towel. By focusing on the now, we forgo this trouble and allow ourselves to maintain our sobriety on a daily basis.



While this most prominent of AA slogans tells us to take life one day at a time, we often hear AA members say that they must take life one hour or one minute at a time. It may sound like they're joking, but quite often they are not. Every moment of every day, we must choose to do the next right thing. Continue to focus on wha't right in front of you, and you can continue to live with a clear conscience. Lose sight of this, and you just might find yourself picking up a slip chip at the next meeting.
