In between the drunken stupors it gave some feeling of doing something. But, that feeling was very fleeting.

As I can recall those were the main times of being of service unconditionally. There were helping the family, helping friends, visiting folks at the hospital but it was seldom unconditional.

I found myself in the 4th one and have never felt more alone in my life. The next evening I was at my apartment and thought what has gone wrong with life? I am not living the way my mom and dad had tried to raise me. What the heck happened?

I went for help and found out that what happened was all along I was with myself and taking myself with me where ever I went. I was the problem. My thinking, perception, opinions, habits, life style and attitude were my undoing. I could not get relief from them. I drank to hide from them.

So changes in all that had to happen for any hope of relief and a better life. I found that relief in the fellowship of Alcoholics Anonymous, the rooms of AA groups, a sponsor and being shown the program of action and working the 12 Steps in AA.

So, now being of service has come full circle. Service now starts with being at my home group when it meets, making coffee, setting up the meeting, greeting people who I do not know when they show up, calling the members who are not at meetings for some reason (? call them), work the steps, sponsor when asked, and reach out to the suffering alcoholics outside and inside the fellowship of AA.

Then, being a member in the fellowship of AA I got interested in the history of this deal. Also, I was strongly suggested to give back to the fellowship that has given so much to me and helped me to change my life. Eventually I was elected a member to the home group's steering committee as an Alternate GRS, GSR, and then Intergroup Delegate. I eventually served as the Intergroup Chairman. Moved to Texas and got new home groups as I have lived here, seeking the fellowship I craved. A new home group was formed and I was asked to serve as the GRS. I did and then at the District served as the Treasurer. Well after three years I stood for Alternate DCM. Started in January this year and in April was moved into the DCM position that the DCM could not fill out her term.

It has been proven to me over and over that if I were to figure out plans and the outcomes of them I would always



Easy Does It

"On the bottom of page 135 of Alcoholics Anonymous' basic text book, commonly and affectionately known as the Big Book, three suggestions or slogans are offered at the end of the chapter titled The Family Afterward. The section concludes with a description of how, sometimes, families miss the miracle of a sober alcoholic because they are too busy expecting rapid progress in areas outside of abstinence. The author of that chapter, A.A. co-founder Bill Wilson, wrote this: "We have three little mottoes which are apropos. Here they are: *First Things First. Live and Let Live. Easy Does It.* They are the only italicized slogans appearing in such a manner in the book.

If you are into stats, we find the word 'easy' appears ten times in the Big

Book and another seven times in the book 12 Steps and 12 Traditions. In the Big Book chapter Into Action on page 86, the page after the Promises end, we find this nugget: "We relax and take it easy." It refers to prayer and waiting for God to lead us into an intuitive thought, a good idea."

In the 12 and 12 book, in the chapter on Step 2 on page 26, we find this: "His sponsor probably says, "Take it Easy. The hoop you have to jump through is a lot wider than you think." Bill is referring to a newcomer struggling to accept his powerlessness and a Higher Power as the answer to it."
