Tradition Six - Non-Affiliation

Reino F, DCM

The definition of Affiliate is "to bring or receive into close connection as a member or branch (affiliated organizations)". The definition of Affiliation is "combined". The definition of Non is "not, reverse of, absence of". The words defined in the 12 N 12 dictionary are: Affiliate "associate, partner, join, unite, ally"; Affiliation is "connection, association, partnership, alliance, attachment". Tradition Six says that "an AA group ought never endorse, finance, or lend the AA name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose".

The Long Form of the Traditions says that "Problems of money, property, authority may easily divert us from our primary spiritual aim. We think, therefore, that considerable property of genuine use to AA

should be separately incorporated and managed, thus dividing the material from the spiritual. An AA group, as such, should never go into business. Secondary aids to AA, such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not use the AA name. Their management should be the sole responsibility of those people who financially support them. For clubs, AA managers are usually preferred. But, hospitals, as well as other places of recuperation, ought to be well outside AA – and medically supervised. While an AA group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An AA group can bind itself to no one."

When I came to the idea that my life was in shambles, not living the way mom and dad tried to raise me or having shown me tools to live by, I had no idea that AA even existed. I went to treatment. The first week an AA group, who met there every Sunday, was my introduction. Then, at the halfway house we were required to attend AA meeting during the week when our house sessions were not meeting. I was unaware what was going on with the Traditions then but those facilities did not even imply any connection with AA. I was told that the hospital was a business and if it closed then the aftercare meeting would be done. They told me that my life line would be the AA program and fellowship whether I liked it or not. It was my choice to make if I wanted to seek sobriety.

Then, I moved and eventually found out that my own home group had looked into getting a piece of property and build a building to meet in it. They moved really slowly and the idea was voted down. But there was a good sum of money that was in an account for the deal. It was still open and collecting interest. The group voted to offer the original contributors, or their surviving families, their donations back. All decided that the money should go to the AA entities the group thought appropriate. So, it was divided per the then current percentages and the account closed. The elders and old timers figured they should do this so the members who were not involved would not stress or weird out about that issue and potentially cause the group future harm.

I have seen a couple of members own and manage recovery centers and I have seen them keep AA and their employment, income, and livelihood separated from each other. They were fine examples of this Tradition. I have also seen some AA members get really jacked up over monetary deals in AA and it affected other members that they drew into it. Everyone suffered to some extent.

There are groups that hold their meetings at hospitals and recovery centers and that can be a good thing if they are there to be available to the newcomers transferring out of those facilities. But it is not a good policy for the groups to get too into the business dealings of the facilities nor let the facilities make policy for the AA groups conscience. Then, the groups may want to find a different place to have their meetings.

You know I do really stress over my personal finances and how I spend money, now. For years I did not pay much attention to that function of life. Consequentially I am getting closer to retirement and I have very little in the way of any life savings for that chapter to come. But I am to live in the NOW and deal with life on a daily type basis and the finances are getting better but no where near comfortable. This was an individual messing around as an active drunk and as an active member of AA. I did not pay very close attention to my mentors. Now I go to work and try to save money, what a novel concept, I try to do the next right thing.

I say that to mention if I had to personally deal with a club or a business in AA what a mess that would be and the mental stress in the background, sheesh, I do not need any other stress than my own mind!!!


I began to learn the importance of singleness of purpose, both in AA and in my personal life. I came to understand the difference between that which helps and that which hinders. By keeping my AA program simple, I underscored my own way to Live and Let Live. This tradition helps to preserve the integrity of the program, groups do not endorse any outside organizations and causes. We are all perfectionists who, failing perfection, have gone to the other extreme. We cannot be all things to all men, nor should we try.

My hope is that I can follow this principle in my life as to be a spiritual example and conduit of what the program and fellowship in AA can do for someone who seeks it and tries to pass it on to others who are still suffering.

The Serenity Prayer is a common name for a prayer written by the American theologian Reinhold Niebuhr (1892-1971). Niebuhr used various versions of the prayer widely in sermons as early as 1934. The prayer spread rapidly, often without attribution to Niebuhr, through church groups in the 1930s and 1940s and was adopted and popularized by Alcoholics Anonymous and other twelve-step programs.
