
## Concept 7

# Tradition Ten - Neutrality

(Outside Issues)

Reino F, DCM

The definition of Neutral is "Not to engage on either side; not aligned with a political or ideological grouping, a position of disengagement (as of gears)". The definition of Neutralize is "To destroy the effectiveness of; nullify". The definition of Neutrality is "The quality or state of being neutral" (whatever the hell that is right?) The word Neutrality defined in the Big Book dictionary is: "Neutral or middle ground/non-participation in war/indifference". Tradition Ten says that "Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.".

The Long Form of the Tradition says that "No AA group or member should ever, in such a way as to implicate AA, express any opinion on outside controversial issues – particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters, they can express no views whatever."

Coming into AA, after being introduced to it through the treatment center and halfway house (where I sought help for whatever the heck was wrong with me and how I was living life) I was introduced to principles and life concepts that were pretty much foreign to me. Other than being all caught up in myself and my issues and my life I had a very narrow appreciation of others and their concerns and their deals. So, I was introduced to the program of action – working the 12 steps in my daily life. As a result, changes started to take place with my acting, thinking, attitudes and perceptions from where they were before.

The working of the program gave me new insights on life and its daily issues that were in my immediate sphere and in general life around me. How I dealt with these people, places, and things had to be rearranged and eventually changed. The application of spiritual principles in my daily life brought about changes in my actions, my thinking, my attitude, and my perceptions. The old stuff was gradually being smashed. Hell, I really was unaware of this happening. It was the gradual or educational variety that is spoke of by old timers.

Here, I began to understand that as an AA member, I owed certain responsibilities to AA as a whole. I could speak out as an individual on any matter with which I was concerned; but as an AA member, I had to operate within certain limits, try to "engage the mind before opening the mouth." I learned that I should not back away from my individual responsibility to act as we believe upon the issues of our time, yet self-righteousness should not cause us to enforce our will on others.

It was suggested that I should not speak out as a representative of AA but that I should talk for myself on my concerns in my life and in the world around me. I am not a spokesperson for the fellowship. In the past we saw what can happen to a society of people, the Washingtonians, when they take on outside issues of the day. They went from helping drunks get sober to breaking up for taking sides in political issues in the 1860's.

So, dealing with outside issues could be harmful to the AA fellowship for its purpose to help suffering alcoholics. When I get into other people's lives and issues, I realize that those are outside issues within my life. I do not need to get into other people's issues and chaos. I do not need to drag my group into other group's issues and how they deal with them. I need to deal with my stuff and my group needs to deal with their issues.

My personal experience with outside issues in AA has been limited. I have seen the issue of court papers being signed from the State of Maryland in our fellowship and we stayed out of the issue publicly. AA groups and members dealt with the issue on a group autonomous and on an individual basis. Then, the issues of the AA circle and triangle trademark lapsing and the original copy of the Big Book manuscript not being given to AA as willed from Lois Wilson to Barry?, but sold in auctions. The issues were looked into but it was decided not to pursue them because it would take public forums for dealing with them and the fellowship decided to follow the traditions and back away from them.

By avoiding opinions on outside issues such as politics, alcohol reform or religion, AA avoids controversy. I need to live by this principle as an AA member. This helps my life be much simpler and serene during the day.


