III. Approval of January 2006 Area Committee Minutes – Emily McF

IV. Treasurer's Report – Barbara C

For our first quarter, it might be interesting to look at this treasurer's report not so much to look at how much money we have in the bank, but how much money we have budgeted for this year. On the second page you find that same number under the total for "BUDGET". That's what we estimate we'll spend this year. This is a tighter budget than past years, so it will be interesting to watch what happens. Always keep your eye on how much we're receiving and spending.

About half of the income listed is available for our daily operating expenses because we hold back prudent reserve and for the SETA Convention. Page 2 gives the details on income and expenses. Groups are doing well in contributions. Last year 240 groups contributed to SETA. Under "Conferences, other" we've received contributions from District 90's convention and from The Spirit of Houston. The quarterly coffee expense is \$0 since we met at the convention last quarter. Hopefully we can break even on this expense this quarter. The last three pages of the report show the groups who've contributed to SETA.

Please take back to your group the "Self Support" pamphlets provided. Take some home to your group.

V. Delegate's Report – Charles P

l've brought Conference Reports and contribution envelopes – birthday envelopes and contribution envelopes for GSO. Some DCMs have written to GSO requesting these envelopes. If anyone needs these, please contact me first. I usually have a supply.

Last night we had a DCM sharing session, with 14 DCMs attending. It's something we're trying. Saturday morning was always too tight a schedule. By the time we'd really get into discussions, it would be time to close. Those who attended gave positive feedback about that meeting time. We had a lively discussion about the Gratitude Dinner; we got a lot of work done, and it went well. If you have any suggestions for agenda items for the next session, just e-mail them to me. These would be letters sent out quarterly or semi-annually giving a report on what the group has contributed. That proposal was sent to the Finance Committee.

David H will be presenting the 2007 budget Sunday. Debi has requested a motion be put on the agenda to have the Registrar provide mailing labels to the SCAP Committee for use in mailing out the State Convention flyers. We do not provide the database, but we have provided the labels. A GSR from a group in District 90, T. W., has made a motion that the Gratitude Dinner be fully self supporting, which will be on the agenda Sunday.

During the last quarter, there have been some problems with the ALLSETA e-mail. The website was in the process of being moved from one server to another. In the process, they changed the way the software handled e-mail. With this change, we're now able to have

addresses so the address could come to each individual address instead of having to go to the SETA website. Betsy has asked Penny, Webmaster, to put the e-mail addresses back in that were there four years ago. When this is completed, you should be able to use those email addresses so we can have anonymous e-mail that can pass from one elected person to the next one. If you would like to have an anonymous e-mail set up, get with Penny or Marshall. who can help you do this. There was some discussion on whether the e-mails would be anonymous in receiving and sending, This will be discussed further at the next assembly.
