**Workshop Reports**

***Advanced GSR Workshop***

There were 24 attendees. Some of the topics discussed were: welcoming newcomers, group inventories, anniversary get-togethers, group contributions, the pie charts, and informed group conferences. Tom K gave a presentation on the Grapevine.

**Literature Committee Workshop – Facilitator Ron C**

The Literature Committee put on a scavenger hunt to have the attendees learn about information in the various pieces of literature AA provides.

**Budget Committee Workshop – Facilitator David H**

David presented and reviewed the proposed 2007 budget. Emphasis was placed on the fact that the groups have done better with contributions. He noted that what is expected to be received and what is expected to be spent ends up to be a balanced budget. There was a lively discussion involving a CFC line item entitled "CFC Convention Advance." The discussion ended with an explanation of the history of that line item and how it came about. There was also discussion on the rooms being paid for by the Assembly at the January convention for the Area officers.

**Policies and Procedures Changes Workshop – Facilitator Patrick C**

There was a good discussion on the changes to the Policies and Procedures Manual. Some of the terminology seemed a bit confusing to the Assembly. There were some questions on the advisors for the State SETA Convention and the timeframe for the number of advisors needed. Some discussion was on any excess funds over the cap. One question concerned excess AI-Anon funds. It was well attended, with a lot of good information coming from it.

**Job Description Workshop – Facilitator Marvin W**

The workshop was a review of all the positions in the Southeast Texas Area Assembly, including DCMs. A job description for each position is posted on the website. If anyone is interested in standing for a position at the October elections, go investigate that position.
