Workshop Reports

New GSR Workshop Leader: Debi U. Recorder: Robert W.

Debi U. from Bryan opened the meeting at 9:30 with the Serenity Prayer. Twenty five people began the meeting by introducing themselves and the groups they represented. "The A.A. Group" and "G.S.R." pamphlets were made available to all those in attendance. The General Service Conference Structure was outlined as: A.A. Groups, Group GSR, District Committees, Area Assemblies, Delegates to the General Service Conference and General Service Board. The duties of a GSR are attend district meetings and area assemblies, serve as the mail contact with the General Service Office and listed in the A. A. directories as group contact, serve as mail contact with the district and area, supply the D.C.M. with updates to group information, knowledgeable about material from G.S.O., learn the Twelve Traditions and Twelve Concepts, serve on group steering committees, work with group treasurers, and participate in district and area service meetings. The G.S.R. is the A.A. Group's voice, which is then heard at the District level and onto the Area level. In order to be a "Guardian of the Traditions", use the "12 & 12" to become familiar with the Traditions. The G.S.R. is not an enforcer of the Traditions, however, tactfully makes members aware of Traditions through workshops, group business meetings, one on one discussion or Tradition meetings. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation. Closed meeting in A.A. are limited to persons having a desire to stop drinking. Open meetings are available to anyone in attendance. As with all group conscience matters, each A.A. member has one vote, and this, ideally, is voiced through the home group. Seventh Tradition money is described as: money collected from "passing the basket" to cover the following expenses: rent, conference-approved books, pamphlets and meeting lists, contributions to Intergroup, districts, area, and General Service Office. A.A. groups are to avoid affiliation with or endorsement of outside enterprises when naming an A.A. group. Typical service structure of an A.A. group is Chairperson, Secretary, Treasurer, Intergroup Representative, Literature Representative, Archives Representative, Grapevine Representative, Cooperation with the Professional Community/Public Information Representative, Treatment Facilities/Correctional Facilities Representative and General Service Representative. Rotation keeps A.A. members from becoming frozen in office.

The group conscience is the collective conscience of the group membership. Group inventories evaluate how well the group is fulfilling its primary purpose. The questions are listed on page 35 of "The A. A. Group" pamphlet. The D.C.M. is usually present when the collective answers to the questions are read. The meeting closed at 11:30am with The Lord's Prayer.

Advanced GSR Workshop

Faciliator: Mike D. Recorder: Beth L.

Mike opened with an explanation of the GSR, vote counting, the conscience of the Area. The following topics were discussed:

- 1. Communication with group by e-mail.
- 2. One meeting/month when to go over a tradition.
- 3. Bulletin Board of Events
- 4. Negativism in groups representing AA. The Voice of the group being heard.
- 5. Experience as a GSR helps with the ability to do things outside AA. Service work connects us to Alcoholics Anonymous.

- 6. What's next after GSR? The key is to be doing something so we don't get complacent.
- 7. The GSR is the lifeline to AA. The GSR is the filter through the District and the Area.

Spanish GSR Meeting Facilitator: Everado P.

The meeting began at 9:50 am with a moment of mediation followed by a reading of the Third Legacy of Service by Bill. W. The leader was Everardo P. The speakers of the meeting were Gustavo P. with the topic of chapter two "There Is a Solution" and Arturo with the topic of chapter seven "Working With Others." Questions followed. Information was given about the elections that would take place the next day. It was suggested that instead of the theme of recovery, we should talk about voting or service. The meeting ended at 10:45 am with the Responsibility Statement.

Policies and Procedures Changes Workshop

Facilitator: Patrick C Recorder: Emily M

Patrick provided background on the workshop held last quarter by him and David H on changing the guidelines for the convention in the Policies & Procedures manual. The current updated version has incorporated all the suggestions brought up during that workshop except for separating the Alanon funds. This was discussed, but the accounting involved would be too difficult, so that change was dropped.

Questions were asked about funding insufficient funds because of the timeframe of paying bills. David explained that these were directions for funds exceeding/lower than the SETA Convention fund. The final bill for the convention doesn't appear until after the convention is over and the rooms are calculated.

The total amount, including prudent reserve, was discussed. However, these are guidelines; they do not have the dollar amount specified.

Gratitude Dinner Proposal Workshop

Paul read and reviewed the printed report, including background of the event, discussion, and conclusions. The Committee recommendation was read. A discussion was held. Gene J reported that so far nine districts have contributed and expenses have been covered. Expenses so far.

Air Fare: 300 Cost of Facility: 500

He suggested, as per the Ad Hoc Committee, that the Assembly at some point make guidelines for the Gratitude Dinner for the future continuance of that event. Additional Considerations for the Area Committee were:

- 1) The Alternate Delegate continue to be the Area contact for the Gratitude Dinner.
- 2) Continue a rotating host district with all the districts supporting the event through food and supplies.
- 3) Reduce overall costs by using a local speaker and food to be potluck style.
- 4) Possibly hold the event in a public park or other inexpensive venue.
- 5) If there is a shortfall pass the basket a second time at the event.
- 6) Set a maximum limit on Gratitude Dinner fund monies.
- 7) Excess funds be passed to the next year's host district and/or contributed to GSO.

The committee has met monthly at the former Houston Council on Alcohol and Drugs since shortly after April, 2004. Attendance has varied greatly at the 4th Thurs. of the month meeting (except Nov.-Thanksgiving) at 6:30. It was evident by late summer (2004) that the "committee" (various members) were going to have to go to the District meetings and Service Committee meetings scattered all over the map and the calendar if we were going to talk to enough fresh faces to **RECRUIT**-that's what we did-WE DO NOT TAKE GRAPEVINE SUBSCRIPTION ORDERS as a SUPPORT team for the GROUPS who want to utilize the GRAPEVINE. Buying GRAPEVINE subscriptions for someone is not the same as teaching them how to buy their own.

However, we highly recommend the purchase of cases of 50 back-issues (\$36.00) as "sample" tokens of 1st meetings, birthday cards (with chip tucked in it), newcomers packets and a wide variety of awareness tactics, so that curious recipients can take advantage of subscription card or order by phone (by credit card) enclosed in every back issue since 2005.

Results: 900% increase in GRAPEVINE REPS-from 12 to over 110 and a 30% increase in the AREA's subscriptions-instead of another 10% decrease in the Area's subscriptions like the last 7 straight years.

There's more - we've gone from 1 GRAPEVINE format meeting (instead of the ever popular open discussion) to at least 14 GRAPEVINE format meetings scattered all over the AREA. Grapevine GvR's have become self-propelled by a **District** effort and there are now five Dist. Grapevine Chairs. Why hold Grapevine Dist. Meetings? – To share ideas, fellowship, education. Remember, we have nearly 600 groups-why aren't there almost 600 Grapevine Reps.? Do we sufficiently impress upon others to do likewise with others like Bill W. was doing in Dr. Silkworth's Hospital 6 months before Bill met Bob?

There was no candidate for Chairperson at the Area level - but, 5 districts have their respective chairs and they may rotate as they see fit as autonomous bodies serving their GROUPS! That's 5 times as many as we had 2 years ago!

We welcome all interested Grapevine and La Viña participants to join us in reviving AA's second oldest literature through which all our experiences, solutions, and guidelines have been discussed and adopted for the Common Welfare of our entire fellowship (informed or not, supporting or not, participating or not) to become the <a href="https://www.whole.com/whole.c
