### **Workshops Reports**

**New GSR Workshop** 

Leader: Tom B, Recorder: (edited from a detailed report by Donna R. recorder)

Chairperson opened with history of his service work in home group. There was reference material including pamphlets on HOME GROUP, SELF-SUPPORT, AA Traditions (and Concepts) and <u>AA Comes of Age</u>. GSRs might want a General Service Manual and the group will decide the sobriety requirement for the Rep (for 2 yr "job")

General Service Representative (GSR) is the "trusted servant" linking the Group to the rest of the fellowship of AA and as such has a responsibility to convey the Group's conscience (not his own) ultimately to the rest of the conference through District meetings and Area Assemblies such as the SETA (South East Texas Area-67). That "opinion" is discussed at Area Assemblies before being sent to the annual conference meeting at the GSO (general service conference in April every year) to confer with the rest of the participating groups of AA. After a weeklong conference, information is sent back to the Areas for sharing with the Groups (where it all starts) by their respective GSRs. The intent is to participate in carrying a substantially unanimous message back to all participating groups. Yours is the most vital link in the chain of what AA is doing as we grow, sometimes slowly, into the future for those yet to come and that SERVICE is the 3<sup>rd</sup> leg of the triangle.

There was a Q&A session following the presentation including questions and comments by over half of the attendees. The age-old topic of how to get others involved was discussed and various suggestions were made on how that might be accomplished (SPONSORSHIP?) One very important point is that the District Committee Member (DCM) has the responsibility to help the GSRs in his district. It was stressed that the more involved one is in the WHOLE program, the more likely he/she is to stay sober! The WHOLE program has been described for years as a 3-legged stool, each leg representing a third of the WHOLE program-STEPS, TRADITIONS, CONCEPTS. There were 23 attendees signed in.

Advanced GSR Workshop

Leader: Parth M Recorder: Joshua H

We had an enjoyable & spirited workshop with energetic participation. The old question of how to get alcoholics involved in the Service Structure was posed & a second question added which sparked a helpful dialogue. The question "How to get people with long-term sobriety involved in the Service Structure?" After a lively discussion on SPONSORSHIP in all 3 legacies of AA, Leadership in AA, Workshops, Home Group involvement in service committee commitments, Service as a topic in open discussion meetings and "AA's Legacy of Service" by Bill W, the summary of ideas is as follows:

- 1. Invite them along to District meetings and Area Assemblies.
- 2. Ask for their help in fulfilling commitments.
- 3. Hold Home Group based Traditions workshops and meetings-invite experienced members to facilitate.
- 4. Go to Service functions as a GROUP.
- 5. Introduce the type of service and people's experience, strength and hope in service involvement at regular AA meetings.
- 6. Use food as a method of attraction.
- 7. Remember to always attract rather than promote or threaten.
- 8. Freely show your gratitude & excitement for service structure work by making it exciting and interesting.

There was a discussion about presentations on (service) workshops at the District meetings.

Hotel Contract 2008/2009

Leader: Tandy B Recorder: Sarah D

Tandy began the workshop by commenting that 1) the committee had done a lot of work, the result of which would be reported and 2) these results might be viewed as indicating a need to do area business differently.

In all approximately 30 hotels, civic centers and such were approached of which only 6 were willing to respond in writing. Hotels can rent some space repeatedly for a few hours at a time, difficult to get long term proposals – some willing to consider 2008 and a few 2009. In reviewing costs, Tandy further remarked a potential tripling.

Discussions included remarks about addressing other options, the prospect of taking proposals back to groups, cost of breakfast rooms for standing committees and maybe changing when and how they meet and need for further clarification from the area about options – what are the guidelines; and, a suggestion about forming another ad hoc committee to consider how the assembly could do business differently. Shortage of time is a factor.

**CPC/PI Workshop** 

Leader: Gary S. / Patrick C. Recorder: Bill B./ Reed A.

Jim McMann, CPC committee, gave the history of the CPC committee, which was formed in 1970-71 to better address the concerns of AA in getting the message out to the professional community, as opposed to the public at large. At that time the general public had a very favorable view of AA, but an unfavorable view of a typical AA member. The formation of the CPC committee was designed, in part to carry the AA message more effectively at the public level, including among professionals who were not alcoholics.

The professional community can be of aid to AA by making the still suffering alcoholic aware that help is available to him/her through AA by providing education, counseling and rehabilitative treatment. And the professional community can help us communicate to the still suffering alcoholic that AA works, for those who want help.

It is important for members of the professional community to try to understand exactly what AA is, and what it is not. Similarly, it is important for AA members to communicate AA concepts, approaches and purpose clearly and effectively. In other words communication is the key – both for AA members and for the professional community – in reaching out to help the still-suffering alcoholic.

All members of the CPC committee are volunteers. The qualifications include a sufficient length of sobriety to discuss our recovery program with professionals – including the steps, traditions, and service. Also we want to give an accurate and positive impression of AA. Service on the CPC committee is not restricted to AA members trained as professional speakers, or to "elder" statesmen/women.

Members of the CPC committee inform professionals and those training to become professionals about AA: what we do, where we are, what we can do, and what we cannot do. The committee members

attempt to establish better communication between AAs and professionals, and to find simple, effective ways of cooperating without affiliating.

Cooperating with nonalcoholic professionals is an effective way to carry the message to the sick alcoholic. These professionals often meet the alcoholic in settings where AA is not present. Through these professionals, alcoholics may be reached who might otherwise never find the program, or some of these alcoholics may learn about the AA program sooner with the help of an informed professional.

How is this accomplished: enlisting AA volunteers for the following:

- Initiate contact with professionals through letters
- Presentations at the invitation of an outside organization
- Workshops for AA members and for professional friends
- Newsletters to inform local AA members of the committee's actions
- Exhibits at national, local, state or regional professional meetings.

CPC needs local sub-committees at each district. It is vitally important that the professionals in the community have a local contact in the AA program.

## Public Information Committee: (Patrick C, Mary Ann – co-chair, and Reed A – member of committee)

**Mary Ann** spoke of the need to have PI committees even at the local district level if possible. She gave a history of AA, and the origin of the PI Committee. The Public Information Committee was established in 1956 by the General Service Office.

She also spoke of District 90's PI Committee's recent projects, including a big book drive for the public library, high schools, and chemical plants in the district.

The PI Committee also responds to requests for workshops, and responds to any other requests offering an opportunity to dispense information or literature about AA.

The PI Committee has its own phone number at the area level, and attempts to answer any inquiries as quickly and accurately as possible. All of the districts in the area need additional volunteers to carry the message. However, you do need to take advantage of the training opportunities offered by the PI Committee before going out and representing AA at the public level by giving a presentation to an outside group.

**Patrick C** gave a summary of what the PI Committee does generally, as well as some of the activities the committee has been involved in since the beginning of the year.

Some of the information disseminated to the general public in the PI presentation may be the following::

- What services are available through AA
- How to reach AA
- What are the signs/symptoms of alcoholism

Public Information service is "12 stepping" according to a recent article in Box 459.

Patrick C advised that the PI committee cooperated with a request from Univision television station in Houston last month. Univision is doing a story on alcoholic abuse in the Spanish-speaking community. As part of the story, the television producers wanted to include a segment on AA, specifically a Spanish-speaking AA meeting. Patrick C worked with Paul M (past Area Delegate) and others to assist Univision in televising a mock AA meeting. Although AA members were being televised, none of their faces will be shown on television, in accordance with AA tradition of anonymity.

The PI Committee has also participated in numerous health fairs recently, including those sponsored by employers, Houston Community College and others. The PI Committee has also addressed a class of graduate students at Houston Baptist University about AA, and its efforts to combat alcoholism in the community.

**Reed A**, a member of the PI Committee, shared at the workshop about a presentation he participated in at Spring Branch High School in Houston. Reed shared that he enjoyed the experience of speaking to the students. He also said that he was careful to address the issue of alcoholism, rather than drug abuse, which many of the students are interested in hearing more about.

The PI Committee is also involved periodically in the preparation and/or dissemination of public service announcements on radio and television, or handling requests from local media in matters pertaining to AA, and alcohol abuse.

The PI Committee meets the first Saturday of the month, at 6 pm. The committee currently meets at St. Thomas University in Houston, pending completion of the parking garage at the Council on Alcohol and Drugs in Houston.

As a committee, we are at a junction now, however, where we are called upon to consider the possibility of further changes, possibly the location for the archives depository. Intergroup has been a good ally for well over a decade in offering a secure place for our collection but the kind of work ahead of us now necessitates freer access to the collection while offering the same level of security, if that can be arranged.

## Correctional Facilities Robert B, Chairperson

We at the CFC Committee hope this communication finds everyone reasonably Happy, Joyous and Free. Times continue to be busy for the committee, the meeting coordinators and the volunteers who give of themselves tirelessly. I'll update some notes from our last report first. At the Harris County Jail system, meetings for the 701 Baker street location have begun on Wednesday of each week. We originally reported that the meetings would be on Mondays but we must be flexible and we're glad they're up and running. We're still a little behind in the number of volunteers we need but there have been enough of us to hold 18 meetings to reach out to 722 inmates of which 10% have received Big Books. There have also been 14 new volunteers added to the list.

One of the facilities we need the most help at right now is the South East Texas ISF located on Preston road at Minute Maid Park. The single meeting has been split into two meetings of over 100 inmates in each meeting. Meetings are held on Saturday afternoon at 1:30pm. We sorely need volunteers to carry the message here. The possibility of adding more meetings for these men looks promising. Right now there are only two volunteers handling this awesome task.

Meetings continue at Plane State women's facility in Dayton and they could sure use some additional volunteers. Meetings are on Wednesday evenings.

Recently, the Fort Bend County meeting coordinator has asked for additional volunteers to carry the message to female inmates on that unit. A list of possible volunteers has been forwarded and hopes are that the tide will be smoothed for a while.

In these facilities and many others another 2000 pieces of literature has been distributed. This would include 740 Big Books, 16 of which were Spanish, and 116 12 and 12s including Spanish versions. Again, in most facilities the message was passed from one alcoholic to another.

If there's any way in which we can be of service to your District or group in the way of workshops, presentations or general awareness of the CFC leg of service please invite us and we'll put together a team and visit your location

CFC activities are on the move. The Byrd Unit had its anniversary in March. The Holliday Unit will celebrate its Fellowship on April 22<sup>nd</sup> and District 31 will be having a CFC workshop in June at the 1502 group in Conroe. District 52 is planning a CFC workshop for sometime this year as well. Our annual SETA CFC Conference is scheduled for September 7<sup>th</sup> –9<sup>th</sup>. This year we will be at the Crown Plaza on the South West Freeway. We also want to extend our warmest gratitude to District 33 for inviting us to their Unity Conference. The fellowship was outstanding, the sharing fulfilling and the chili....well...plentiful. Thanks so much.

Our Correspondence committee has been helping others find avenues to carry our message. They added 14 volunteers in January and another 7 in February. Most encouraging is the number of incarcerated alcoholics who are corresponding regularly. It proves we can commence our common journey, shoulder to shoulder, regardless of what type of barriers separate us.

Starting with this month's assembly, the CFC Committee will be doing mini workshops at the 4:30pm committee meeting on Saturday. This assembly our Literature chair will cover a couple pieces of literature and discuss the CFC literature order form.

We also want to graciously thank all the groups who support the CFC through the Seventh Tradition; time, talent and a little money. It's <u>only</u> through your efforts that our message reaches those who can't reach us.

It's been a busy 1<sup>st</sup> quarter. If you feel that there's something missing in your life this just might be the time to get into service. It's likely to fill any hole you have in your life. No matter where you live, we have a meeting where you can be of service by carrying the message to those who don't have the same opportunities we enjoy. It's fun, it's needed, it's fulfilling, it's.....the twelfth step! Come be a part of.

WOW! I don't believe I could have got that out in two minutes so we're grateful for our Newsletter Committee for helping the CFC Committee carry the message of Service and Unity in an effort to do our Twelfth step work.

Greetings to all. Thank you for the opportunity to serve in this position. I attended the Board Meeting on March 15, 2007. I am always impressed by the level of dedication and willingness to serve that I have

seen in the members of the Intergroup Board. This is a summary of the discussions held at the meeting. If you need further information, I'm sure any of the Board Members would be happy to provide it. It was noted that the website has been quite successful and receives 1200-1500 hits a day. In the future, a link will be provided on the website to correct inaccurate meeting information.

The numbers and types of phone calls made to Intergroup are counted on a monthly basis. There was discussion, pro and con about the continuing of this practice. It was said to be time-consuming and noted that this information had not been used for any purpose so far. Others said that this information should be available to interested members and groups, as they do provide financial support. It was asked if the phone company could provide the information about numbers of calls and this will be investigated. The Intergroup Corrections Committee is trying to visit one group per week. They provide "White Cans" to groups for the purpose of purchasing literature for the inmates in prison. The committee has purchased back issues of Grapevines for distribution and literature in Spanish for the Spanish CFC Committee. I was unable to attend February's meeting due to an unavoidable work commitment, but here are some items of interest from the minutes:

1062 calls were received in January. Halfway Houses and Detox Centers will be added to the Website. The Correctional Facilities Chair is involved in coordinating new volunteers. A committee was formed to review the pricing of bookstore items. They made the conclusion that most of the pricing margins were "proper and reasonable as related to World Service Catalogue pricing and other experimental pricing criteria" but some areas and items needed attention. Some prices were increased slightly, and recommendations were made and approved to purchase some items in higher volumes to take advantage of discounts. The Committee will again review this subject in 6 mos. A Committee was formed to investigate opportunities to cooperate and participate in the 2010 International Convention in San Antonio.

The next meeting will be on April 19, 2007, with the Board meeting at 7 pm and the Delegates meeting follows at 8 pm.
