- III. Registrar Peggy M. Report: The Group Information Forms for updating were sent to DCMs about a month ago; the deadline is today. She's received information from (6) districts. She noted

that this is for the National Directory. She'll do as much as she can by the end of April. Main interest is in the Groups listed as Unknown.

These are active Groups but we have no information so we aren't communicating with them at all. (104) Groups are listed as UKN, (unknown), which is about 20% of groups in the Area.

  Correction of error of \$.01 from the End of Year Report;
  - 2012 SETA Convention returns: Committee did an excellent job: unrestricted funds have skyrocketed to \$24K;
  - The Archives Repository is in the final 1.5 years of funding;
  - Group Contributions are up; expenses are down;
  - Reminder that we are tax exempt; forms are available.

#### Treasurer's Report: no questions from the Area Committee. VI. Delegate Comments- Deborah D, Panel 61

We had a great DCM/Delegate Sharing Session; we talked about visitations in the Districts, Area and the Groups. We had an increase of Groups contributing from our Area to G.S.O. of 44% to 48% over

the 4th Quarter of last year, which is good. My question is what's going on with the other 52%? Madame Chair, the DCMs & Delegate would like to request that we have workshop on how to increase participation through sponsorship & enthusiasm. When I think about

the 2000 meetings per week around Houston, I'm really thinking, our Assembly weekend could be full.

Next, I'm passing around a list for current contact information as I want to keep everyone informed. I have my calendar with me to help plan visits; I've been invited to many Districts, but not to so many Committee meetings. I appreciate invitations to your Groups, District and Committee meetings.

Round Tables – I am very excited to have you talk about the GSC Agenda Items. There's (10) English groups & (4) Spanish groups.

I'd rather have more groups with fewer people so your voice can be heard.

Grapevine made a profit of \$22,800 profit. The budget was for a deficit of \$100K and it made \$22,800. It has 90K subscribers.

La Viná - the budget was for a deficit of \$115K - it was half that at \$69K. La Viná has 8,000 subscribers - Texas is second with 1100 while California is 1st with 2400 & NYC is a distant 3rd place.

When I get to the GSC, I'm going to the floor microphone and ask the other delegates, what happened to the other 90 Areas with their La Viná support. We had a great session with La Viná committee & its members. Over 30 people showed up to talk about the La Viná & what I kept hearing was it's about principles, not personalities and it touched me when one of the members said "we may not speak Spanish, but that doesn't mean we can't support a service material like La Viná." So one of my challenges to you is even if you don't have Spanish-speaking people in your meetings, talk about it & support it, because we all know Hispanics who may need to be in these rooms one day. So that's my challenge: it's about principles not personalities and when I get to GSC, I'm going to tell them that my Area is doing its part – what about yours? Thank you for allowing me to serve.

#### VII. Alt Delegate Comments- Patrick C, Panel 61

Patrick said that District 20 is hosting the 2012 Gratitude Dinner with District 70 as co-host and they had their first meeting. It'll be held at a great place. Committee meetings are on the 4<sup>th</sup> Saturday at10AM; get with Patrick for details.

Patrick said there was a language barrier at last year's Dinner that went beyond translating Speakers' stories, so they will have bilingual greeters and food servers at this year's event.

## XIV. New Business

Ad-Hoc Committee on Spanish Interpreter – Report: Paul M. ZBM presented the report as Paul was leading the GSR Workshop. She said that after the motion to hire a translator was approved at the October Assembly, she appointed an Ad-Hoc Committee to determine how we do it, who's responsible & if there's anything we Page 5 of 37 July 2012 SETA 67 Assembly need to look at.

Members of the Ad-Hoc Committee: Paul M, Chair; Eduardo P; Julio J; Ricardo D; Miguel O. It was noted that correct terminology is "Interpreter", not "translator", as Interpreters translate orally while Translators interpret written text.

The Committee checked with other Areas for their experience & learned that some budget as much as \$5K/year, that the going rate can run up to \$150/hour and sometimes (2) interpreters are required. It was noted that often volunteers can't be found because now they can be paid for the service.

It was determined that the Multi Lingual Committee would seek out & hire the interpreter(s). (See complete report on Page 21) Q&A

Ricardo C: What was the conscience of the Area when they voted on it at the prior Assembly?

ZBM: The intent was to get some procedures written & in place so in future there won't be questions about who's hiring.

Ricardo C: Who appointed this Committee?

ZBM: I appointed the Committee to work out some procedures. What I'm asking if the Area Committee feel that the Multi Lingual Committee should be the responsible party and is this recommendation worth forwarding to the Area Assembly?

Rocco M: Will those reports be available? ZBM: Yes, after lunch.

ZBM asked the Area Committee if they wanted to forward the report to the General Assembly and placed on the July Agenda. The vote was (25) in favor with none opposed.

Intergroup Liaisons Reimbursed for Assembly Hotel Costs – Lee G. As SETA Liaison for Houston Intergroup, I was surprised to learn that there's no budget to reimburse Intergroup Liaisons for Assembly hotel costs. It seems to be the only position that has a duty & a responsibility to show up and give a report but doesn't get a room night reimbursed. I'd like to have this issue brought up to the Finance Committee. I understand from previous members of the Finance Committee that this is an oversight and that it should have always been included.

ZBM asked that the request be put in writing so she could submit it to the Finance Committee.

## VIII. Treasurer Report - Ron C.

Ron noted that he was off by \$.01 on the End of Year closing figures and made the correction in this report.

Ron reported that income has been very good this quarter because the SETA Convention made over \$16K, bringing unrestricted funds

to \$24K. Other points Ron made in explaining the report are:

- Gratitude Dinner Funds are funds Area holds for the dinner and is currently at \$2600.00;
- The Convention Fund at the time of this report, Ron said he had to give an advance to the 2013 Convention so next quarter's report will reflect that;
- SCAP Fund- this is not Area's money but we hold it for SCAP;
- Funds set aside for the Spanish Interpreter- \$900 for the year;
- Archives Repository- was funded for (3) years; \$14K remaining.

## <u>Q& A</u>

Question: Betsy G asked why Area was holding SCAP funds. Answer: SCAP Committee voted to hold reserves in the Area account.

It came as a recommendation from the Finance Committee. Question: Betsy G asked why Area is holding Gratitude Dinner funds. Answer: Patrick C said that they didn't move the funds because the

Host District didn't want to hold it in their account. He said that he can talk to District 20 to see if they want to move funds this year. Betsy G: Annual Reminder- those are not Area funds. Host District

should turn the fund over to next year's Host District.

Treasurer's Report accepted as presented.

## IX. Delegate's Report: Deborah D - Panel 61

Good Morning and Greetings to Everyone,

It is great to be with you this weekend. I'm very happy to be here & would like to welcome everyone to the South East Texas Area 67 Assembly. I've been looking forward to this assembly for months.

Since this is my 2nd year serving as your delegate I now have some experience behind me.

Since the Convention in January, I have been visiting districts, new groups, a few committee meetings and attended district workshops. I've been reviewing background material for the final agenda items and hearing from you concerning the agenda items. Thank you for your input.

Before getting started I'd like to report on the agenda items that did and didn't make it to the conference that came from our Area. **CPC (Cooperation with the Professional Community) Committee** Consider adding the phrase "non-alcoholics may attend as observers" to the "Singleness of Purpose" statement in CPC literature. Final agenda item that we will be discussing today.

**La Viná** – include the purpose in the RLV workbook; will be included beginning in the next printing.

**Literature/Publications** - Pathfinder Group – request to publish Pass it on, AA Comes of Age, & Dr. Bob and the Good Old Timers be printed in soft cover.

This didn't make the 2012 Publication budget, but AA Comes of Age was a souvenir at 2010 International Convention and is still for sale.

**Grapevine** - Review the AA Grapevine editorial policy, to ensure it complements the AA Grapevine statement of purpose, and the AA tradition of singleness of purpose. This didn't make it on the agenda; we'll continue to pursue this agenda item through the Group, District and then the Area.

Later on this afternoon, we will all be on a journey to talk about Alcoholics Anonymous as a whole, discussing this year's agenda items for many of the committees. I've selected the topics that I feel will have the most interesting comments. I will take all of your inputs and thoughts with me to New York next week. I have some materials with me to lend to anyone who needs a reference. We'll break into 14 tables (10 English and 4 Spanish). Every table will have background information & suggested guidelines. My hope will be for you to get a sense of what it may be like to belong to a conference committee and experience the potential discussions.

**Finance Conference Committee** (which is the committee that I'm on) has 6 items: 2 of them are:

- Consider a suggestion that amount requested from each delegate area, as a conference fee, be increased. Last increase was in 2006 from \$800 to \$1200 which is approximately 26% of the direct costs.
- Review the current dollar limits on contributions received from individuals and as one-time bequests.

## Now I'd like to report on the happenings at the General Service Office (G.S.O.), Alcoholics Anonymous World Services, Inc. (A.A.W.S.) & Grapevine (GV)

The e-book Web site and the instructions for use on the app are now available in Spanish and French. An updated app for the iPhone was deployed in mid-February and final testing has been completed on the Android app. The iPad version will follow the Android version.

With the move of the Grapevine from the 10<sup>th</sup> Floor in the building to

smaller offices on the 12<sup>th</sup> Floor, GSO has begun handling on-site shipping, mailroom and sales functions. This reduces costs by just over \$74,000 per year.

The committee reviewed a report on the viability of using e-delivery, similar to current e-Newsletters, for *Daily Reflections*, and asked that the staff also explores resources for mass e-mail delivery being developed by the A.A. Grapevine.

The General Service Board (GSB) started their inventory process, looking at 23 questions. This will be ongoing.

The AAGV-AAWS are looking at what efficiencies & objectives can be accomplished by combining services and sharing resources, including reviewing Concept XI, while still maintaining editorial and corporate independence. This is a result of the action of last year's conference.

Area 67 percentage of groups contributing for the twelve months ended 12/31/2011: 2011 -- 48.84%, in 2010 -- 44.88%.

It is an honor & privilege to serve Area 67 and Alcoholics Anonymous.

## X. Alternate Delegate Comments - Patrick C

Good morning to everyone and welcome to all first-time attendees at the South East Texas Area Assembly. I hope you have a great first experience at an Area Assembly and that you watch listen and learn.

My own experience has taught me that with time, reading service materials, participating and asking experienced trusted servants a lot of questions, continues to be how I stay on the path of general service. My name is Patrick C. and I am grateful to be serving you as your Alternate Delegate, Panel 61, Area 67.

#### Make Amends:

I want to make amends to the Area Committee/Area Assembly for an inappropriate action I took at the last Area Business meeting in January. It has to do with the vote & discussion that was taking place in regards to a member wanting to stand for the open Area Standing Committee Grapevine Chairperson. I was wrong to go to the microphone, right after the willing member provided service credentials & share that I wanted to table the vote. I later learned that I asked to table the vote based on incorrect information.

I realized afterwards what I had done to circumvent this member's willingness to serve. I will continue to work on holding my tongue & not requesting an action unless I'm fully informed.

It has been great traveling with Deborah again this year and meeting,

working & serving with many of you since we last met in January at the SETA Convention. I have attended the following Area/Region events:

D- 33 Unity Conference, D-31's 1502 Group Anniversary, a D- 90 and D-40 Committee meeting, Workshop Discussion with D-63 members,

Southwest Region Delegates Assembly, the 2013 Budget Committee Meeting & the first 2012 Gratitude Dinner Committee meeting.

#### Gratitude Dinner Update:

District 20 is the host district for this year's gratitude dinner. District 70 is the co-host district. Thank you to the districts for stepping into these important roles to plan this year's dinner, held in November. Alisa O'L is the Chairperson of District 20's Gratitude Dinner Committee. The committee will meet the fourth Saturday of each month at 10 a.m.

Also regarding the Gratitude Dinner, this year's Committee is satisfied with how the funds were held at the Area level.

We need to line up a District willing to co-host the Gratitude Dinner for 2013 with District 70. I do not want this to fall off the radar for next year, so District Committee Members please take this request to co-host the 2013 Gratitude Dinner back to your groups. Any interested District should be ready to let me know by the July Assembly.

As promised, I want to provide an update on the financial picture for this year's dinner. The Annual Gratitude Dinner is funded by voluntary contributions of AA members in Area 67. Contributions can be made throughout the year. Simply send contributions to the Area Treasurer, being sure to include a note stating that the contribution is for the Area Gratitude Dinner fund.

I'm happy to report that we're currently in great fiscal shape for this year's dinner. AA members, groups & districts contributed a total of \$2,581.00 last year. The result of these 7<sup>th</sup> Tradition contributions is that we have a balance of \$2,657.79 to fund this year's gratitude dinner. As a comparison, we started last year with a balance of \$1,722.35.

We received good feedback from participants on how to improve in some areas, like translation, and some are now members on this year's committee. DCMs will be working on getting their district commitment information to Alisa O'L. Site selection is underway; I will have more to report on that at the next Area Assembly in July, 2012.

## SWRAASA 2012:

The event is being hosted by Area 46, New Mexico, in Albuquerque at the Marriott Uptown, October 19-21, 2012. How many of you here this weekend have been to a SWRAASA? These are great events that are hosted on a rotating basis by the Areas within the SW Region. The last event in Colorado was a completely bi- lingual event; I know New Mexico is working to make this one as well.

In an effort to gain more participation from our Spanish members, Area 46 has created invitations to the event, in Spanish, for MCDs to take to Groups & pass out to each Spanish group in Area 67. I've given some of these to each MCD.

I have a few of these neat "save the date" bookmarks to pass out, but only have a limited number, so first come first receive. This is a great way for English groups to get their members interested in attending.

This service weekend is made up of many workshops that have a short presentation by facilitators & plenty of time for the workshop attendees to share their experience, strength & hope and answer questions.

Every Alternate Delegate in our region selected three workshop topics that each is responsible for asking someone to lead or co-lead at this year's SWRAASA. Also, each Delegate topic was selected by the Alt. Delegate. Deborah has hers, so come hear her presentation with each of the other Panel 61 and Panel 62 Delegates from our region.

## (Committee Report on Page 21)

The initial question asked after the report was given was whether we had voted last October to hire a translator. The answer to that is YES - the purpose of this committee was to determine protocol and arrive at a policy, to be added to the Area Policy & Procedures Manual. Many fine details weren't covered in the Motion which was made, voted on & passed last October. such as who would be in charge of hiring the translator.

The following question was why Blanca, the translator, was not present at this Assembly. ZBM asked Paul M to speak at this point; Paul said he had spoken to Blanca by phone on Friday, which is when she first indicated she wasn't going to be here, saying she thought it was last weekend & she had a sick family member.

Katherine M said that she first learned that she wouldn't be here on Friday; that her mother was going back to Mexico. Katherine said she understood that Blanca would like to do it and <u>will</u> do it for \$300/assembly & she's confused as to what happened.

Paul M said she'd been recommended by the Spanish community, Page 17 of 37 July 2012 SETA 67 Assembly she had sent her resume; she was a translator and an AA member.

When he spoke to her on Friday to find out what the problem was, she said that she was ill. He said that they had emailed back & forth and he thought it was all set. He emphasized that he would never tell anyone not to come.

Miguel said he was confused as to why anyone got involved other than those who approved, asking if anyone had the ability to cancel her appearance. Others said that they felt this was a violation of the Second Tradition; that in the interest of Unity, the assembly should not proceed with the motion to hold the workshop, but proceed with what has already been decided. The DCM of District 64 requested that the motion be withdrawn & the matter be handled between the Treasurer and the Multi Lingual Committee.

ZBM outlined areas not covered in the motion passed in Oct-11:

- Who is responsible for hiring the translator;
- What are the qualifications/requirements necessary, other than they be an AA member;
- Procedures for payment;
- Any other issues not addressed in original motion.

ZBM said that she too, was considering those yet to come, in this attempt to develop the protocol for this completely new situation, to have a policy in place for the future.

Paul M spoke again, saying that he had sent Blanca copies of the Service Manual, the Policy & Procedures Manual, and a list of common terms, all in Spanish. He sent all this to her, expecting her to be here.

After more discussion, ZBM stated that there will be no workshop on the findings of the Ad Hoc Committee; that Blanca will be here in July; and that this will be handled between her, those who came before me and the Spanish Districts. ZBM also stated that she will assume responsibility to see that a translator is present in July.

New GSR Workshop - Facilitator: Paul M Recorder: Evelyn C.

Opened meeting with Serenity Prayer. A total of (21) attended.

The first half of the meeting was the Power Point Presentation for new GSRs, covering all major points of "How to" & "What do I need to know". The new GSRs were told that GSO would be sending all a "New GSR Packet".

The second half dealt with questions and comments such as:

<u>Housekeeping</u>: "Group Change Forms" to inform all entities of the Group's new GSR. It was suggested that the form be sent to Area, GSO and District, unless otherwise instructed.

Current Events: The DCM is usually the best source of information.

Also AA-SETA.org and AA.org are both a wealth of information.

<u>Opportunities</u>: Joining a SETA Committee, like PI, CFC, etc. for fun, fellowship & more learning. Service Sponsors were suggested.

<u>Problems</u>: Biggest was lack of Group interest; suggested solutions were 1-2 bullet announcements per week or month; say what you'll do, before you're elected. The meeting adjourned in the usual manner.

#### Advanced GSR Workshop

Facilitator: Jes K Recorder: Cheryl B

Jes opened the meeting by stating that the purpose of the meeting was to provide an opportunity for GSR's to discuss group issues or concerns & ask questions. Jes provided the 12 Traditions Checklist and encouraged GSRs to use the checklist as part a checks & balance process to determine if their

groups are following the Traditions. The topic for discussion was Tradition 7.

Jes specifically asked the GSRs to share how their groups split the money collected, in order to carry the message.

In general the discussion helped to define the difference between AA groups & clubs. Many of the attendees' groups met in AA clubs, so they were able to share experience on how contributions were split between the two.

Many GSRs stated they contributed money to the club so the facility was able to maintain operations as well as provide amenities to group members. Many groups are giving significant portions of 7<sup>th</sup> Tradition collections to the club, but are also able to keep money to contribute to the various AA service entities like District, Area, Intergroup and GSO.

The major takeaways from today's meeting were:

\*\*AA clubs are separate entities which are allowed to manage their finances & accept donations from outside entities. They don't have to follow AA Traditions.

\*\*AA groups can only accept funds from AA members. The group should be selfsupporting & be able to decide how the money is spent. (the club should not govern the group's conscience).

\*\*Encouraged the GSRs to remind their groups' members that the cost of

carrying the message keeps increasing but the group donations don't provide adequate support. One member stated that her group has meetings on the Traditions occasionally, especially on Tradition 7, to explain where the money goes.

The meeting closed with the Responsibility Statement.

#### RSG Workshop – No Report Submitted

#### Ad Hoc Committee Reports

#### I. Hiring an Interpreter – Chair: Paul M

Other members of the committee were Ricardo D, Everado P, Julio J, and Miguel O.

The committee was charged with forming some guidelines as to who would be responsible for hiring an interpreter, how that process would work, what requirements the interpreter might need, and to address any other procedures not considered in the motion.

Motion passed at October 2011 Area Assembly:

- Professional translator to provide oral translation & written summary;
- Maximum \$300.00 per weekend. (\$50/hour) \$1200/year 4 Assemblies;
- Translation to begin in April 2012 (if budget permits) or Jan 2013 (as budgeted);
- Area Treasurer to pay translator directly.
- Translator is a member of A.A.

After research and discussion with professional Interpreting companies, GSO and numerous Areas throughout the US, we discovered the following:

The going rate per Interpreter runs up to \$150/hr. Some companies want a commitment for two Interpreters because of the workload. We discussed the cost, time commitment and payment details with several other Areas. Some Areas budget up to \$5,000/ year. All used two interpreters. Most used professional interpreters who were members of AA & the cost was at a reduced rate, in the \$70/hr. range per interpreter. All were being paid as

independent contractors; no 1099 forms were being filed & no contracts signed. None had written guidelines. In most Areas, the area chairperson did the hiring. All sent agendas to the interpreter in advance, with items marked, denoting where an interpreter was needed. Also lists of commonly used acronyms, terms and definitions were supplied in advance.

After discussion, this ad-hoc committee recommends that the following procedures be put into place:

- 1) The responsible entity for hiring the interpreter be the Multi-Lingual Committee;
- 2) That the responsibilities be added to the Multi-Lingual Job Description;
- Procedure for payment to the Treasurer be added to that position's Job Description & include that a written invoice be submitted;
  - 4) The expense to not be a part of the Multi-Lingual budget.

In addition. we found that it's important for the interpreter to have varied experiences in the professional field and be familiar or be willing to become familiar with Area Service language.

Finally some of the challenges we could encounter that were not addressed before the motion was passed:

- Volunteers interpreters will <u>not</u> volunteer because they can get paid for the job;
- 2) Inability to procure a PAID professional volunteer (AA Member) will have an impact on the Area's expenses and budget.

This four member committee (Mark, Lucky, Alisa and Charity) took existing guidelines from other districts & used them as a template for our own. We appreciate all their hard work.


