I am so grateful for all of these experiences because when I suit up and show up, I find you there to greet and welcome me with a warm hug, a smile and a quiet strength that I treasure.

Area Committee Report – October 4, 2014

<u>The Importance of Communication about Rotation!</u> During my Panel 63 Delegate service term I have included the topic of the importance of communication as a portion of each of my quarterly delegate reports to the Area Committee and Area Assembly. You have heard me share about how critical it is for all of our service positions outlined in our general service structure to be filled by willing and committed trusted servants. Our service structure is only a theory on the pages of the A.A. Service Manual unless members make it come alive.

Today I want to put a different slant on this topic. Page S23 of our English Print service manual details "the principle of rotation". *(Patrick read the short paragraph).*

I encourage each of us who are rotating out of our current service roles on 12/31/2014 to spend a solid amount of time to "share our experience with the incoming person". Just as important as it is to share our experiences, the actions we took, the plans we made come to fruition (with our Higher Power's help), is the importance each of us places on making the personal decision regarding which row of chairs we are going to sit in as we rotate on.

As a Delegate, I have asked myself, am I going to allow the new delegate to bring their ideas to the service they commit too? Or am I going to be critical that the new Delegate is not doing it right, because it is not the way that "I" did it? I pray the chair I pick is on the elder statesperson's row! I am sure someone will tell me when I switch to bleeding deacon corner.

So, I encourage each of us to support the incoming trusted servants. To answer the telephone when they reach out with questions and to not get upset when the telephone stops ringing because God has filled the gap and given them the personal power they need to carry on the legacy of service.

I encourage each of us to let the new panel of trusted servants to have the freedom to serve and the support they deserve to try new ideas. Remember they are not acting alone. Our program has spiritual principles by which we live, work, and stay unified.

Area Assembly Report – October 5, 2014

Current 2014 Financial Highlights:

AAWS made a net profit of \$627,000 for the first six months of 2014; Grapevine made \$155,000. The Reserve Fund presently stands at \$14 million or 9.4 months of expenses.

<u>A.A.W.S Board General Price Adjustment on Literature</u>: I would like to share some updated information from the many communications I have received from our General Service Office over the summer months since our last Area Assembly.

The A.A.W.S. Board increased our literature prices as of October 1, 2014. Copies of the new prices are located on the Delegate's table and can be found on our website: <u>www.aa.org</u>. Some information about increasing literature prices:

- Policy to review literature prices every three years.
- Our last price increase was on July 1, 2009, five years ago.
- Price increase effective 10/1/14 for most book prices in the three languages of our Conference.
- Literature income helps to cover costs for services provided by G.S.O.
- As we strive to become more self-supporting, it is necessary for the Board to raise prices to maintain the level and quality of those services and the financial health and stability of the office.
- A.A.W.S. Board has decreased our shipping and handling charges at the same time the literature price adjustment goes into effect.

Action being taken:

- Policy and Admissions Progress continues on including electronic voting for nonelection votes on Thursday of the Conference in 2015.
- The Archives video shown at the Conference, Markings on the Journey, is available for distribution.
- There is a service piece being created on ways to engage more members in Corrections service.
- <u>www.aa.org</u> has been set up to receive recurring contributions if any member wants to give monthly.
- Finally, a study comparing costs to move GSO from our present space in New York to three different U.S. cities vs. staying at our present location was completed and shows that <u>such a move would not be prudent</u>. Consequently, the General Service Board has decided to keep GSO in its present location when its lease expires next year and begin the preliminary work on obtaining a new 10 year lease for our 11th Floor location and remodeling the Office with actual construction to begin after the 2015 International Convention. The present space is as it was when GSO moved there in 1992 except for installing new light fixtures. As part of any remodeling, the Board intends to locate all AA's activities, including the Grapevine, on a single floor.

Potential 65th GSC Agenda Items already submitted:

- The Trustee's committee on the General Service Conference agreed to forward to the Trustee's Public Information Committee a request that the Conference Advisory Action from the 61st General Service Conference regarding the "Policy on actors portraying A.A. members or potential A.A. members in videos produced by the General Service Board or its affiliates" be rescinded.
- The committee agreed to forward to the 2015 Conference Committee on Literature a request to develop literature directed to transgender and gender non-conforming alcoholics.
- The committee agreed to forward to the 2015 Conference Committee on Literature a request to produce a book combining Twelve Steps and Twelve Traditions with the Twelve Concepts for World Service.

Reminder about Area 67 request for a format change of existing A.A. service literature: Our 5 Spanish Linguistic districts requested to add a format, audio version, of an existing service piece of A.A. literature titled; "Twelve Concepts for World Service", catalog number BM-32. The publishing committee of the A.A.W.S. Board reviewed the request and it has been placed on the July 2014 Board Agenda for discussion. <u>UPDATE:</u> No movement by A.A.W.S. Board on the request to make Twelve Concepts available on CD – in any of the languages of our Conference. For now it remains on a list of potential projects (as yet unfunded).

Grapevine -

The Grapevine Committee was asked to attend The Traditions and Concepts on the Beach by District 81 that was held Sept. 19-21 at Galveston. Listening to the candor, comradery, personal experiences, and knowledge shared by David H., Past Delegate District 10, and Gary K., Past Southwest Regional Trustee, empowered all of us. Both men love Alcoholics Anonymous and dedicate their time and talent keeping us informed and focused about our past and future. The GV Committee held its world famous Grape Guessing Contest and *Language of the Heart* was awarded. A member from League City won. Her guess was 360 when the actual count was 366. Everyone has enjoyed playing this game and are always excited to receive the compilation of Bill W's Grapevine writings from 1944-1970.

The Grapevine display table has been at every Area Assembly for the past two years offering GV books, subscription forms, and free copies of our magazine for anyone to enjoy. The new book, *Sober & Out*, plus the 2015 Calendar and pocket calendar were on display this month along with other popular books. All sales are immediately turned over to our Area Treasurer who provided receipts.

Groups, districts, areas, regions and GSO have been celebrating the Grapevine's 70th Anniversary all year and it's time to do it in Southeast Texas. Join us December 6th at Houston Intergroup from 1-5 pm. We will offer panel representation from CFC Intergroup outlining the "Adopt an Inmate" program that sends Grapevine and LaVina subscriptions to those incarcerated, staff from Houston Intergroup to discuss their cooperation with "our meeting in print", and GV Chair will give history and future of the Grapevine. We will have a skit from our Grape Nut Players and free raffles for literature prizes and subscriptions. Join the whoopie party serving old fashioned ice cream floats, whoopee pies, fresh fruit, coffee and water. From there we enter our second workshop with two GV Committee members describing the Writing Guidelines and Audio Recording Strategy. With information, topics, pen & paper in hand, we will break for a writing session. Another room is set aside to provide a quiet environment for recording your 7 minute audio submission. We suggest you write it first and bring it to the workshop where it will be uploaded to the Grapevine in your voice. Select a short topic rather than giving your story. Don't forget to take a picture of your home group and bring it to us where we will help you upload it to Grapevine. We hope to flood our International Journal of Alcoholics Anonymous with scripts, photos, and audio from Southeast Texas Area 67. Ya'll come out and enjoy the Fellowship and purpose of the Grapevine.

Brazos Valley Intergroup -

Brazos Valley Intergroup has been very busy during this quarter. We ordered several thousand dollars worth of inventory and ordered large orders for several groups in District 33. We also had a table set up to sell books and other items at a local convention. In the past 4 years we have sold \$200-\$300 at this convention. We sold nearly \$2000 worth of inventory this year. The BVIG continues to grow and serve more and more groups and individuals in our district.

At the district elections held in September, I stood for the Brazos Valley Intergroup Liason for the next two years with the understanding that I would need to be nominated and elected at the October Assembly. My goal is to visit each meeting in our district and better inform them about our district and area. I will also gather contact information of each group's GSR and alt. GSR. Districts Represented: There were 5 attendee's present at the Area PI committee meeting. District's 31, 33, 40, 51, and 90 were represented.

- Meeting was called to order at 4:37 pm.
- Open: Serenity prayer
- Introductions: Tom K. introduced himself as did the other members.
- Old Business:
 - Tom stated that the (PI) committee is the oldest service committee. It was established by the General Service Board (GSO) in 1956. He displayed the

Public Information Kit and reviewed several pieces of literature contained in the kit. Tom encouraged the representatives to but the \$18 kit for their groups.

- Harold, from District 33, read pg. 26 from the pamphlet "The A.A. Group" (P-16). Additionally, the F-2 (Free) pamphlet, "Information on Alcoholics Anonymous" was reviewed and encouraged as a great summary of what A.A. does and does not do.
- A new roster was passed out to obtain current contact information. An announcement was made that the representatives needed to attend the Area PI committee, which meets the last Saturday of the month at the Delta Club.
- Tom reviewed the Three "T"'s that are required to get anything done: time, tools, and talent. He added that team work is key and two people are more than 4 times more powerful than one.
- Tom passed out the literature catalog for 2014, however, the prices have been increased due to lower contributions and increased cost of production.
- District Reports:
- **District 31**, Kim G., Reported as the incoming PI Representative that she looked forward to the new role.
- **District 90**, Dean, PI/CPC Representative reported that their district has held 2 health fairs which were successful. The district has held two Recovery Rally's in the past, only in English. This year it was done in both English and in Spanish, however, it was not well attended. They plan to continue this bi-lingual effort going forward.
- District 40, Kate E., PI/CPC Representative reported that her district was reaching out to the local Emergency Room Clinics to hand out literature. She stated that her team had business size cards printed which state, "If you want to drink that is your problem, if you want to stop, we can help". They are reaching out to the administrators from the facilities to request permission to display some A.A. literature in English and in Spanish. The use of the card board AA pamphlet holders is how they intend to do this. They also are attending health fairs with a booth to pass out A.A. literature to the public in October and March. She explained to the group their involvement began through a talk at the Houston Council on Alcohol and Drugs. She also reported that her district has budgeted \$2,500 in support of the PI/CPC efforts. Historically, they have had Public Service Announcements during Christmas which costs apx. \$1600. Kate added, that she would like to be considered for the Area Public Information Chair Position.
- **District 33**, Harold, DCM, Reported they were challenged by the Spanish speaking community and needed a Spanish liaison. Tom encouraged him to attend Spanish speaking groups to get a liaison.
- **District 51,** Tom K., PI, Reported that the effort in his area was limited to one. He has been going to other district meetings to share PI information. He

encouraged all to do similar. He also reported that some Districts were using Billboards to get the message out as well as purchasing trailers at theaters.

- Open forum:
 - Kim G. requested additional information regarding her group having a booth in an upcoming health fair. The committee stated that was part of the PI efforts and reviewed the PI workbook and gave information to comply with the traditions.
