And in between all of that, I've read Conference background material, with a focus on my Conference Committee, which is Treatment/Special Needs – Accessibility. Round Tables Workshop

Many of you are familiar with the Agenda Items Summaries and the Response Forms that Patrick introduced during his term as Delegate. And the Response Forms made getting that information to the Delegate a little easier too.

I want to thank those of you who have responded to requests for feedback on specific Items as well as those who have submitted feedback from their Groups and Districts. I was excited each time I received an email with a response!

And today we'll practice the original method we've used in Area 67 to ensure that SETA delegates are informed: the Roundtable Workshop.

This year I have been working with delegates from Areas with large Spanish Communities, in an effort to have sections of the Background Material translated. I feel strongly about this because how can our Spanish members be informed without these translations.

Some delegates had commitments that weren't met because they had only one person who could, or would, translate and the job was too much for them.

After much cajoling and wheedling only to learn that another Area's committee couldn't commit, I received an email from California about a grassroots effort called the National Translation Project, or NTP. I'm happy to say that Area 67 participated, translating several sections of the material. And the Spanish Tables today will be working on Agenda Items with background material in Spanish. More will be revealed.

Self-Support: Area 67 Groups

As of December 31, 2014, Area 67 groups contributed \$74,800 to GSO. The number of groups in Area 67 was up from (550) to (563) active groups and we had an increase of 1.5% of groups contributing to GSO over December of 2013.

Publishing sales: Sales were substantially below estimates for the first month of 2015. In January, gross sales (including digital books) were \$1,116,216 vs. budgeted amount of \$1,255,254.

Reserve Fund Transfer: The A.A.W.S. Board approved recommendations brought by the Finance Committee that a transfer to the General Fund of the General Service Board of \$2,827,106 to cover 2014 General Fund deficits from operations, and \$132,026 to cover funding of La Viña; (Remember, the GSC voted and approved a 1991 advisory action, that the La Vina magazine is funded as a service to the fellowship.)

a transfer to the General Service Board Reserve Fund of \$1,200,000 representing excess Working Capital needs be approved; with the understanding that as funds may be needed for construction, they will be withdrawn from the Reserve Fund.

A.A. Grapevine: The A.A. Grapevine, along with La Vina has issued a 2015 Subscription Challenge. The Area that sells the most new subscriptions by December 20th will be featured in a 2016 Edition of either the Grapevine or La Viña, with a section highlighting the area's members' articles on recovery.

The Carry the Message project focuses on getting Grapevine and La Vina subscriptions to alcoholics in need, in one of two ways: 1) forward contact information from requests for subscriptions received by AAGV and 2) by encouraging members, groups and districts to forward subscription gift certificates to the area delegate for forwarding to the appropriate committee, such as Corrections, Treatment, CPC, etc.. More details will be coming.

Grapevine Finances: Grapevine finished 2014 with net income of \$325,828 against budgeted income of \$98,240; Gross profit for the magazine and subscription products reached \$1,529,063 (ahead of budget by \$147K; Gross profit on books and related items was \$509K; Overhead costs were budgeted at \$1,820,700 vs an actual of \$1,719,600, leaving a savings of \$101K, mainly in Website expenses and G&A expenses.

International Convention Update: There are currently more than 36,000 registrants. GSO is working on the Advance Program with information about the Convention and a tentative list of A.A. and Al-Anon meetings that will be sent to all registered attendees. Once available, the Advance Program will be posted on GSO's A.A. Web site.

1. Conventions

Final Report 2015 SETA Convention –David A. –

I would like to thank you for the opportunity and privilege to be part of the SETA Convention Committee. It has been such a wonderful experience for me to work together with all of you in unity to serve the alcoholic that still suffers. I have heard of so many complements on the convention and know that this could not have been possible without the help of our higher power working with and through us all. I have been so very fortunate to work with such a dedicated and talented committee. Thank you all so very much for your service.

Moody Gardens Hotel:

The 2015 SETA Convention final room count, excluding the parlors for the hospitality rooms, was 661 room nights. This represents a net increase of 105 room nights from our final room count in 2012 when the SETA Convention was last held at Moody Gardens. The final room count in 2012 was 556.

The hotel staff was very pleased with the room count and they gave us a \$1000 break in our favor and removed the charge for the ballroom. In addition, the hotel staff was very generous and allowed us to have the Expo A (rooms 1, 2 & 3) for the band and dance and did a splendid job to decorate the tables with flowers and candles at no extra charge. To reciprocate the generosity of the hotel and to provide refreshments to the membership, the committee voted to have a concession stand at the dance and hired 2 concession cashers for the night for an extra charge of \$250. The hotel grossed about \$1,100 from the soda and chip concession at the dance.

In addition the hotel also sent complementary refreshments and food to the workers at the registration table from time to time. The staff and hotel management was excellent to work with.

Finally, the Moody Gardens Hotel requested feedback on their service and facilities in a formal Group Rating Form. Based on all of the positive feedback that I received from our membership about the hotel, I have completed the form with a rating of Excellent.

Finance Summary:

The Final Income/ Expense report for the 53rd Annual SETA Convention is attached to this report. The Convention Committee had an excess of \$8,844.82. After returning the advance of \$3000.00, we will be have a net excess of \$5,844.82 to return to the SETA Assembly General Fund.

Recommendations for next convention:

Special Needs - One thing that I think we could have done better on is to do more for special needs. In retrospect we should have some special seating areas for the members with scooters, wheel chairs and the people with canes and the elderly who have a hard time getting around. I also believe that we should have special seating set aside for the speakers and the hosts and the registration committee. We did finally think to reserve space for the speakers and for the registration table on Saturday night but I we had done this ahead of time for Saturday and more for that ahead of time.

Workshop- In an effort to get the flyer out early for the April Assembly we did miss a detail. We did not have the Leadership workshop listed on the flyer. A SETA Announce bulletin was sent out just before the convention but it would have been better to have that detail in the program / flyer. I believe that we had decent attendance for the workshop; but it did start out sparsely attended but later the attendance for the workshop did pick up.

53rd Annual SETA Convention Convention Guidelines and Policy and Procedures Manual review is recommended:

1. Missing Information: A motion was approved at the July assembly in 2011 to make some changes to the Convention Guidelines to have the Convention Chair obtain the finance committees approval on the hotel contract and a budget. The motion also strengthened the wording on the final report to the assembly. It appears that there is some wording missing that had been previously approved in July of 2011.

•••Current wording: Submit a detailed final Convention Treasurer's Report to the April Quarterly Area Assembly following the completed Convention.

•••Should be changed to: The SETA Convention Chairperson is required to compile and submit a detailed final convention treasurer's report to the SETA Assembly in April following the convention to include the number of hotel rooms' booked and total registration numbers. Copies of the report are to be given to the SETA Finance Committee and the next year convention chairperson. I recommend that we take another look at the guideline and make sure we get the extra wording in it and make sure it is posted on the SETA Website under Convention folder before then next assembly.

2. Speaker's meals – I was somewhat confused on how to handle the speaker's meals. With some discussions with persons with past convention experiences we came up with some guidelines as to what is customary. However I never received any idea as to what was a proper amount. This all seems to be tribal knowledge as to what is customary. One of the speakers was very appreciative of us paying the meals and stated that there is always incidentals that he has to pay for when he travels to speak and that when conventions reimburse for meals that it is greatly appreciated. That being said, some speakers are frugal and others not as much. I would recommend that the committee should decide how much to compensate for the speakers and to give them a fixed stipend. Major corporations do not require receipts for meals under a certain amount. For example if we gave each speaker \$150 that would equate to \$15 for two breakfast meals and \$25 per meal; two lunch meals and two dinner meals. No one would be compelled to give receipts and then each would be treated fairly. Whatever the case there should be more of a speakers meal policy in the convention guidelines.

3. Area 67 Policy and Procedures Manual – It is not clear from the Policy and Procedures manual that the SETA Convention Chair is part of the Area Committee. Although it may be implied that the Convention Chair is the chair of an approved committee, when I was elected I was told that I was to have a vote only the year preceding the convention and that the assembly treasurer would cover the cost of my room only for that year. If this is the case it should be stated implicitly in the policy and procedures manual that this is the case. The convention chair is required to give reports for 2 years on Saturday and Sunday of each quarterly assembly.

Records

Finally a detailed records book has been compiled for the incoming Chairperson that contains the records, notes, documents, contracts, and minutes. This record book is available electronically in pdf file format for any elected Convention Chairs for future Conventions and to be archived in the SETA Archives.

2016 SETA Convention – Mary M. – She mentions that it is a privilege and an honor to be the SETA Convention Chair for 2016. She says that David has done a great job, and will be a hard act to follow. She thanks David for all his help, the emails, phone calls, and suggestions. District 33 is the host committee for 2016. We are holding are committee meetings on the 3rd Saturday of each month at 3:00 pm at the Brazos Club in Bryan Texas. The convention dates are January 15th-17th at Moody Gardens in Galveston Texas. The room rate is \$117.00 per night. Hospitality rooms are \$375.00 per night, and they come with a one bedroom suite. We are currently working on the speakers. We will be needing lots of volunteers, so if you would like to be involved, please let me know.

We already have guidelines that have been approved for email, they are online, and guidelines approved for the SETA website. Does anyone have any questions about the guidelines before we vote? There are no questions, so Marshall steps down, and Troy states that the proposal comes out of the committee, and has been seconded. **Troy states the motion:**

"Move that Area 67 adopt the content of Section 3¹ in it's entirety as recommended guidelines pertaining to the general management of SETA's information resources and SETA owned hardware and software:"

Troy asks for a show of hands of all those in favor, and all those opposed...**The motion passes unanimously.** Troy thanks the IT Committee for their very hard work.

Report from The GSC Agenda Item Roundtable Discussion – Melissa R.- She thanks everyone who participated in the Roundtable Workshop. She mentions that she added some questions in that had only to do with SETA. The questions were about, how do we get more participation in our service committees. She also added in some questions about anonymity at our International Convention. She goes on to thank the participants again, and thanks the past delegates for their input. She then turns the floor over to the Roundtable Workshop recorders who each give their reports to the assembly.

A Motion from The Floor Concerning Melissa R., Our Current Area 67, Panel 65 Delegate – Patrick C.- Patrick thanks the chair, and states:

"I would like to make a motion that the Southeast Texas Area 67 send our Delegate, Melissa R. to the 65th General Service Conference, fully informed but not instructed."

The motion is seconded, and the **motion passes unanimously** to a standing applause.

X. Announcements – Troy B. – Troy reads through the many upcoming service events, and activities coming up in SETA 67. He then states, and asks for any objections to forming an ad hoc committee on a review of the SETA Convention Guidelines. The recommendation comes from David A., the 2015 Convention Chair. (There are no objections from the floor,) Deborah D. takes the floor and thanks Miguel O., Chair of the Multilingual Committee for doing the translation for the April assembly. Troy gives the info that the GSR Workshop had 24 new GSRs, and the Advanced GSR Workshop had 20 participants.

XI. Close Assembly – Troy B. - The April 2015 SETA Assembly closes at 11:15am with the A.A. Responsibility Statement.

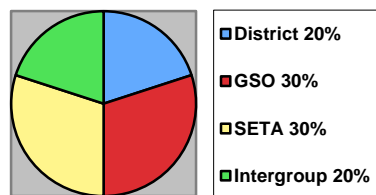
