**Area Committee Meeting**  
**Saturday October 3rd, 2015**

**I. Open – Troy B** – opened the meeting with at 8:37am with a moment of silence followed by the Serenity Prayer.

**II. Preamble – Kris H** – read the preamble to the SETA Policies and Procedures Manual

**III. Minutes – Jim K** – Jim presented the April 2015 minutes. Jim mentions that he sorry for not sending the minutes out electronically before today's meeting and also apologizes for the "google translate" version of the minutes in Spanish. Troy mentions that approval of the minutes must be delayed until everyone has a chance to read them.

**IV. Treasurer's Report – Dave P** – Dave mentions that we had a operating beginning balance of **\$79,729.29**. Deposits were made totaling \$34,123.89. Checks were written totaling \$41,971.97, giving a net change of -\$7,848.08. Leaving a total bank balance of **\$71,881.21**.

**V. Delegate's Report – Melissa R.--** Good morning to all the members of the South East Texas Area Committee/Area Assembly. My name is Melissa R. and I am serving as your Panel 65 Delegate, for Area 67. I want to offer a special welcome to new trusted servants. We're very happy you're here. I also want to thank our Alternate Delegate, Ron C, who's serving our Area and Alcoholics Anonymous as a whole, very well.

My main role is to inform you about what is going on in Alcoholics Anonymous as a whole and to be your voice; to express your ideas and experiences, and the collective group conscience of our Area at the General Service Conference. Here are a few highlights of the 3rd quarter of 2015.

Our Trustee/Delegate Telecom was held last Wednesday. Our trustee, Yolanda F told us that the main focus of the August Board Meeting was about determining who would be the new General Manager of GSO. According to Yolanda, it came down to (3) final candidates – each of whom would have been a. great choice. Greg Tobin, who has been the publishing director of AAWS since 2013, was chosen and he assumed the position on October 1st. He has a strong background in book publishing and prior to A.A.W.S., he served on the Grapevine Editorial Advisory Board, and as both Director and Chair on the Grapevine Corporate Board. If you haven't met Greg, he'll be at the SW Regional Forum.

Other than selecting the GM, little else was accomplished during the August Board Weekend –reports and decisions were all tabled until the October Board Meeting. However, a couple of items came up that Yolanda shared with us and that I would like to make you aware of. Discussion is going on among the Trustees Corrections Committee about the viability of a National Corrections Workshop, similar to the Archives Workshop, which also started from a Trustees Committee.

GSO believes that a lot of Corrections Committees work outside the "arena", without a connection to GSO; therefore GSO has the idea that Corrections Committees aren't working very well. Because it's so disconnected, GSO doesn't know how effective these committees actually are and so they want to hold a national workshop.

The idea is that the Trustees Committee would start the Workshop: provide tools; GSO would send a representative and provide their contact list – but the Areas would host it (on a "traveling" basis) and all Areas could participate.

This created a lot of discussion during our telecom, which produced three main points:

Correctional Facilities have such differing standards, rules and requirements, not only between states but between counties; therefore its questionable how effective sharing among (93) Areas can be;  
Question as to why only Corrections? Why not P.I.? Or CPC? Or all of the Committees? A note that this could create a kind of "super-committee" which gets very large and where rotation ceases to take place;  
There is already so much travel eating up Area funds, which could be used for local 12th Step work.

Yolanda agreed to take these points back to the Board for further discussion.

Yolanda also shared that the Trustees CPC/Treatment/Special Needs-Accessibilities Committee has decided to go forward with renaming a pamphlet – dropping “Special Needs” from the title. Later they will look at changing language in the pamphlet. These steps will be taken first; then later they will consider making the same change in the name of the committee.

General Service Conference Inventory Reports are still being reviewed; new estimated ship date is mid-November... And I had an idea I'd like your feedback on. Don Miller, who was the “architect” of the Inventory, will be attending the SETA Convention in January. Instead of telling his story, what do you think about asking him to speak on the results of the inventory?

The 2015 General Service Conference Final Reports are here! Your DCM will have copies by the end of the weekend. There's a very interesting report that shows a break-out of the unit quantity of books and other items sold; it's also broken out by language: English, Spanish and French.

Finally, I want to mention the 2016 Proposed Agenda Item on the Agenda Selection Process. I brought copies of the Background Material in English and Spanish. If you haven't had an opportunity to review it and you would like to, please take a copy, read it and then return it to the Delegate Table so that others can review it. Thank you.

**VI. Alternate Delegate's Report – Ron C—** Good Morning My Name is Ron C. and I am an Alcoholic. I also have the honor of serving as Alternate Delegate Panel 65 Area 67.

The past few months have been extremely busy as I have accompanied Melissa our Area Delegate as she has delivered the General Service Conference report out. I have become very proficient at setting up the screen and projector one-handed. By the time we had finished in the middle of August I had even run out of bad jokes. Melissa was very thankful. It is always a pleasure to visit the different Districts and see old friends and new family members. The amount of energy and dedication that I saw definitely speaks to Area 67 being the best Area to serve in.

The Grapevine/LaVina challenge is still going on. The State or Province that shows the largest increase in new subscription for Grapevine or LaVina in 2015 will have an issue of that magazine dedicated to that State or Province. Currently Texas has an increase of approximately 19% or 427 new subscriptions and approximately 34% or 562 new LaVina subscriptions in August. So let's keep up the good work. This information has been communicated to the Delegates in the various Areas where these members currently reside. The program is called “Carry the Message”. Our Area had 16 requests from 14 incarcerated members. All 16 requests have been filled thanks to the generosity of the DCMs of Area 67. If you, your Group or your District would like to buy additional gift subscription for other members and help carry the message of recovery, please let me or the Grapevine or the CFC chairpersons know.

**B. Convention Updates – 2016 SETA Convention – Teresa** - mentions that the 2016 Seta Convention has been meeting regularly, and they have some good speakers lined up. The editor of La Vina will be giving a workshop, and on Friday night there is a Spanish speaker from Mexico City. There is live entertainment at night and a ice cream social planned. The schedule will be on the website soon.

**C. Cooperation vs. Affiliation Proposal. – Troy B.** – Gives a brief history of the proposal, and mentions the proposal is available on the table in the room.. The vote on the proposal had been delayed until this assembly. He asks if there are any questions concerning the proposal, and if Gus H. would like to speak on it. There are no questions, and Gus defers on speaking. The proposal will be voted on tomorrow.

## **IX. New Business**

**A. Finance Committee Motion – SWRAASA Pool Motion** – Troy asks Gary to come up and speak on this motion coming out of the Finance Committee. Because the SWRAASA Pool was overlooked in preparing the SETA Budget for 2016, and because the category should have been funded when the budget was prepared, the Finance Committee recommends that, in addition to the Delegate, Alt. Delegate, and Area Chairperson (whom are already funded), we provide sufficient funds to pay for four additional current Area Officers, pr Committee Chairpersons, to attend the 2016 SWRAASA in an amount not to exceed \$2,400.00, which is \$600.00 per person. This motion is made in order to satisfy the motion previously approved on April 8, 2001, that the Area fund a pool of four persons (in addition to the Delegate, Alt, Delegate, and Area Chairperson) to attend SWRAASA in even numbered years.

Following a brief discussion, Troy thanks Gary, and mentions this motion will be voted on tomorrow.

**B. Troy asks the floor if there is any more new business from the floor?** Hearing no new business from the floor, the Alt. Chair is asked to come up for announcements.

**X. Announcements – Kris H.**—Kris mentions that he needs a district or two to volunteer to host the April 2016 Assembly. He mentions that D90 has been doing a great job on this Assembly. Kris mentions that hosting the assembly comes with the responsibility of gathering and storing all the SETA hospitality gear until April.

Gus H. asks Troy if he can read the motion for the ad hoc committee proposal on affiliation versus cooperation and Troy gives him permission. Gus reads the motion. Some discussion follows and a consensus vote is taken in favor of the motion. The motion will go in front of the assembly with the area committee's recommendation to vote in favor of the motion. The same procedure is followed to get "a sense of the committee" vote on the Assembly Weekend Scheduling Motion which is read by Patrick C.

**XI. Close – Troy B** – Troy closes the Area Committee meeting with the Responsibility Statement at 9:30am.

**I. Open – Troy B** – Opened the meeting at 9:45am with a moment of silence followed by the Serenity Prayer, then asks Art to come up and present Tradition 1.

**II. Tradition 1 – Art – GSR “The Orange Group” D90 & D52-** Art gives us a brief history of the Traditions and how we got them. He then reads the long form of Tradition #1. He then reads the short form of Tradition #1. He mentions that our whole A.A. program is securely founded upon the principle of humility, and that we each see ourselves how we are as members: A small part of a great whole. “We suggest, we don’t discipline.” Any matter or individual member deeply effecting the whole group is controlled by group conscious. “Our common welfare comes first.” “Without substantial unity there could be no A.A., and without A.A. there could be little life ia a program for anyone.”

**III. District Committee Member Reports**

**IV. Concepts Workshop Part 1.—Troy B.**—Troy mentions his excitement about this workshop that will be done using the “speed dating” workshop method. Troy explains the workshop will be split into two parts, covering half the concepts before lunch, and the other half after lunch. The assembly splits into 6 groups and the workshop takes place.

**V. Concept 1 – Diana S. – D90 & D52** –Diana gives a brief presentation about Concept 1. “The final responsibility and ultimate authority for A.A. world services should reside in the collective conscience of our whole fellowship.” She mentions our upside down triangle, and how the power is at the top of it. The Groups. Speaks about an informed group conscience. She asks the question: Does your group have a GSR? Does your group know what’s going on in Area 67, in A.A. world services? She continues with a brief history of how concept 1 began. She closes by saying, “The groups have the authority in A.A.”

**VI. Concepts Workshop Part 2 –Troy B.**—Troy gathers the 6 workshop leaders back together and Concepts 6-12 are discussed in this second part of the workshop.

**VII. Ad Hoc Committee Final Report on 3<sup>rd</sup> Legacy Voting—Deborah D.**—Deborah thanks the committee for serving all this year. She mentions that they met seven times. The members are Paul M., Kate E., Troy B., Ron K. and Cecil L. Deborah gives a brief history of this committee, and how it is a continuation of the original ad hoc committee that disbanded in 2014. The committee learned a lot from the previous one, and reformed as a result of

the Area 67 inventory. She says that there was a lot of different opinions about the subject, there was total agreement about how the area's voting procedure could be improved. She mentions that they recommend some changes in the policy and procedures manual so the changes they are putting forward are in the area 67 p&p book. She goes on to say that the committee recommends that their 5 motions are put on the agenda for voting tomorrow as "floor action". Deborah reads the 5 motions for voting written by the ad hoc committee:

- 1. The committee makes a motion to change the first three sentences of the first paragraph of the section on voting (Pg. 9) of the SETA Policy & Procedure Manual.**
- 2. The committee makes a motion to move all area business to Saturday, and only hold elections on Sunday Assembly.**
- 3. The committee makes a motion to change the fourth sentence of the first paragraph of the section on voting (Pg. 9) of the SETA Policy & Procedure Manual. In addition, this change will need to be made to section 2 of the voting procedures on the same (Pg. 9) of the manual.**
- 4. The committee makes a motion to begin using the electronic spreadsheet created by the IT Committee for the October 2016 election and to discontinue the use of the white board: this change will need to be made to section 2 of the voting procedures on the same (Pg. 9) of the manual.**
- 5. The committee makes the motion to encourage the Area Chair to have a 30 minute elections workshop in April 2017. The workshop will discuss the results of the survey conducted following the 2016 elections. If the Assembly is not satisfied with the timing of the 2016 elections, then a vote to rent the electronic voting system for the October 2018 Assembly would be proposed.**

Deborah then goes on to read all the specific changes the committee is recommending in the above motions. How the original sentences are written in the Area 67 P&P Manual, and the new wording the ad hoc committee is recommending in the motions.

The reading is followed by several questions from Zaz M., and Deborah answers the questions. Gus H. asks for some clarification on the motions, and Deborah explains. There is a question and answer session between Betsy G. and Deborah D. Deborah then gives some further explanation of motion #5. Deborah then asks the assembly for a show of hands if they would rather have motion #5 be a recommendation rather than a motion. Troy B. talks to Deborah away from the microphone, and she informs the assembly that the 5 motions above can't be voted on tomorrow as a "floor action". The 5 motions will have to be tabled until January 2016.

**VIII. Proposed Agenda Item for the 66th GSC—Melissa R.**—Our area delegate begins by mentioning that the proposed agenda item has been out on the table, and she hopes that everyone has had a chance to read it. She then goes on to read the proposal:

*"The General Service Board to develop an outline, framework, or a detailed plan for the submission, vetting and selection of proposed General Service Conference Agenda Items, which involves meaningful input and participation by Delegate members of the Conference throughout the process, and present this plan to the 2016 General Service Conference for review."*

Melissa thanks Gus H. for his help in providing background material and input on this proposal, and she thanks Area 10 for their help as well. She goes on to give a brief history of the agenda item process, and what brought about this agenda item proposal. She explains the process that agenda items have to go through to get on the GSC agenda. She explains that the area delegates, and therefore the groups, have been taken out of the selection process for agenda items for GSC, and that this goes against the original intent of the conference agenda item committee. She is asking for our Area 67 input on this matter.

**IX. Ad Hoc—Assembly Weekend Scheduling Final Report—Patrick C.**—Patrick thanks the committee members, and that they have only one proposal, and that proposal is a recommended change to the Area 67 Policy and Procedure Manual. He then recognizes the Ad Hoc Committee members: Betsy G., Michelle H., Corrie H., and Brad H.. Patrick also mentions the help of several trusted servants in the committee’s process. He thanks Deborah D. for being their recorder. They did outreach to the Spanish districts. He goes on to explain the process they used to sort through many ideas. The ideas were taken from various workshops, forms of format, concerns taken to the assembly, and the use of Saturday evening sessions. He goes on and gives a description of the ad hoc committee’s process, and their purpose. The best use of our time and service. Patrick tells use that the committee has recommended several changes to the Area 67 Chair, and he goes on gives a description of background, history, and reasons for their recommendations. He speaks about the importance of a Friday night session at the Assembly to help make the rest of the weekend more efficient, and that the Friday night session is the reason behind the motion their ad hoc committee has written and put forward.

GSRs, please get with your DCMs and check on your Group’s contribution report to see if it is correct. I’ve heard from some Groups that their checks have not been cashed. In some cases, the checks have gotten so outdated that new checks have had to be issued. I spoke to our Trustee about this and she said to call and continue to call if your Group’s contributions are not recorded on the GSO Contribution lists and/or if your checks are going uncashed.

For the six months ending June 30, 2015, AA Grapevine realized a net income of \$92,322, which is \$134,000 over budget. Expenses were less than budgeted

A donation of \$240,000 to the Reserve Fund was made in March and the cash balance as of June 30th is \$548,908.

**2016 SETA Convention – Francia C.** – She mentions that the SETA 2016 Convention Committee has been meeting regularly. They have a registration table set up outside this assembly room. "We take credit cards, fast and easy". She mentions that Moody Gardens in Galveston is a lot of fun. The SETA website has been updated, and you can pay with Paypal.

**2017 SETA Convention –Dana—**Gives a brief report on the progress of the 2017 SETA Convention Committee. She says they are going to start their meetings in February.

**3. Cooperation vs Affiliation –Troy—**He reads the proposal as submitted by the Ad Hoc Committee:

***"The proposed revision, that would be added to the Area Policies & Procedures Manual and monitored by the SETA Area Alternate Chairperson, reads as follows:***

1. Verbal announcements, flyers, or displays shall be allowed at all SETA Assemblies and Conventions if the events are sponsored by any one or more of the following entities:
  - a. SETA Assembly sponsored events, including, SETA Conventions and SETA service committees.
  - b. Events sponsored by SETA districts and/or groups.
  - c. General Service Structure of AA events sponsored by the General Service Board or General Service Office of Alcoholics Anonymous, including General Service Conferences, International Conventions, SWARAASA, Regional Forums, Special Forums, and other similar events.
  - d. Texas State Convention, including when held in cities outside of the SETA Area 67 Area; and
  - e. Intergroups/Central Offices events, such as workshops, sponsored by Intergroup/Central Offices and their service committees located within the boundaries of SETA Area 67.
2. If approved, this motion shall be added to the SETA Policies & Procedures Manual under the section titled AREA ASSEMBLY MEETINGS and monitored by the SETA Alternate Area Chairperson."

Troy mentions that this motion will require a 2/3rds majority for approval because the motion calls for a change in the Area 67 P&P Manual. So he asks each voter to count off their votes in favor of, or opposed to. Troy allows some more discussion at the microphone before the vote is taken. There is much discussion that follows both pro and con. Troy calls for those in favor of the motion to raise their hand. The vote is 56 for, and 8 opposed. Zaz M. stands to give a minority opinion, and Troy asks if anyone changed their vote based on the minority opinion. No one changed their vote, so Troy announces that the 2015 REVISED COOPERATION NOT AFFILIATION PROPOSAL has passed.

**4. Assembly Weekend Scheduling Final Report–Anna—**She says the area has been given a well detailed handout on the ideas that the ad hoc committee explored, and what could be accomplished. She reads from a fairly lengthy report on the recommendations of the ad hoc committee. The name of the document is "*Ad hoc Committee Final Report to SE TX Area 67, September 2, 2015.*"

**5. Third Legacy Voting Procedures–Zaz M.—**She mentions that Deborah D. chaired the committee. The other members were Kate E. D40, Cecil L. D90, Paul M. D81, Ron K. D90, and Troy B. D20. She mentions that 5 motions have been brought forward by the committee, but after discussion with the assembly yesterday, changes have been made. The issue of written notification of the motions to all the area's trusted servants came up. Written changes to the Policy & Procedures Manual must be done in writing to the area's trusted servants. The committee agrees to re-present the motions for voting to allow ample time to notify groups by mail. Overall the sense of the workshop was informative and supportive of the proposal. Troy takes the microphone and mentions that this proposal will be sent out (hopefully) with the January 2016 agendas for the January Assembly in Galveston. He mentions that if this business is not taken care of in January, that it will be brought forward in April 2016's SETA Assembly.

**6. SETA Convention Guidelines–David A.—**He mentions that he is the chairperson for this ad hoc committee. He mentions that the committee met yesterday. The committee did agree in principle on what actions need to be taken, but they have no motions to be brought forward today. He says that there are three issues they plan on going forward with.

He tells us that the committee is composed of himself, Marvin (past delegate), Betsy G. (past delegate), and Paul M. (past delegate). He mentions that they will recommend some changes in the SETA P&P Manual to reflect the ways that the convention committee is created and functions. He says that not all of the current convention guidelines have been implemented yet. They want to update the convention guidelines. He goes on to talk about having funds available for speaker hospitality.

## **X. New Business**

**1. Finance Committee –Motion—SWRAASA—Troy—**The motion coming out of the finance committee is read by Troy, ***"Because the SWRAASA Pool was overlooked in preparing the SETA Budget for 2016, and because this category should have been funded when the budget was prepared, the Finance Committee recommends that, in addition to the delegate, alt. delegate and Area Chairperson (who are already funded), we provide sufficient funds to pay for four additional current Area Officers or Committee Chairpersons, to attend the 2016 Southwest Regional Service Assembly in an amount not to exceed \$2,400.00, which is \$600.00 per person.***

***This motion is made in order to satisfy the motion previously approved on April 8, 2001, that the area fund a pool of four persons (in addition to the Delegate, Alt. Delegate, and Area Chairperson) to attend SWRAASA in even numbered years."***

There is a discussion at the microphone with Rick M. being opposed to this motion. Gary S. comes to the microphone to give an explanation that this motion is in support of an overlook by the Finance Committee. A friendly amendment has been suggested for the motion by Rick M. Troy brings up a point of order that once the motion has been turned over to the floor, it belongs to the floor, and must be tabled, or voted on. Gus H. speaks in favor of the motion. Troy brings the motion as written to a vote, He mentions it does not require a 2/3rds majority for approval. The motion is seconded and a show of hands is asked for. Troy asks if any are opposed? **The motion passes.**

**2. Assembly Weekend Ad Hoc Motion.—Troy—**He mentions that this motion was read earlier, and now he will read it again. Here is the motion to be voted on:

***"Presently, Section 1 of the section "AREA ASSEMBLY MEETINGS", which is found on page 6 of the Policies & Procedures Manual, reads as follows:***

**1. The Area Assembly shall meet quarterly in a two-day session.**

***The proposed revision adds the words "at a minimum" and reads as follows:***

**1. The Area Assembly shall meet quarterly. Each quarterly session of the Area Assembly shall meet for a minimum of at least two days."**

Troy opens the microphone for discussion on the motion. There is much discussion both pro and con, with an explanation of the motion by Patrick C. Gus H. shares his support in favor of the motion. Troy calls for the vote. Troy asks for those in favor to please stand. Those in favor count off...35 in favor of the motion. Troy asks for those opposed to stand. They count off...27 against the motion. **The motion does not pass.** Troy asks for a minority opinion. Brad H. steps to the microphone to share his minority opinion in favor of the motion. More trusted servants share their opinions in favor. Many share about how the motion allows for possibilities for more service to be done. Dave P. calls the question, and Troy asks if anyone has changed their vote based on the minority opinion. No one raises their hand...**The motion does not pass.**

**3. Open Positions—Troy**—Troy mentions that Melenie has stepped down as the TFC Chair and asks the Assembly if anyone would like to stand for the position. Pam steps up to the microphone and gives her qualifications for the position. Troy mentions Pam is willing, able, and qualified, and ask for a showing of hands for her to be TFC Chair. Troy then asks for a showing of hands of those opposed...**Pam is elected as TFC Chair unanimously.**

Francia C. steps up to the microphone to make an announcement: **Betsy G. is attending her 100<sup>th</sup> Assembly in a row. "She has not missed any!"** The room fills with applause!!

Troy mentions we are expecting at least 100 more...

**Xi. Announcements—Kris**—District 33 will be the Assembly host in April 2016. We will next meet in January 16-17 at Moody Gardens. The Literature Committee does their book giveaway.

**XII. Close Assembly – Troy-** - The July 2015 SETA Assembly closes at 11:45am with the A.A. Responsibility Statement.

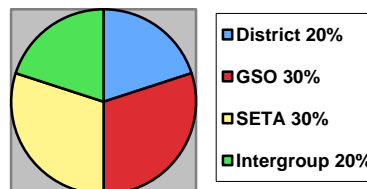

The 7th Tradition of Alcoholics Anonymous suggests "Every AA group ought to be fully self-supporting, declining outside contributions. "Self-support includes financial support of AA entities that support the group.
