I. Open – Kris H. (Alt. Chair) – opened the meeting at 8:45am with a moment of silence followed by the Serenity Prayer.

II. Delegate Report - Melissa R.-

My name is Melissa R. and I'm serving as the Panel 65 Delegate for Area 67. I want to welcome the new trusted servants – we're glad you're here. October Assembly's in election years are always exciting and I look forward to participating in the spiritual practice of the Third Legacy and rotation.

Ron and I continued to visit Districts and present the General Service Conference Report over the last three months. Again, I want to thank the DCMs, the Alternates and the District members for welcoming us, and making our visits special.

I want to take a moment to thank our Alternate Delegate, Ronald C. He has done a great job. He's gone just about everywhere that I've gone. We've split up to distribute Final Conference Reports in order to get them into the Fellowship's hands as quickly as possible. He's stood beside me at Delegates tables at so many events over the last (21) months. He has been all that I could ask for, as an Alternate Delegate. He has set a wonderful example of what a trusted servant should be.

2016 Final Conference Reports are here. DCMs should have their copies and I have some on the display tables. Please encourage your members to read the report. Keep in mind that these reports include last names so treat them as confidential materials.

General Updates

2016-2018 Service Manuals are now available. I ordered a few to distribute to our DCMs; they are available at our Intergroups or you can order from AAWS – discounted pricing for quantities. Keep in mind that this will be the last edition until 2019.

2018 General Service Conference was to be held in Rye brook, NY making Panel 67 the first panel in which the delegates would not get to experience the spiritual and exciting aspects of attending a conference held in New York City. The Trustees have appointed a hotel-search subcommittee to research alternate hotel sites in Manhattan.

Trustees Strategic Plan

The trustees have started implementing portions of the Strategic Plan (Serving the Fellowship) which was the Trustees portion of the Feasibility Study that we discussed in a Workshop at the April Assembly. A tentative timeline for the roll-out was discussed at the July Board Meeting. When that timeline has been finalized, I'll provide information on the actions and timeframe.

2019 Regional Forum

The Regional Forum will be held in SE Texas Area 67 in 2019. I submitted (4) hotel bids to Steve S, the Regional Forums Coordinator.at GSO. The criteria included hotels near the airport with a capacity of 500-700 people. The hotels I chose for bids are the Sheraton IAH, the Marriott N. Houston, The Hyatt North Houston and the Hilton North Houston. I'll keep you informed.

GSO Staff Opening

A vacancy for GSO staff member has been announced. I sent the notice out through "seta-announce" this morning. Applications must be in by November 15th and the vacancy will be filled in January of 2017.

Updates – 2016 Conference Actions

The call continues for personal histories of Young People in A.A. for the revision of the pamphlet. The deadline is December 15th. so please announce this at your meetings and encourage your young members to participate.

Agenda Selection Process – the Trustees Committee on the Conference has sent out requests to current directors, trustees and staff to ask for ideas about how area delegate members of the Conference can be provided a role in the vetting and selection of proposed agenda items. In this communication, these current position-holders have also been encouraged to seek input from their past counterparts.. Their input will be compiled and shared with the Committee (without names included) to be used as a resource for their ongoing work.

Translation Project the Trustees' Committee on the Conference appointed a subcommittee to create a plan for the translation of all background material and produce a report for the committee to review. Staff was asked to gather information on volunteer translation efforts within the Fellowship and provide it to the subcommittee for integration into their work.

Posting 2017 Proposed Agenda Items on Delegate Dashboard This was proposed as a partial solution to the Delegate Participation in Agenda Selection issue at the 2016 Conference. I visited the site recently and saw some new proposals. Following are some samples of proposed agenda items:

- * Request to consider revising the short form of the Concepts;
- Consider retiring the A.A. pamphlet "Too Young";
- * Reconsider the 2010 Advisory Action to maintain spiritual parity between the Grapevine and La Viña and instead allow the staff and Board the right of decision in how each magazine is published.
- * Request to consider development of A.A. literature providing information and guidance to A.A. groups regarding matters of personal conduct, safety and protection of our members.

Financial Update - as of June 30, 2016 - Now for continued good news!

Contributions at the end of the Second Quarter were \$3,784,683, almost \$500,000 higher than the same time period last year.

Net Sales were \$ 5,255,593, a little over \$1 million over last year's.

Total Income was \$9,040,500 – more than 1.5 million over last year at this time. Total Operating Expenses were \$8,078,255 – over \$1.5 million less than budgeted. Net Operating Income for the period ending 6/30/16: \$962,245.
