Delegate Report – Troy B-D.

2019 ended with revenues higher than budgeted but with expenses greater as well with a loss of \$313,000, Contributions were higher than budgeted and almost 6% higher than 2018. Online contributions accounted for almost 12% of total contributions which creates considerable savings in processing charges!

Grapevine ended with the year with a net loss of \$44,461 with continued decrease in subscriptions. Sales of the book Our Great Responsibility were less than budgeted with only 34,137 copies sold at the end of the year. If you are bored at home and are looking for something to read, try this collection of Bill's talks to the General Service Conference.

The Big Book is available in 70 languages, which includes the original English and the recently completed American Sign Language revision. Thirty-four of these languages are printed and distributed by A.A.W.S. and 37 languages are licensed to be printed by local entities abroad, with 21 printed by both A.A.W.S. and international entities.

Audiobooks for Big Book, "Twelve and Twelve" and Living Sober have been completed in English, French and Spanish. Grapevine also completed the long-awaited Spanish Audiobook of Language of the Heart which is available now.

The Young People's Video "Young and Sober in A.A.: From Drinking to Recovery" is completed and is posted on aa.org and A.A.W.S.'s YouTube channel.

In February the Board met and agreed to the 2020 Budget for GSO which reflected gross sales of over 14 million and a profit of just over a thousand. They also approved the 2020 Grapevine Budget reflecting income of \$5,141 and La Viña Budget reflecting expenses of \$317, 025 to be covered by the General Fund. Most of the Committee meetings were focused on which items to forward to the General Service Conference.

GSO has brought Lorna Graham (nonalcoholic) in as Interim Director of Technology services and to provide support for the ERP Steering Committee.

International Convention in Detroit has been canceled. As of January, there were close to 27,000 registered for the convention. If you registered for a hotel through the convention webpage lottery there will be no need to contact the hotel, your registration will automatically be canceled.

As you are likely aware, the 70th GSC has been postponed but will happen this year. The conference committees will be convening soon (Finance 4/5/2020) to discuss moving forward. Please continue to discuss the agenda items you have been given and send me your group's responses.

Delegate's Q & A

- (Q) Diana S. You said contributions were up, but the budget was a minus so if they budgeted a certain amount why did they go over that amount or what happened?
- (A) Troy Contributions were greater but our expenses were even more so. The ERP system is greatly responsible for that loss and additional personnel expenses. But mostly the ERP system and that transition.
- (Q) Diana S. What is the ERP system?
- (A) Troy It's a system that allows all the software in the GSO and Grapevine to be transitioned into one system. As technology has changed, we started using one software system, but they don't interact or interface with each other. The ERP system allows that.

Alternate Delegate Report - Kris H

Greetings Southeast Texas!]

First, I'd like to give a big shout out to Mike D., past Delegate, Panel 49 who was the lone attendee at SWRDA from Area 67. Evidently, he gave a great presentation and I can't wait to borrow the CD from Betsy.

Area 67 will be presenting workshops at SWRAASA in October on Area Chair, CFC and Concepts 3, 4, 5. Our current Area Chair, Rick M. has agreed to host the Chair workshop, and our current CFC Chair was thrilled to be invited to host the CFC workshop as the one that he was set to do at the Texas State Convention had just been postponed until 2021. I'm still waiting to hear from the person I asked to host Concept 3, 4, 5 at this writing.

The Alternate Delegate committee met at SWRDA and again via conference call afterwards to discuss the proposed changes to the SWRAASA policy and procedure manual. I am relieved to report that some of the more involved proposals regarding mandatory contributions from each Area have been eliminated. About the only thing of note left in the revisions is to increase suggested registration from \$10 to \$15. All the rest is pretty grammatical changes.

It has been amazing to see the speed with which many of our groups were able to transition into offering an online meeting alternative once the authorities mandated the cessation of public and private gatherings. Alcoholics really are industrious folk. A quick review of the Meeting Guide App shows that just the meetings "near my current location" (no idea what the radius is, but I'm guessing 50 miles) shows 209 meetings with "Location Temporarily Closed" and 97 "Online" meetings. I've heard that several other online meetings not associated with previous groups have sprung up, but no word on whether there has been any effort or desire to register those meetings.

I can't help but think that once social distancing runs its course, and groups can return to their normal routine we may see a large influx of suffering alcoholics that found themselves isolated and in their cups. I'm sure that our members and groups will be up to the task. I also appreciate some of the stories in our literature about the strength of the solution even in trying times, including such events as WWII when members were scattered around the world without the instant gratification of a virtual meeting-and surviving soberly. I predict that there will be some moving stories about this period in our history published in Grapevine. I look forward to seeing you all in October in Amarillo (God Willing). In love and service,

2021 Budget Rollout - Michelle H.

Before Finance chair gave her report, Rick asked that you take the budget back to your committees and groups
to formulate any questions you have and be prepared to ask those questions in July when we vote on the budget.
Since many are seeing this for the first time, we prefer not to have an extended questions and answer period at
this time. If you have questions before then you can directly email the Finance committee.

- Archives Repository has moved and saved us money; it went from \$9,564 to \$7,435

Dear SETA Family,

The convention hotel is the Houston CityPlace Marriott at Springwoods Village, 1200 Lake Plaza Drive, Spring, TX. This is near the intersection of I-45 and 99 Grand Parkway. It is a newer, slightly smaller hotel than we are used to, but it will be easier for us to meet the smaller room block and not be in danger of attrition fees.

The convention committee has had 3 meetings so far this year, with an enthusiastic bunch of drunks showing up to be of service for our event. We are still in need of a representative for the Multi-Lingual position and alternate. Veronica M. will be reaching out to the SETA Multi-Lingual committee to request their assistance in finding a person to serve. We also have a couple of alternate committee chair positions open, and the committee chairs are searching for volunteers. We have not been able to transfer the bank account to the new committee yet, due to COVID-19 restrictions. We have the documents ready for when we are able to go to the bank. We are opening a PO Box in The Woodlands and are working to get the first flyer developed ASAP. The website updates are in progress, as well as the EventBrite setup.
