## Motions to Lower the Restricted Funds for the Convention Fund – Michelle H.

#### Background:

On April 9, 2006, the following motion was passed:

Area Convention funds should be separated from the Southeast Texas Area budget and account. A separate restricted fund should be established for convention monies. A suggested cap of \$15,000 should be placed on this account. Any monies over the cap will be directed to the Finance Committee for a recommendation.

Currently any funds over \$15,000 in the Convention Fund are moved to unrestricted funds. The SETA Convention has been fully self-supporting the last 10 out of 11 years. The following is 11 years of SETA Convention Net history:

#### Motion to Establish a Permanent SETA Convention Checking Account with Chase Bank – Michelle H.

It has long been an option for the SETA Convention Committee to close the (outgoing) convention bank account with one bank and open a new account with a bank of choice. The preferred bank of choice has been up to the current committee. The current SETA Convention Chair and the Area Treasurer have recently run into several obstacles that lead to research and discussions. With ever changing banking laws, regulations & policies it is difficult to open new accounts for the SETA Convention Committee at every rotation.

We consulted with the bank SETA uses, Chase bank. There are branches located throughout all of Area 67. This adds convenience for all SETA Convention Committee Member regardless of where they are located. The committee feels it is of great importance to document this in our Policies & Procedures Manual as well as the SETA Convention Guidelines to ensure it is not misunderstood with each rotating convention committee.

SETA uses Chase Bank for all the Area's banking needs and after consulting with Chase Bank at length regarding such policies and options, the Area Finance Committee would like to recommend the following motion for the Area's consideration:

The Motion As Proposed Will Read:

The SETA Convention Committee will have one separate and individual checking account with Chase Bank for all convention financial needs.

The signors on the checking account according to Chase Bank's requirements will be:

- Convention Committee Chairperson
- Co-Chairperson
- Convention Committee Treasurer
- Alternate Treasurer
- Area Treasurer
- Area Secretary

No SETA Convention Committee member or account signors will have authority or SETA's support to close the SETA Convention Chase Bank Account without the Area's approval first.

#### Southwest Regional Trustee Overview/Update – Jimmy D.

- AA is alive and well!
- We love Zoom! The General Service Board and AAWS has been using the Zoom format to the utmost.
- AA's "Money Situation"
  - Profits from literature are down. This is our main source of revenue
  - Early retirement is being offered to those employees that qualify. Of the 25 eligible, 20 took the offer which AA in turn had to take a \$1.5 million draw from the Prudent Reserve to cover those employees, which roughly comes out to \$50,000 from AA and the rest is covered by insurance. <u>Those 20 employees had 530 years of combined service to Alcoholics Anonymous!</u>
  - We are waiting on the insurance money from the International Convention. Thank God we have insurance! It is given to us in increments, but we should receive the final payment by the end of this year. We DID NOT lose money on the convention because of the insurance we had in place.
  - Yes, we will be experiencing more draws from our Prudent Reserve. We are in a "flying blind" period right now.
- We are working from where we live right now.
- \$10,000 per month is paid to Google in order to be at the top of any search that has "alcoholism" in it; this amount is paid by a non-profit organization. Other keywords are "how to stop drinking" and "how to find a meeting". These are the goals we have with regards to this grant.

#### Alternate Delegate's Report – Kris H.

This rotation has been full of surprises. Lots of event cancellations (i.e., SWRAASA) and postponements. Look for virtual regional events at aa.org throughout 2021.

It's been a good experience serving as your alternate delegate. By the time this report is published, I'm guessing that any specific event information I give will be subject to inaccuracy due to Covid, so please check with the various hosts for up-to-date information before finalizing any plans (i.e., Texas State Convention, Regional Forums, etc.)

#### Delegate's Report - Troy B-D.

Letter from Greg- General Service Board has authorized a drawdown of \$1.5 million from the Reserve Fund by A.A. World Services, Inc. to cover cash flow requirements in the 4th quarter of 2020.

Previously, in May, A.A.W.S. drew down \$3 million to address the sudden emergency situation related to the severe drop in revenue we saw in March and April. Also, over the summer we refunded nearly \$4 million for 2020 International Convention registrations.

Note: We received \$972,000 as an advance against our International Convention insurance claim to recover lost income, and we expect the balance of the claim to be paid out very soon

Note: This will put the Reserve Fund balance at approximately \$13.1 million, which reflects a level of approximately 7.8 months of office operating expenses. (The Reserve Fund calculation is based on recent actual operating expenses.)

Since May—through September—the groups have responded with breathtaking generosity in their Seventh Tradition contributions, which have ensured continuation of services to the Fellowship. For six months (March through August), our publishing revenue was well below budgeted levels, but September saw a positive uptick in literature sales. Not a trend yet, but very encouraging.

#### COST SAVING EFFORTS- Reforecast budget

Voluntary Retirement Incentive- 25 employees offered 22 AA 3 GV Program (VRIP) that has been offered to eligible employees as of August 1.

The General Service Board U.S./Canada has withdrawn from hosting the 26th World Service Meeting onsite in Rye Brook, NY in October.

No Face-to-Face gatherings for the remainder of 2020 and all of 2021. There will be virtual Forums with ours being scheduled for December 19th. Virtual Western U.S./Canada Forum on December 19, 2020, with the theme: "2020: Experience, Strength & Hope - what it was like, what happened, and what it is like now." The one-day event will feature participation from the Pacific, Southwest, West Central and Western Canada Regions.

NetSuite ERP system has been ongoing. Special focused efforts are underway in the areas of Finance (contributions), Services (My Portal) and Publishing (webstore) with strong input and support from vendors, consultants and select workgroups.

PI- A vendor has been selected for the development of two new PSAs. Diversity will be a key factor in the casting process.

Literature- "A.A. for the Older Alcoholic" DEADLINE for submission: December 15, 2020. Stories not used will likely be forwarded to GV.

That Judith Ann Karam, Class A Trustee, serve for the balance of this panel year as director on the A.A. World Services, Inc. Board of Directors.

Archives- Posthumous Anonymity- Not to publicized photos of Co-Founders since we have no permissions.

Google Ads/Grants has been launched. I am disappointed that the Board has moved forward but I will trust the committee process. I am in no way against Google Ads/Grants however, I am concerned that one, we still have lots of questions and concerns about the program and two, that the floor action that came from the Finance Committee was deemed irrelevant. #### **GSR Workshop**

The new GSR workshop was presented for the first time on zoom, Saturday, October 3rd at the seta assembly. The committee consisted of Elizabeth G., Dan K., Doug D. and myself.

We offered a "buddy system" for first time GRS's at their first assembly. Each person was given a name and number of someone attending the assembly for the weekend. That person could answer any questions and help them navigate the weekend.

We used the slide presentation the "GSR orientation" found on the alt. chair web page. It was great tool (with screen share) and our presenters could expand and add information as needed during the presentation.

With zoom being a new format, we asked everyone to turn off their video and remain muted during the presentation. We asked that all questions be held and typed in at our first break, and then again at the end of the presentation when would try to answer them all. That seemed to work pretty well as it allowed us to screen shot them. We let everyone know if we were unable to answer them all we would send out the questions and answers on seta announce.

We showed participants how to get on the seta website and to the GSR page (letting them know seta would be changing to a new internet system soon). We were able to show and explained all the valuable information the GSR page contains. We screen shared pictures of books and pamphlets that would be helpful for new GSR's

For our first zoom new GSR workshop it went well. We had four participants. I believe as we continue this zoom format, and with our new internet system coming on line soon, the possibilities for creativity are limitless.

I'd like to thank the committee for their hard work on the workshop. With this being our first new GSR workshop on zoom, there were some challenges we faced. Together we thought them through, and we came up with what we thought was the best way to present this important workshop to new GSR's and anyone who wanted to attend.

### Service Committee Reports

**2020 SETA Convention** – Debi F. Dear SETA Family,

I hope that this finds you all sober, healthy and safe.

The Convention Committee has been meeting monthly since January and has done a great deal of work planning for a successful event. We have been working closely with the convention hotel and area officers to stay apprised of current restrictions due to COVID-19.

At this time, the hotel is restricted to 50% occupancy for any events in the facility. Full capacity of the ballroom space is approximately 1200; 50% occupancy would be 600. Our convention treasurer has calculated we would need 1050 attendees at the full convention fee of \$20 each to break even on our planned budget and contract requirements.

Upon discussion with the Area Chair (Rick M.), Delegate (Troy D.), and District 90 DCM (Bella L.), we learn that District 90 does not yet have a convention chair or hotel contract for 2022. In light of this, we discussed the option of requesting the CityPlace Marriott to roll our 2021 contract over to 2022 and all parties were in agreement this would be an optimal solution.

Based on all of these factors, we have asked the hotel for modifications on the contract as follows:

 Reduce required sleeping room block from 211 (7 Thursday, 102 Friday, 102 Saturday) to only the sleeping rooms required for speakers (7 Friday, 7 Saturday) and necessary convention committee members (chair - 2 nights, co-chair - 2 nights, treasurer - 2 nights, registration - 2 nights, hospitality - 2 nights, security - 2 nights) - 13 sleeping rooms for 2 nights each. 1.

- Reduce the Food & Beverage requirement for the ballroom space from \$5000 significantly to allow us to make our budget (suggest utilizing only the coffee costs, which are \$45/gallon + 20% service charge)
   --OR--
- 3. Option to roll the contract from 2021 to 2022 dates.

Our CityPlace Marriott event manager is working with the hotel's sales and catering director to review our requests and will respond next week. We will have a limited face-to-face meeting at the hotel on October 11 immediately following our committee meeting via Zoom.

We currently have 48 pre-registrations, a total of \$1130 (registrations, coffee tags, and scholarship contributions). If a decision is made to either cancel the event or roll it over to 2022, we will contact each individual who has pre-registered to ask if they prefer a refund, to contribute it to the expenses occurred to date (\$359.97 + \$500 deposit), or roll it over to 2022 convention registration (in the event it is held in Houston).

We still meet on third Wednesday of the month at 7:30pm at Intergroup and we will be meeting Wednesday October 21<sup>st</sup> at Intergroup. We had already had our monthly meeting scheduled so we will not be meeting in the virtual room at 4:30 today.

We still sending books into the prisons and jails. Our Blue can fund has seen a decline in contributions but we still getting pretty close to half of what we use to.

At the same time, we are sending in a lot less books. Some of the facilities are allowing us to drop books off and we continue to do so and there has been a few more mail ins.

We still encourage Blue Can Contributions as meetings are going to be continuing soon. Real Soon.

TDCJ, and governor's task are working on allowing volunteers to come back in. We have submitted a Covid Plan showing what our staff will do in regard to social practices. Most likely they will allow this in the private prisons to start with.

Zoom meetings are not available in the prison as is the norm throughout the nation and Canada. The 4 Areas in Texas have been able to record audio zoom meetings and these recordings are going out to the 212 units. We have done meeting over steps 1 - 12. You do have to be an approved volunteer to participate in this. The BAMBI unit in Houston Texas has allowed us to have Zoom meetings at their facility and, again, you have to be an approved volunteer. It is a women's facility so only women can participate in this.

Our CFC conference has been rescheduled for next year on September 17 – 19th. At the Double Tree

We are participating in a workbook and corrections pack up date. A couple of our trustees are doing this with us and the trustee corrections committee.

We have A lot of CFC chairs - past and present - from all over that are participating in this

Going to get something in there related to information technology and zoom meetings. This will be interesting. Updating the corrections workbook has been on the General Service Conference agenda for a number of years. A lot of updates have already been suggested such as contact information and links and such.

There is going to be a CFC workshop at the Spring Group November  $7^{th}$  from 1 - 4 and there is going to be a Spanish CFC workshop on November  $22^{nd}$  from 1 - 4 at the District 65 in Pasadena.

And Finally, I just want to say, again, it has truly been a pleasure to be of service these last couple of years and I pray you all stay safe and healthy.
