#### **NEW BUSINESS**

I. The Area Chair would like to get a sense from the Area Committee: Should we keep our current website the way it is now OR if we should create an Ad Hoc committee to determine if we should pay a third party to finish the new website?

<u>Background</u>: The IT Committee has done a huge amount of work, especially since COVID and has tried to keep up with the on-going demands for their services. The Committee Chair, Christina S., asked Jorge F., the IT Chair to pause on any additional work being done on the new website because it is almost a full-time job. Members of the IT Committee are working 40-60 hours in their spare time to complete the new website, in addition to their existing duties the committee has done Zoom Assemblies and the G-Suite roll out.

Q: How much would it cost to pay a third party? Reino F.

A: The research for the additional cost will be done by an Ad Hoc Committee, once a sense of the Area Committee and Area Assembly has been obtained. Christina S.

Q: What would the cost be if the third party were to pick up where Vern P. left off in building the new website? Reino F.

A: The Ad Hoc committee would be responsible for making the determination, if we start where Vern left off the third party would need the exact same tools to continue what has been done or build an entirely new website. Christina S.

The new website would be user friendly, more current and updated and the Ad Hoc committee would review other Area Websites to gain ideas of how the website will look. The cost would range from \$20K-\$40K dollars depending upon what is needed to either continue the work done or starting over with a new design from the beginning. Jorge F.

Q: Concern was expressed with the delays that have already taken place, the TFC Chair would like to have an estimate of the cost to hire a third party before a vote takes place. Kendyl W.

A: Again, the Ad Hoc committee would be responsible for this endeavor, the vote today is based on the fact that we do not have the manpower to complete the new website. The question up for vote today is if we would like to keep the website as it is or if we would like to pay a third-party to complete or build a new website. This is NOT a motion, it's just a sense of the direction we as an Assembly want to go. Christina S.

#### II. Public Information Committee proposal: Kristi A.

The SETA PI Committee would like to propose that SETA fund several outdoor public service announcements to inform the public on how to communicate with Alcoholics Anonymous as follows:

4 public service announcements of the Bulletin', 2 in English and 2 in Spanish. The only difference between public service announcements in English and Spanish will be the contact number/website.

Vinyl newsletters cost (14'x 48') \$500 installation fee/each

Printing costs \$325 per vinyl (lasts approximately 18 months and can be reused)

Approx. Cost for 4 PSA newsletters \$3300.00

Clear Channel Outdoor will also include, at no cost, 2 digital public service announcements (14'x48') 1 in English and 1 in Spanish that will run on 32 panels across the metropolitan area.

All digital boards are located outside the city of Houston. The digital panel rotates every 8 seconds and can be viewed 1250 times a day.

# <u>note</u>:

- 1-Projected costs are for print and installation labor-Advertising space will be donated
- 2-The locations for the newsletters are on and off the city limits of Houston.

We may request specific areas and will attempt to adapt, but utility announcements will be installed as space becomes available.

3-Normal runtime for donated PSAs is 28 days but can be advanced if space is sold commercially. Vinyl Bulletin's utility ads will be moved to another location if ad space is sold. Digital utility announcements will be installed as the board space becomes available again.

4-The committee would like to coordinate this project with District 81, as they have approved a smaller PSA project to be published on the neighborhood poster panels (12'x24) on the district's secondary roads. The PSA used will be the same. All necessary paperwork can be sent at once.

Floor Action: Area Assembly discuss and vote on the current situation regarding the SETA website. Reasons why

- 1. Don't understand how it can be mandated that the IT Committee pause any further work until after an Ad Hoc Committee comes up with a recommendation and another vote is taken at Assembly.
- 2. Don't understand why the IT Committee was told to pause all work on the new website as opposed to the committee discussing the issue internally and taking a vote.
- 3. Concerned that the only options were to hire a third-party or keep the current website. There were no other. Options for continuing work on the website in- house.
- 4. Why does one individual have the power to stop action that SETA has voted and approved?
- 5. There have been recent developments within the committee, an addition of (3) highly skilled developers on the committee, and a focus on simplifying support procedures.
- 6. October 2020, it was estimated that the committee had spent over \$832,000 in man hours developing The new website. Why scrap all this hard work and pay an outside source without looking at the changing. Factors on the committee? Susan W.

This will be discussed in our Sunday session as "new business," so that the Assembly would have the opportunity to discuss. The Area Chair felt for the sake of Unity, one of the main goals is to keep the Assembly unified and there has been a lot of dis-unity occurring within the IT Committee because of this issue. The two individuals who were able to develop the website were becoming over-whelmed with developing the new website along with additional Area support duties.

Since the beginning of January, I met twice with Ron S the past Treasurer and received the bank account information, checkbook, and the forma needed to carry out the work for the Treasurer position. Worked each month to learn the back account workings and reconciliation process. Have learned the deposit and contribution process so I can pass it onto Roy E the Alt. Treasurer. Attended the monthly Finance Committee meetings. Made available and followed that the appropriate signers were added to the correct bank accounts.

Need to make sure that any check or expense request is sent to me with the filled-out expense form and any receipts if there were or are any. No check will be written without this form being complete and it can be found on the Treasurers web page. I thought that I had setup the electronic group contributions link on the Treasurers web page. But 2 contributions were not accepted this week. So, I need to follow up as to what needs to be corrected for these connections need to operate properly.

Have been authorized from the Finance Committee to send the \$400.00 for fully funding the delegate to this year's General Service Conference. I sent the originally requested \$1,800.00 per Area. The total from GSC to fully fund the Area delegate is \$2,200.00. I will have the approved 2021 1st Quarter's Treasurer's Report Summary put where it is required to be put on the Treasurer's webpage and sent to SETA announce for distribution. I will make sure that I get the Committee budget expenses sent to the committee chairs. I will get the Area officers their band statements and proper forms when required for this quarter and for future quarters as required.

#### Delegate's Report – Kris H.

Hi Y'all,

The 71st General Service Conference is almost upon us. Beginning next Saturday, April 17th and running through Saturday April 24th, we will conduct the second all virtual conference due to the ongoing pandemic. As Troy reported last year, the 70th GSC was able to conduct some important business, but many of the agenda items were in effect, deferred until this year. Thus, we have a 97-item agenda with a record 1400 pages or so of background material. If you believe me when I tell you that I have read every page, then I have a bridge you might be interested in buying. Our very own Patrick C. has been remarkably busy as Conference Coordinator, and he and his crew have implemented what should prove to be some highly effective procedures for our virtual environment. The tentative schedule for this year has been expanded considerably from last year, and the Conference Committees will be given more time to meet than is typically given during in person Conferences. I have seen two different draft schedules, but both of them showed start times each day at 9:45 am with a Serenity A.A. meeting and the work beginning at 11:00am and wrapping up at about 8:00pm each night. Word on the street is that Troy was very instrumental in helping put together one of the scheduled workshops which I am very much looking forward to checking out.

As some of you know, I was assigned to the Grapevine/LaVina Conference Committee. Unlike in-person Conferences, one of the positive things to come out of the pandemic is that the committees are all getting a chance to know one another prior to showing up in New York. The GVL Committee Delegates have already met informally a couple of times, as well as a couple of times in Joint meetings with the Grapevine Board. During the last meeting with the Board, Kathi Fowler, AA Grapevine Board Chair gave us the Grapevine La Vina annual report. I can make that report available to anyone interested, but one of the most notable things that I took away was that LaVina is celebrating its 25th Anniversary. During our most recent housekeeping meeting of the GVL Conference Committee, it was decided that that voting will be by substantial unanimity, and that we will consider our 6 items in the order they are listed on the agenda.

Patrick and some of the GSO staff have provided all of the Conference members with some basic Zoom training and a Mock Conference Session to familiarize us with the procedures that will be implemented for this Conference. Jimmy D., our Regional Trustee also gave our Regional Delegates a training session which was more focused on general conference etiquette all of which has been shared about by our Past Delegates over the years. The Southwest Regional Delegates will caucus with Jimmy one evening during the Conference to select our Regional Candidate for the At-Large Trustee position. I will enthusiastically be putting our Area's candidate, Deborah D. forward to the Region.

Jimmy has also given the Regional Delegates and Alternates a couple of in-depth reports following Board weekends. Some of the notable items he relayed regarded the ongoing search for a GSO General Manager, and the fact that group contributions (60%) outpaced literature sales (40%) for the first time in many years. Let me know if you are interested in a copy of his full report.

Rick and I attended SWRDA last month, and it was truly a learning experience. As a 1st year Delegate, I was required to chair a mock conference committee which covered one of the current agenda items. Several of our Past Delegates were at my table, and all were extremely helpful and had I listened to what they told me, I would have given a flawless report back to the whole crowd. Instead, I was the last presenter, and based on what my peers reported, I embellished- not wanting to appear inadequate. This was followed by what felt like 10 hours of the professional AA debate team discussing the use of current agenda items at SWRDA. For me, the whole event boiled down to what I heard in one of my early AA meetings. I forget the topic, but I remember someone saying, "newcomers need newcomers". The next person to share was a crusty old-timer who said, "be careful with that because newcomers have also been known to go drink together". My wife could tell that I was a bit bummed out after SWRDA, and I shared what all had gone on. All she said was, "So you followed the herd and now you regret it?" I'm still chewing on that.

I have set up a Google Meet with the DCM/MCDs for this Tuesday night to start lining up the report outs, and already have two scheduled virtual District report outs in May. Hopefully, we can also get a feel for what kind of frequency the DCMs would like to hold sharing sessions in the future. For the time being, I plan to follow GSO's lead and maintain a virtual only presence until further notice.

I would like to thank all the leaders and recorders for the Round Tables this year. They are getting by on little guidance and were all willing to try something new with the report outs. Thanks to Bella and the Host Committee for pulling this virtual Assembly together and letting me get away with pirating a big chunk of the practice session. Thanks to the IT committee for continuing to work on the implementation of GSuite. I still believe it is going to be a valuable tool for our whole Area service structure. We have not even begun to scratch the surface of what is there yet. Thanks to the 20 people and groups that responded to the online survey. After some of the early feedback from respondents, I did not feel confident in broadcasting its existence on the Area website until the kinks could be worked out (looks like that will be a project for next year). Thanks to all of our Past Delegates, without whose example, guidance and encouragement, I would never have continued in General Service past GSR. And finally, thanks to my wife. She is a far more competent, dedicated and true servant than I will ever be. To paraphrase my sponsor, she keeps me mindful of a desire to be one of God's success stories.
