**Motion for Assembly Voting by Count Off Method** – Kathleen T.

Motion For Assembly Voting by Count-off Method Update the Policy and Procedure Manual (P&P) to incorporate the method for determining the number of voting members present in Assemblies to a count-off method. The Area Registrar shall ensure persons present (virtually or in person) and serving in positions eligible to vote in that Assembly count-off during roll call. Advantages of the proposed method over the current method: • All people present will know with assurance the number of voting members present and how that number was reached • Faster during the Assembly, leaving more time for activities that support our primary purpose • Increases awareness of Assembly voting eligibility • As accurate as the current method • Accommodates counting voting members in-person and online with one method. • Frees time for Registration table volunteers to greet, help with name badges, explain logistics and collect information on Trusted Servants new to their positions The P&P currently states: "The Area Registrar shall

ensure that all voting members are assigned NUMBERED badges upon registering at each quarterly Assembly. The numbered badges assigned will become the roll of qualified voters. Prior to voting, that roll will be called by the Registrar to verify that all are present and to identify any qualified voters missed in the registration process. Attendance by a member of the Assembly will be required for that member to exercise the voting privilege.” Motion: Change P&P to read: “The Area Registrar shall ensure that all voting members are present when voting by asking all voting members (virtually and in person) to count-off. “

**The Committee APPROVED this motion by majority vote.**

### **Motion for Policy and Procedures Editorial Changes – Ron C.**

An Adhoc Committee was established by the Area Assembly in October 2021 to review the Policy and Procedure Manual (PP&M). After numerous meetings and much discussion, several changes were suggested. These changes are separated into Editorial Changes that are needed to make the PP&M consistent with current procedures and Policy Changes that we feel are needed to improve the functioning of the Area. If motions are approved, the Adhoc Committee (with the help of the Alt-Chair) will make the changes and present to the Area Assembly no later than the October Assembly. Editorial Changes 1. Change Forward to Foreword. (Page 1) 2. Finance guidelines need to be removed from PP&M and placed in guidelines for Finance Committee. (Page 8-9) This Finance guideline also need to be edited and brought in line with current procedures. Remove the reference of Courts of Common Pleas from Finance guidelines (Court does not exist in Texas) 3. Rewrite Preamble to include reference not only to our primary purpose of electing a delegate but also our responsibility to the fellowship and the groups of Alcoholic Anonymous (page 3). This will help the Area to understand that we also have a responsibility as members of Alcoholic to support the concepts of recovery and unity. 4. Assemblies– (page 6-7) a. needs to reword “quarterly 2-day Assemblies” #1 on page 6 b. include educational and informational workshops and sharing sessions for GSRs and DCMs c. include workshops for new committee chairs, etc., who have not been GSRs 5. Add email option to PP&M where only mailing is mentioned (page 6 and 13)

### **Policy Changes – separate votes**

1. Combine PP&M, job descriptions and Committee guidelines in an Area 67 Service Manual If we can combine in one place all our operating documents, this will make them easier to find and to audit at a maximum of every five years when doing our Area Inventory. Currently the Committee guidelines and PP&M are only looked at when changes are made and are not consistent with changing times.
2. Election of Alt Chairperson by third legacy Unlike most other Area Officer Alternate positions, the Alternate Chair has clearly defined and critical responsibilities other than filling in for the Chair if needed. This is similar the Alternate Delegate who is elected by the 3rd Legacy Procedure. Election of other officers and committee chair by majority instead of plurality with many individuals standing for positions, an election can be decided by someone receiving a very small percentage of the votes cast. This motion will require a procedure for multiple ballots and provisions for tie votes.
3. Adding past Delegate Responsibilities to Service Manual Our past delegates in the Area are a remarkable resource that the Area is lucky to have. The adhoc committee feels that a statement in the service manual could serve to encourage the involvement of past Delegates in the Area and reemphasize to the fellowship that our past Delegates are available to help with Area concerns.

### **Delegate Report – Kris H.**

Good morning,

Hot off the press from GSO is an exciting opportunity to be a part of our Big Book's future. Call for stories – Fifth Edition of the Book Alcoholics Anonymous —Big Book with a deadline for submissions: October 31, 2022. Online portal information has been forwarded through SETA ANNOUNCE.

I want to thank you all for your participation in the Roundtables, and I look forward to hearing the reports in a little while. I will be taking all of that feedback with me to Brooklyn when I leave for Conference week on April 23rd. I'm so grateful that I had the opportunity to attend the Board weekend back in January, as it really helped get rid of the travel anxiety that I had been carrying around for a long time. I found out that we will be allowed to use our computers during the entirety of the conference, so I should be able to find time to compile a daily journal to send y'all, but no promises.

Last month, I attended SWRDA in Oklahoma City. For those of you who don't know, this is a long-standing gathering of the Past Delegates of the 11 Areas in the Southwest Region who gather together to meet with the current panel Delegates to share their experience and help prepare them for the Conference. No current agenda items are discussed, as the intent is to discuss or recommend actions that might supersede the function of the Area or Conference, but to give the new Delegates a sense of what to expect. Roundtable discussions very similar to those we held yesterday are conducted using past Agenda Items and old background. The support I've felt from that particular group of people is unparalleled in my service career. They actually record the whole event, which has some great presentations on various topics, and I went ahead and purchased the digital files. There are a couple of the presentations this year that focused on the spirit of rotation that I am seeking permission to share throughout our Area.

One of the other things that happens at SWRDA is that all current panel Delegates are required to present their strictly time limited Area Highlights in two minute or less, just like used to happen at each Conference. Similar to the Gratitude Dinner, I can thank Troy and his panel for doing away with that part of the

Conference. As of two years ago, the Highlights are now only published in the final Conference Reports. This is what I have submitted for my Area.

### **Southeast Texas Area (SETA) 67**

Area 67 covers about 25,000 square miles with Houston, the 4<sup>th</sup> largest city in the US being the hub. Our Area encompasses not only Harris County, the country's third largest county by population but also serves 30 other counties which have a combined population of about 8 million. Although our area is the smallest geographically of the state's four areas covering less than 10% of the total area, we serve 28% of the state's population.

Currently we have about 665 active groups on our roll, including 3 listed as virtual groups. Most groups seem to have resumed in person activities at full strength. Our groups comprise eighteen districts, five of which are Spanish linguistic districts. In January, the Assembly voted to continue with hybrid Assemblies for at least the remainder of 2022. Our IT committee was charged with researching the cost of equipment to conduct hybrid meetings, as the venue pricing is quite extraordinary.

Returning to some sense of normalcy, we began this year with a combined Area Assembly and SETA Convention which rotates between Houston, Beaumont and Galveston, Texas. This year's convention was held at a brand-new hotel in Houston and was very well attended. We were lucky to get both of the current Board chairs of AAWS and AA Grapevine to come and share their experience, strength and hope with us. We were also pleased to welcome representatives from Area 39 after their long trek down from Western Missouri to present a timely workshop on Bridging the Gap. It was a great way to kick start our TFC committees project to re-create and update our BTG Volunteer database. Over 1300 people attended the Convention, enjoying all of the speakers and a whole lot of coffee-on average, every attendee had at least 4 cups.

We are still learning how best to leverage GSuite as a Service tool, and recently implemented shared folders. This is a great way to pass along large piles of information such as the Conference background files with at least a semblance of security.

True to form, we continue to spend a lot of Assembly time determining how we are going to spend Assembly time. An ad hoc was appointed to review and recommend potentially rewriting our whole Policies and Procedures manual. Early indications are that the P&P along with several other documents might be combined to create an Area Service Manual. More will be revealed.

Finally, I have continued to serve the Area over the last 16 years mainly because of the people I've met and come to love and respect. I met Melissa when we served together as DCMs and on my first ad hoc-something about PO Boxes and Mailouts. From that point, I could never have imagined the impact that she and her family would have on me and mine. Some of you may have heard about the recent passing of Dane. She was in the thoughts and prayers of all of the Past Delegates of SWRDA, but I never saw anything about it in the Area chats. As current Delegate, that may have been my responsibility. Sadly, I will be traveling to Brooklyn on the day of Dane's memorial. In any case, I wanted to share a few thoughts on the matter. I had a lot of help from the love of my life putting this together:

There are so many different reasons why we as individuals get sober, followed by so many new reasons why we stay sober, but none of us can truly comprehend what sobriety will lead us to experience in our lifetimes.

We experience on a deeper level than we've ever known before love, happiness, peace, honesty, life, laughter, connection, fears, heartbreak, trials and at times death.

What sobriety does not give us no matter when, how or why we get sober is more hours in any given day. So the time we are gifted, one day at a time is precious, ours to do with as we want and on occasion as we must.

I believe it is appropriate and important to take this moment in time to celebrate two amazing sober individuals that through the Power of God found love, happiness, peace, honesty, life, laughter, family, connection & compassion. When the cancer found one & they both experienced the fears, heartbreak, trials & recent death at the core of it all was God's Love.

Dane McAnally lived through his cancer soberly with a sense of humor, love, grace and dignity!

Melissa loved & cared for him with her whole heart in magnificent detail until his very last breath!

There are so many different reasons why we as individuals get sober, followed by so many new reasons why we stay sober, but none of us can truly comprehend what sobriety will lead us to experience in our lifetimes.

One thing that is certain is that death makes life precious & we should never be too sober to stop & celebrate each day as the gift from God that it truly is.

(and his team), to provide outstanding audio/visual services for the event. Due to Allise's efforts, we were able to have Zoom projections of the speakers in the AI-Anon, Hispanic, and Overflow breakout rooms at no cost. And a big shout out of thanks to Districts 32 and District 52 for providing their Zoom equipment. Betsy, Jorge, Marshall, and Ryan supported the Zoom broadcasts for our virtual convention attendees, as well as the Area Committee, Area Assembly, and GSR Workshops. All of the beautiful historic posters, videos, and the sound and projection equipment in the ballrooms were provided by Lee at no charge, saving the convention thousands of dollars in audio/visual costs that the hotel would have charged. I'm so grateful to all of these individuals for their contributions.

Due to Veronica Mendez's diligence and enthusiasm, we had hospitality contributions from the Santa Fe Group, Serenity Group (Woodlands), This Side of the Lake Group, and Districts 40, 52, 70 and 90. Due to their

generosity, Veronica's team was able to offer low-cost food and snacks throughout the weekend to convention attendees without utilizing the \$2000 allocated for hospitality in the convention budget. Thank you to Veronica and those groups and districts for your contributions!

I don't have the time or space to call out every single convention committee chair for all that they did to make our event so great, but we were really blessed to have each and every one of you who was willing to commit for the weekend to making sure our event was wonderful! Archives, Coffee, CFC, Entertainment, First Timers, Grapevine, Greeters, Hospitality, Literature, Marathon Meetings, Multi-Lingual, Registration, Scholarships, Security, Speaker Hosts/Gifts/Readers, Signs/Banners/Flowers, and YPAA - and all of the SETA Area Standing Committee representatives who brought their displays and information. Thank you each and every one, along with all of your alternates and volunteers!!!

I want to recognize my co-chair, Tony W., Beth L., the Voice, Treasurer Lauren D., and Greeter's chair, Dan M., who all worked so hard during the planning stages and were unable to attend due to falling ill to COVID the week of the event. We missed you being there and give thanks for everything you contributed. I could not have done this without you.

### **Attendance**

We had a lower attendance than the average SETA Convention. Initially, we chose a smaller facility to reduce the guest room block requirements (which are always difficult to meet when the convention is held in Houston) and anticipated a lower attendance because of this.

The surge in COVID in the weeks leading up to the event made us very apprehensive about how many people would actually show up. So overall, we are very happy with these numbers!

### **Financials**

My hope was that this event would not experience a loss, and we worked hard to ensure success. However, I have learned over the years that the SETA Convention is not about making money, it is about doing the footwork and leaving the results to God. It has always been about carrying the message of AA and service, showing newcomers how to have fun in sobriety, and exposing everyone to our service committees and opportunities. I am proud that we knocked those goals out of the park.

Losses are attributed to lower attendance than previous conventions due to and space restrictions and the pandemic, along with higher-than-expected coffee consumption/cost. We had planned for 203 gallons for the weekend, and you all drank 333 gallons!!! This resulted in a 61% increase in coffee consumption and related charges.

**Convention Loss = \$2,905.70**

### **Handoff**

We were able to give left over registration and hospitality materials, etc., to Annette C. from Beaumont on Sunday at the end of the convention. I went to visit her a few weeks ago and we reviewed all of the processes and lessons learned from the 2022 convention so that she is set up for success. Please reach out to her to see how you can be of service to the convention. The committee should have Area-wide representation and never be the burden of just one district. WE stay sober together!!!

### **Gratitude**

When Rick Mueller contacted me in 2019 and asked if I would be willing to stand for convention chair, I was honored to be considered and excited about the opportunity. I have served on many convention committees in the past 31 years, and I worked in event planning professionally for 9 years. I truly love the experience of bringing together alcoholics of all backgrounds and lengths of sobriety to expand our collective AA knowledge and networks. My first convention was at 9 months of sobriety in 1991, and I still remember the impact the speakers and the fellowship had on me. I believe that campouts, conventions, roundups, workshops,

jamborees, speaker jams, and anything else that we do to bring a bunch of drunks together to have fun in sobriety while learning about AA as a Whole (and the service opportunities) is KEY to ensuring the future of Alcoholics Anonymous while combating the limited scope view that members have when only participating in their home group and/or small local gatherings.
